1. Uganda Bureau of Statistics invites sealed bids from eligible bidders for the provision of the above service under Framework Contract for three years.
2. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

4. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 100,000**. The method of payment will be by Banking through a BAF obtainable from URA website.
5. Bids must be delivered to the address below at 8(c) at or before **11:00am 23rd February 2024**. All bids must be accompanied by a bid security of **UGX. 2,000,000**. The bid security shall be in form of Bank Guarantee. Bid securities must be valid until **19th September 2024**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:20am, 23rd February 2024**.
7. There shall be a pre – bid meeting/ site visit at **Statistics House** on **2nd February 2024** the dates indicated in the proposed schedule in this notice.
