All bids must be accompanied by a bid security in form of a Bank guarantee of **UGX 2,000,000 (Uganda Shillings Two Million Only)** Bid securities must be valid until **31st December 2018**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:10 5th June 2018**
