6. Bids must be delivered to the address below at 8(c) at or before **11:00am 15th October 2019**. All bids must be accompanied by a bid security of **UGX 20,000,000**. Bid securities must be valid until **27th July 2020**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:10am, 15th October 2019**
