1. Uganda Bureau of Statistics has allocated/received funds to be used for the **Servicing of three (03) Stand-by Power Generators under the Framework Contract for Three Years**
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **8:00 am-4:30 pm**.
5. Interested bidders may purchase the Bidding documents in English on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 100,000**. The method of payment will be by Banking through a BAF obtainable from the URA website.
6. Bids must be delivered to the address below at 8(c) at or before **11:00 am, 21st November 2025**. A bid security of UGX 1,500,000 must accompany all bids. Bid securities must be valid until **29th July 2026**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:10 am, 21st November 2025**.
7. There shall be a pre-bid on **11th November 2025** as per the dates indicated in the proposed schedule in this notice.
