

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten baskets of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index was rebased from 2005/2006 to 2009/2010, using weights derived from the Uganda National Household Survey (UNHS IV) that was conducted from May 2009 to April 2010. During the rebasing exercise, Kampala was further decomposed into three baskets from the two that has been existing. In addition, Fortportal Centre was incorporated into the Index. The rebased CPI is now classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP). This is a shift from the Central Product Classification (CPC) that was used in the earlier series.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten baskets mentioned above and indices are available from the EA level.

ACRONYMS AND DEFINITIONS

COICOP: Classification of Individual Consumption According to Purpose, is a nomenclature developed by the United Nations Statistics Division to classify and analyse individual consumption expenditures incurred by households, non-profit institutions serving households and general government according to their purpose.

CPI: Consumer Price Index - a general indicator of price levels paid by households for consumer goods and services.

CPI basket: A commonly used term for the goods and services priced for the purpose of compiling the CPI.

Elementary aggregate: The lowest level of commodity classification in the CPI, and the only level for which index numbers are constructed by direct reference to price data.

Inflation: A term commonly used to refer to changes in price levels. A rise in prices is called inflation, and a persistent fall is called deflation.

Jevons price index: An elementary price index defined as the un-weighted geometric average of the sample price relatives. It can also be defined as the unweighted geometric average of the current to base period price relatives.

Laspeyres price index: The Laspeyres price index is an index formula used in price statistics for measuring the price development of the basket of goods and services consumed in the base period. The question it answers is how much a basket that consumers bought in the base period would cost in the current period.

Outlet: The interface between a supplier of products and the consumer. It may be a shop, a market stall, a catalogue, a website etc. Also referred to as a "retail outlet", although it can include wholesale outlets which also sell directly to the consumers

Outlier: A term used to describe any extreme value in a set of data, such as a price or price relative that requires further investigation or has been verified as incorrect

Price relative: A measure of price movements: the ratio of the price level in one period to the price level in another.

Reference base: The period in which the CPI is given a value of 100.0. The CPI is currently on a reference base of 2009/10.

Weight: The measure of the importance of an item in the index regimen relative to the other items. Weights can be expressed in either quantity or value terms. Value weights are used in the CPI.

1.0 HIGHLIGHTS OF CPI FOR DECEMBER 2018

1.1 Calendar Year (CY) 2018 Inflation

The Annual Average Headline Inflation for the 2018 calendar year (January to December 2018), rose by 2.6 percent. This rise was, however, slower than the Annual Average Inflation for 2017 calendar year which rose by 5.6 percent. The increase is partly due to the Annual Average Energy, Fuels and Utilities (EFU) Inflation that rose by 10.7 percent during the 2018 calendar year from 7.5 percent registered for the calendar year 2017. The main drivers were the increases in prices of water, electricity, petrol, diesel, kerosene, charcoal and firewood during the period. The Annual Average Core Inflation rose by 2.4 percent for the calendar year 2018 from the 4.4 percent rise registered during the 2017 calendar year. Conversely, the Annual Average Food Crops Inflation is registered at minus 1.5 percent for the 2018 calendar year compared to 13.0 percent registered during the 2017 calendar year.

1.2 Annual Inflation

The Annual Headline Inflation for the year ending December 2018 has been recorded at 2.2 percent Compared to 3.0 percent registered during the year ended November 2018. This is a 0.8 percentage point decline from that recorded during the year ended November 2018.

The decline in Headline Inflation is largely attributed to the Annual Food Crops and Related Items Inflation for the year ending December 2018, which decelerated further to minus 5.0 percent compared to minus 3.3 percent recorded for the year ended November 2018. The deceleration is due to Annual Fruits Inflation that registered minus 13.2 percent for the year ending December 2018 compared to minus 9.3 percent recorded for the year ended November 2018. However, the Annual Vegetables Inflation slightly increased to minus 1.0 percent for the year ending December 2018 compared to minus 1.1 percent recorded for the year ended November 2018.

In addition, the Annual Core Inflation declined to 2.8 percent for the year ending December 2018 compared to the 3.4 percent registered for the year ended November 2018. This decrease was due to Annual Other Goods Inflation that registered 2.2 percent for the year ending December 2018 compared to 3.0 percent recorded for the year ended November 2018. In particular, Foot Wear Inflation declined to 7.8 percent for the year ending December 2018 compared to the 8.9 percent recorded in November 2018. Besides, Services Inflation declined to 3.6 percent for the year ending December 2018 compared to 4.0 percent recorded for year ended November 2018.

The Annual Energy, Fuels and Utilities (EFU) Inflation also declined to 6.9 percent for the year ending December 2018 compared to the 7.7 percent recorded for the year ended November 2018. The decrease in EFU is largely attributed to Solid Fuels that registered 3.4 percent for the year ending December 2018 compared to the 5.2 percent recorded for the year ended November 2018. In particular, Charcoal Inflation decreased to 3.2 percent for the year ending December 2018 compared to the 4.8 percent recorded during the year ended November 2018. Similarly, Firewood Annual Inflation declined to 9.0 percent for the year ending December 2018 compared to the 14.2 percent recorded during the year ended November 2018.




Figure 1: Uganda Headline Index and Annual Inflation for 3 major components, December 2017 - December 2018: (2009/2010 = 100)

The one year series for the Headline Index and the Annual Inflation rates for the three major components are shown in Figure 1.

1.3 Annual Headline Inflation by Income Groups and Geographical areas


Analysis by geographical areas shows that Kampala Low Income registered the highest Annual Inflation of 3.2 percent for the year ending December 2018 compared to the 2.4 percent recorded for the year ended November 2018. This is driven by Annual Inflation for Food and Non Alcoholic Beverages that increased to minus 0.1 percent for the year ending December 2018 compared to minus 3.2 percent recorded for the year ended November 2018. In addition, Recreation and Culture Inflation rose to 2.8 percent for the year ending December 2018 compared to the 2.4 percent registered during the year ended November 2018.

The second highest Inflation was registered in Kampala High Income at 3.0 percent for the year ending December 2018 though lower than 4.7 percent recorded for the year ended November 2018. The main driver for this increase was Annual Inflation for Restaurants and Hotels that is registered at 3.2 percent for the year ending December 2018 compared to the 1.1 percent registered for the year ended November 2018. In addition, Housing, Water, Electricity, Gas and other Fuels inflation increased to 3.8 percent for the year ending December 2018 compared to the 3.1 percent for the year ended November 2018.

The least Annual Inflation was registered in Fort Portal Centre at minus 1.3 percent for the year ending December 2018 compared to 0.0 percent recorded for the year ended November 2018. This was driven by Annual Inflation for Food and Non Alcoholic Beverages that registered minus 10.1 percent for the year ending December 2018 compared to minus 7.5 percent registered for the year ended November 2018. In addition, Housing, Water, Electricity, Gas and other Fuels Inflation recorded 3.9 percent for the year ending December 2018 compared to 5.5 percent for the year ended November 2018.

Annual Inflation figures for all the ten consumption baskets are shown in Figure 2 and Table 7.

1.4 Monthly Inflation

The Monthly Headline Inflation for December 2018 has been recorded at minus 0.2 percent from the minus 0.1 percent recorded in November 2018.

The decrease in the Monthly Headline Inflation was attributed to the Monthly Food Crops and Related Items Inflation that registered a minus 3.7 percent in December 2018 from the minus 1.4 percent recorded in November 2018. This was largely driven by Monthly Fruits Inflation that declined by 4.5 percent during the month of December 2018 from the 0.1 percent rise recorded for the month of November 2018.

The Monthly Core Inflation registered 0.3 percent rise in December 2018 from the 0.0 percent recorded in November 2018. The rise was due to the monthly Other Goods Inflation that registered a 0.2 percent rise during the month of December 2018 from the 0.1 percent drop recorded for the month of November 2018. In addition, Services Inflation recorded a 0.5 percent rise during the month of December 2018 from the 0.1 percent rise recorded for the month of November 2018.

The Monthly Energy Fuel and Utilities Inflation registered minus 0.5 percent during the month of December 2018 from the 0.0 percent recorded in November 2018. The drop was due to the Monthly Solid Fuels Inflation that decreased by 1.5 percent during the month of December 2018 from the 0.5 percent drop recorded for the month ended November 2018.

The detailed Monthly Inflation figures per Division are presented in Section 2 of the explanatory notes in the annex.

2.0 ANNUAL INFLATION BY COICOP DIVISIONS

The evolution of Annual Inflation according to COICOP is described in the following paragraphs.

2.1 Food and Non-Alcoholic Beverages

The Annual Inflation for Food and Non-alcoholic Beverages registered minus 2.5 percent for the year ending December 2018 compared to minus 2.2 percent recorded for the year ended November 2018. This was due Annual Food Inflation that declined to minus 2.8 percent for the year ending December 2018 compared to the minus 2.4 percent recorded during the year ended November 2018. In addition, The Annual Inflation for Non-Alcoholic Beverages dropped to 1.8 percent for the year ending December 2018 compared to 2.0 percent recorded for the year ended November 2018. Graph 3 shows the trends of Food and Non Alcoholic Beverages Inflation from December 2016 to December 2018.




Figure 3: Food and Non Alcoholic Beverages Annual Inflation Trends; December 2016 - December 2018

2.2 Alcoholic Beverages, Tobacco & Narcotics

The Annual Inflation for Alcoholic Beverages, Tobacco & Narcotics was recorded at 1.1 percent for the year ending December 2018 compared to 1.5 percent recorded for the year ended November 2018. This was due to the Annual Alcoholic Beverages Inflation that registered 0.7 percent for the year ending December 2018 compared to 1.1 percent recorded for the year ended November 2018. In addition, the Annual Inflation of Tobacco dropped to 4.4 percent for the year ending December 2018 compared to 5.7 percent recorded for the year ended November 2018.

2.3 Clothing and Footwear

The Annual Inflation for Clothing and Footwear decreased to 5.5 percent for the year ending December 2018 compared to 5.9 percent recorded for the year ended November 2018. The drop was mainly attributed to Clothing Inflation that registered 5.0 percent for the year ending December 2018 compared to 5.3 percent recorded for the year ended November 2018. In addition, Footwear Inflation decreased to 7.8 percent for the year ending December 2018 compared to 8.9 percent recorded during the year ended November 2018.

Graph 4 shows the trends of clothing and Footwear from December 2016 to December 2018.




Figure 4: Clothing and Footwear Annual Inflation Trends; December 2016 - December 2018

2.4 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and other Fuels comprises of Actual Rentals for Housing, Maintenance & repair of the dwelling, Water Supply, Electricity, Gas and Other Fuels

The Annual Inflation for Housing, water, electricity, Gas & other fuels decreased to 3.3 percent for the year ending December 2018 compared to 3.8 percent recorded for the year ended November 2018. The drop was attributed to Inflation of Electricity, gas and other fuels that registered 6.6 percent for the year ending December 2018 compared to the 7.7 percent recorded for the year ended November 2018. In addition, Maintenance and repair of the dwelling Inflation dropped to 2.6 percent for the year ending December 2018 compared to 3.6 percent recorded for year ended November 2018.

2.5 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture & furnishings, Carpets & Other Floor Coverings, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools & Equipment for House, and Goods & Services for Routine Household Maintenance

The Annual Inflation for Furnishings, household equipment & routine household maintenance registered 3.8 percent for the year ending December 2018 compared to 3.5 percent recorded for the year ended November 2018. This rise was due to the Annual Inflation for Goods and services for routine household maintenance that registered 2.2 percent for the year ending December 2018 compared to 0.9 percent recorded for the year ended November 2018. In addition, Glassware, tableware and household utensils Inflation rose to 3.6 percent for the year ending December 2018 compared to 2.2 percent recorded for year ended November 2018.

2.6 Health

The health Division comprises of Medical Products, Appliances & Equipment, Outpatient Services, and Hospital Services.

The Annual Inflation for Health decreased to 1.9 percent for the year ending December 2018 compared to 2.3 percent recorded for year ended November 2018. The drop was attributed to Annual Inflation for Hospital services that registered 4.3 percent for the year ending December 2018 compared to 5.6 percent recorded for the year ended November 2018. In addition, Outpatient Services Annual inflation registered 0.4 percent for the year ending December 2018 compared to the 0.9 percent recorded for the year ended November 2018.

2.7 Transport

Transport division comprises of Purchase of vehicles, Operation of Transport and Personal Equipment and Transport Services.

Annual Inflation for Transport decreased to 9.8 percent for the year ending December 2018 compared to 15.1 percent recorded for the year ended November 2018. The drop was due to Purchase of Vehicles Inflation that recorded 15.2 percent for the year ending December 2018 compared to 40.5 percent recorded for the year ended November 2018. In addition, Transport services Inflation dropped to 8.6 percent for the year ending December 2018 compared to the 10.7 percent recorded for the year ended November 2018.

2.8 Communication

Communication includes Postal services, Telephones and Telefax equipment and Telephone and Telefax services.

The Annual Inflation for Communication registered a decrease of 5.7 percent for the year ending December 2018 compared to the 6.1 percent recorded for year ended November 2018. The main driver was Telephone and Telefax services that registered 7.0 percent for the year ending November 2018 compared to the 7.6 percent recorded for the year ended November 2018.

2.9 Recreation and Culture

Recreation and Culture comprises of Audio-visual, photographic & Information processing equipment, Recreational & Cultural services, Newspapers, books & Stationery and Package Holidays.

Annual Inflation for Recreational and Culture decreased to 1.9 percent for the year ending December 2018 from the 2.2 percent recorded the year ended November 2018. The decline was attributed to Package holidays Inflation that registered 2.8 percent for the year ending December 2018 compared to 3.9 percent recorded for the year ended November 2018.

2.10 Education

Education comprises of Pre-Primary and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education not definable by level.

The Annual Inflation for Education registered 4.4 percent for the year ending December 2018, the same rate recorded for the year ended November 2018.

2.11 Restaurants and Hotels

Restaurants and Hotels comprises of catering services and accommodation services. Restaurants and Hotels.

Annual Inflation for Restaurants and Hotels decreased to 1.1 percent for the year ending December 2018 compared to 1.2 percent registered for the year ended November 2018. The drop was due to Inflation of Catering services that registered 1.2 percent for the year ending December 2018 compared to 1.3 percent for the year ended November 2018. In addition, Accommodation services decreased to 0.7 percent for the year ending December 2018 compared to 1.0 percent recorded for the year ended November 2018.

2.12 Miscellaneous Goods and Services

Miscellaneous goods and services comprises of Personal Care such as hairdressing salons and personal grooming establishments, Personal Effects such as Jewellery, clocks and watches, Insurance and Other services such as passport fees, photocopying and radio announcements.

The Miscellaneous goods and services Inflation for the year ending December 2018 registered 3.1 percent compared to 3.2 percent recorded for the year ended November 2018. This decrease was due to Inflation of Insurance that recorded 0.7 percent for the year ending December 2018 compared to 1.1 recorded for the year ended November 2018.

3.0 MONTHLY INFLATION BY COICOP DIVISIONS

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs

3.1 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic beverages dropped by 1.6 percent for the month of December 2018 from the minus 0.7 percent recorded for November 2018. The decrease was due to Food Inflation that recorded minus 1.7 percent in December 2018 from the 0.7 percent drop recorded in November 2018. However, Non-alcoholic Beverages increased by 0.2 percent for the month of December 2018 from the 0.1 percent rise recorded in November 2018.

3.2 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages & Tobacco registered a decrease of 0.2 percent during the month of December 2018 from the 0.1 percent increase recorded in November 2018. The drop was due to Alcoholic beverages Inflation that dropped by 0.2 percent in December 2018 from the 0.0 recorded in November 2018. In addition, Tobacco inflation registered minus 0.5 percent for the month of December 2018 from the 1.5 percent rise recorded for the month of November 2018.

3.3 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear registered a 0.6 percent increase for the month of December 2018 from the 0.5 percent drop recorded in November 2018. This rise was mainly attributed to Clothing Inflation that registered 0.6 percent during the month of December 2018 from the 0.6 percent decrease recorded in November 2018. In addition, Footwear Inflation registered a 0.5 percent increase for the month of December 2018 from the 0.4 percent rise recorded in November 2018.

3.4 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, water, electricity, Gas & other fuels, registered a decrease of 0.3 percent in December 2018 from the minus 0.1 percent recorded in November 2018. The drop was attributed to Electricity, gas and other fuels Inflation that registered minus 0.8 percent in December 2018 from the 0.2 percent drop recorded in November 2018.

3.5 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, household equipment & routine household maintenance registered a 0.5 percent increase during the month of December 2018 from the 0.4 percent rise recorded for the month of November 2018. This was due to Goods and services for routine household maintenance inflation that rose by 0.8 percent from the minus 0.1 percent recorded in November 2018. In addition, Tools and equipment for house and garden Inflation registered an increase of 0.1 percent in December 2018 from the 0.2 percent drop recorded for the month of November 2018.

3.6 Health

The Monthly Inflation for Health registered 0.0 percent for the month ending December 2018 from 0.2 percent rise recorded for the month ended November 2018. The Monthly Inflation for Medical Products, Appliances & Equipment registered minus 0.1 percent for the month of December 2018 compared to the 0.2 percent increase recorded in November 2018. This was offset by Outpatient services monthly inflation rose by 0.1 percent for the month ending December 2018 from the 0.5 percent rise recorded for the month ended

November 2018 and the monthly inflation for Hospital Services that rose by 0.2 percent for the month Of December 2018 from the minus 0.3 percent recorded for the month of November 2018.

3.7 Transport

Transport division registered an increase of 2.1 percent for the month of December 2018 from the 0.4 percent rise recorded during the month of November 2018. This increase was due to Purchase of vehicles that registered 3.6 percent during the month of December 2018 from the 0.2 percent rise recorded for the month of November 2018. In addition, monthly Transport services inflation registered a 2.4 percent rise for the month of December 2018 from the 0.6 percent increase during the month of November 2018.

3.8 Communication

The Monthly Inflation for Communication registered 0.0 percent for the month of December 2018, the same rate recorded for the month of November 2018. However, Telephone and telefax equipment monthly inflation dropped to 0.1 percent for the month of December 2018 from the 0.1 percent increase recorded for the month of November 2018.

3.9 Recreation and Culture

Monthly Inflation for Recreational and Culture registered a 0.1 percent increase during the month of December 2018 from the 0.0 percent recorded for the month of November 2018. This was due to the Monthly inflation of Recreational and cultural services that recorded 0.1 percent rise during the month of December 2018 from the 0.0 percent registered in November 2018. In addition, Newspapers, books and stationery monthly inflation registered an increase of 0.4 percent during the month of December 2018 from the 0.2 percent rise recorded for the month of November 2018.

3.10 Education

Monthly Inflation for Education registered 0.0 percent during the month of December 2018, the same rate recorded for the month ended November 2018.

3.11 Restaurants and Hotels

The Monthly Inflation for Restaurants and Hotels registered an increase of 0.2 percent during the month of December 2018 from the 0.0 percent registered for the month of November 2018. This rise was due to Catering Services inflation that rose by 0.2 percent during the month of December 2018 from the 0.1 percent increase recorded for the month ended November 2018. However, Accommodation services that registered 0.0 percent during the month of December 2018, the same rate recorded for the month ended November 2018.

3.12 Miscellaneous Goods and Services

Miscellaneous goods and services Inflation for the month of December 2018 registered a 0.2 percent increase, the same rate recorded for the month of November 2018. The rise was mainly attributed to Monthly Inflation for Personal effects n.e.c Inflation that recorded 0.5 percent during the month of December 2018 from the 0.1 percent decrease recorded for the month of November 2018. In addition, Insurance monthly inflation registered a 0.4 percent rise for the month of December 2018 from the 0.0 percent recorded for the month of November 2018.
