PRESS RELEASE PRODUCER PRICE INDICES AND INFLATION MANUFACTURING AND UTILITIES - DECEMBER 2022

1.0 Annual Headline Inflation




Figure 1: Annual percentage changes in Producer Price Indices, December 2021 – December 2022

The inflation as measured by the producer price index for manufactured goods and utilities for the 12 months to December 2022 increased to 9.8 percent compared to 9.4 percent registered for the year ended November 2022. This was mainly attributed to 10.1 percent increase in inflation of the manufacturing sector for the year ending December 2022 compared to 9.7 percent registered for the year ended November 2022 as shown in Figure 1.

The main drivers in the manufacturing sector were the manufacture of food products whose inflation increased to 8.7 percent for the year ending December 2022 compared to 7.2 percent registered for the year ended November 2022. Particularly, manufacture of grain milling products inflation increased to 58.2 percent for the year ending December 2022 compared to 31.5 percent registered for the year ended November 2022.

Manufacture of pharmaceuticals, medicinal chemical & botanical products increased to 8.7 percent for the year ending December 2022 compared to 6.6 percent registered for the year ended November 2022 and manufacture of electrical equipment increased to 3.9 percent for the year ending December 2022 compared to 2.3 percent registered for the year ended November 2022.

However, the inflation for utilities slowed down to 3.0 percent for the year ending December 2022 compared to 4.1 percent registered for the year ended November 2022. This was attributed to 2.6 percent slow down in the inflation of electricity power generation registered in December 2022 compared to 3.9 percent registered in November 2022.




Figure 2: Annual Inflation in PPI-Manufacturing for Domestic and Export, December 2021 – December 2022

The producer price index for manufactured goods is further disaggregated into goods produced for the local market (domestic) and for export. For the domestic market, the inflation as measured by the producer price index for the 12 months to December 2022 increased to 14.9 percent compared to 14.5 percent registered in November 2022. This was mainly attributed to 18.6 percent increase in inflation for manufacture of food products in December 2022 compared to 16.8 percent registered in November 2022, manufacture of beverages increased to 4.0 percent in December 2022 compared to 3.2 percent registered in November 2022 as shown in Figure 2.

In addition, the inflation for exported manufactured products increased to minus 1.0 percent for the 12 months to December 2022 compared to minus 2.3 percent registered in November 2022 as shown in Figure 2. The main drivers were manufacture of food products inflation which was registered at minus 3.3 percent compared to minus 5.4 percent registered in November 2022 and manufacture of paper and paper products inflation that increased minus 10.6 percent in December 2022 compared to minus 11.0 percent in November 2022 as shown in Figure 2.

2.0 Monthly Inflation


The monthly inflation for manufactured goods and utilities rose by 0.2 percent in December 2022 compared to 0.9 percent drop registered in November 2022. This was mainly attributed to a 0.2 percent rise in the commodities under the manufacturing sector in December 2022 compared to 0.9 percent drop in November 2022.

Inflation for commodities under manufacture of food products rose by 1.1 percent in December 2022 compared to 1.3 percent drop registered in November 2022. Specifically, inflation for processing and preserving of fish, crastaceans and molluscs rose by 25.6 percent in December 2022 compared to 12.5 percent drop registered in November 2022, coffee processing rose by 4.3 percent in December 2022 compared to 1.0 percent drop registered in November 2022 and manufacture of sugar rose by 2.3 percent in December 2022 compared to 1.2 percent drop registered in November 2022.

In addition, the inflation for utilities dropped by 1.0 percent in December 2022 compared to 0.9 percent drop registered in November 2022 as shown in Table 2 and Figure 2. This was attributed to electricity power generation inflation that dropped by 1.2 percent in December 2022 compared to 1.0 percent drop registered in November 2022.





The monthly inflation for exported manufactured products rose by 1.6 percent in December 2022 compared to 1.9 percent drop registered in November 2022. This was mainly attributed to the rise in inflation of commodities under manufacture of food products by 2.3 percent in December 2022 compared to 1.9 percent drop registered in November 2022.

In addition, the monthly inflation for goods produced for domestic market dropped by 0.2 percent in December 2022 compared to 0.6 percent drop registered in November 2022. This was mainly attributed to a drop in inflation of manufactured chemicals and chemical products by 2.8 percent in December 2022 compared to relatively stable prices registered in November 2022.




Figure 4: Monthly changes in PPI-Manufacturing for Domestic and Export, December 2021 – December 2022
