PRODUCER PRICE INDICES AND INFLATION MANUFACTURING AND UTILITIES – DECEMBER 2025

1.0 Annual PPI M&U Headline Inflation

The Annual Headline Inflation as measured by the Producer Price Index of Manufacturing and Utilities for the 12 months to December 2025 was registered at 0.8 percent compared to 1.0 percent registered in the year ended November 2025. This was mainly attributed to the Annual Inflation of the Manufacturing sector that registered 0.9 percent in the year ended December 2025 compared to 1.3 percent registered in the year ended November 2025, see table 1 and figure 1 below.

The main driver for the Annual Inflation of the Manufacturing sector was Manufacture of food products whose Inflation was registered at 2.9 percent in December 2025 compared to 3.7 percent registered in November 2025 as shown in Appendix Table 2. Specifically, Manufacture of sugar registered minus 5.1 percent in December 2025 compared to 3.6 percent registered in November 2025 and Distilling, rectifying and blending of spirits registered minus 3.5 percent in December 2025 compared to 1.4 percent in November 2025.

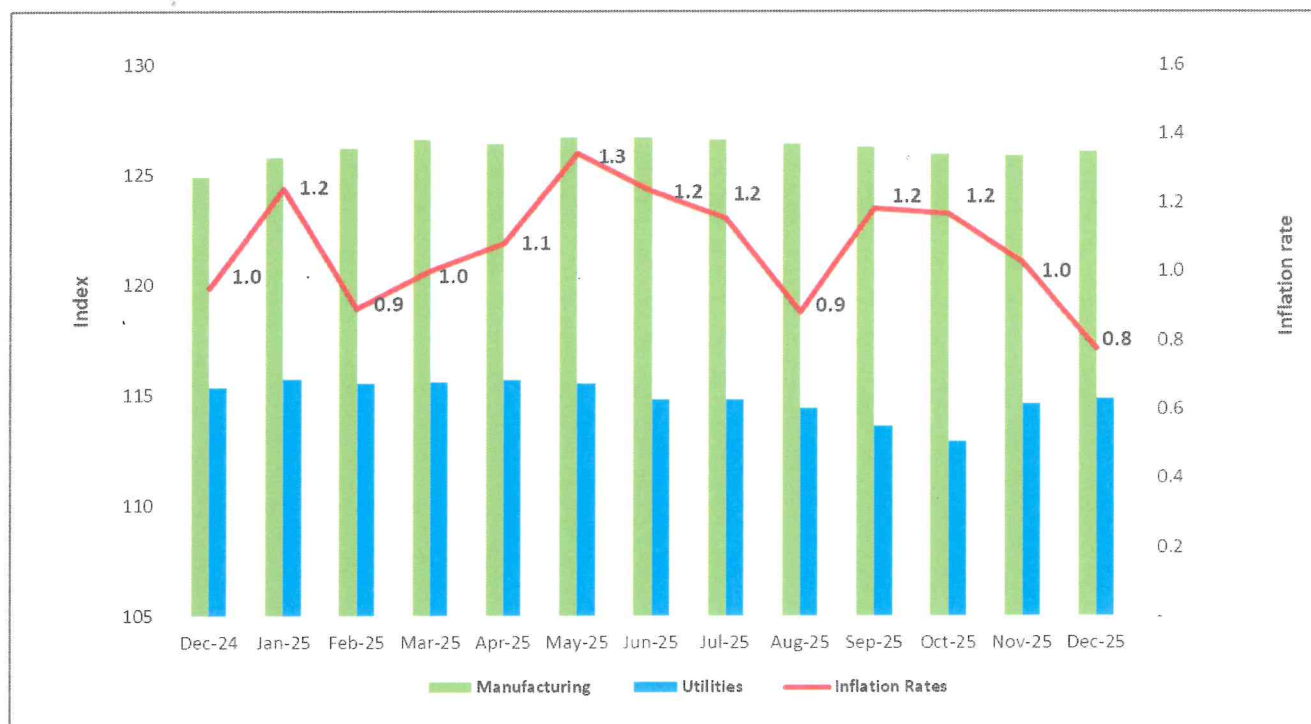
The Annual Inflation for Utilities sector was registered at minus 0.4 percent in the year ended December 2025 compared to minus 1.0 percent registered in the year ended November 2025. The main driver to the Annual Inflation for Utilities sector was the Electric power generation inflation which registered minus 1.9 percent in the year ended December 2025 compared to minus 2.8 percent registered in the year ended November 2025 see table 1 below and appendix table 2.

2.0 PPI M&U Monthly Inflation

The Monthly Headline Inflation as measured by PPI M&U for December 2025 was registered at 0.1 percent the same registered in the month of November 2025 as shown in Table 3 below. This was mainly attributed to the monthly inflation for Manufacturing sector which registered 0.1 percent increase in December 2025 compared to 0.0 percent registered in November 2025 as shown in Appendix Table 3.

The main driver for the Monthly inflation of the Manufacturing sector was the Manufacture of food products inflation which increased by 0.4 percent in December 2025 from 0.2 percent decrease recorded in November 2025 as shown in Appendix Table 3. Specifically, Processing and preserving of meat increased by 4.1 percent in December 2025 compared to 0.5 percent decrease registered in November 2025.

The monthly inflation for Utilities sector was registered at 0.2 percent increase in December 2025, compared to 1.5 percent increase registered in November 2025. This was mainly due to the monthly inflation for the Electric power generation which registered 0.0 percent in December 2025 from 3.2 percent increase registered in November 2025. See Appendix Table 3.
