DEFINITION AND PURPOSE

Distributive Trade statistics is a subject area of economic statistics concerned with the provision of data about economic units whose main activity is Wholesale and Retail i.e. (sale without transformation) of any types of goods together with performing services incidental to sales such as repair, installation and delivery.

The main purpose of the Index of Distributive Trade is to describe the short-term changes in volume of wholesale and retail trade output and distributive trade sectors as a whole and their respective components.



HIGHLIGHTS

Annual Changes

The overall volume of trade in the Distributive trade sector reduced by 3.7% for the year ending Quarter one of FY2020/21 compared to 0.6% decrease for the year ended Quarter four of FY 2019/20.

The Main contributors to the 3.7% decrease in volume of Distributive trade were;

- An 8.4% decrease in volume of trade in the wholesale trade sector for the year ending Quarter one of FY2020/21 compared to a 4.1% decrease for the year ended Quarter four of FY 2019/20.
 - This decrease was mainly driven by a 9.2% decrease in other specialized wholesale subsector in the year ending Quarter one of FY 2020/21 compared to a 3.9% decrease for the year ended Quarter four FY 2019/20.


- A 1.6% decrease in volume of trade in the retail trade sector for the year ending Quarter one of FY2020/21 compared to a 2.5% increase for the year ended Quarter four of FY 2019/20. This decrease was mainly driven by;
 - A 5.4% decrease in Retail sale in nonspecialized stores in the year ending Quarter one of FY 2020/21 compared to a 2.8% decrease for the year ended Quarter four FY 2019/20.
 - A 7.7% decrease in retail sale of goods in specialized stores in the year ending Quarter one of FY 2020/21 compared to a 5.9% increase for the year ended Quarter four FY 2019/20.

Quarterly Changes

Quarterly volume Changes in Distributive Trade Sector

The volume of trade in Distributive trade sector increased by 2.6% in the first quarter of FY2020/21 compared to a 4.5% increase in the fourth Quarter of FY2019/20.


Figure 2. Quarterly percentage volume changes (Total trade)



The 2.6% increase in volume of trade in Quarter one FY2020/21 was mainly due to:

- A 2.0% increase in volume of trade in the wholesale sector in quarter one of FY2020/21 compared to a 5.0% increase in Quarter four of FY 2019/20. This increase was mainly driven by;
 - A 9.5% increase in wholesale of food, beverages and tobacco in Quarter one of FY 2020/21 compared to a 1.0% increase in Quarter four FY 2019/20.
- A 10.1% increase in volume of trade in the trade of motor vehicles and motorcycles in Quarter one of FY2020/21 compared to a 3.0% decrease in Quarter four of FY 2019/20. This increase was mainly driven by:
 - A 15.0% increase in sale of new and used vehicles in Quarter one of FY 2020/21 compared to a 5.1% decrease in Quarter four FY 2019/20.
