It is important to note that, the statistics contained herein exclude informal cross border trade which was suspended in April 2020 due to the outbreak of COVID-19 that led to the closure of borders. This affected small scale cross border trade and hence the Informal Cross border Trade surveys.

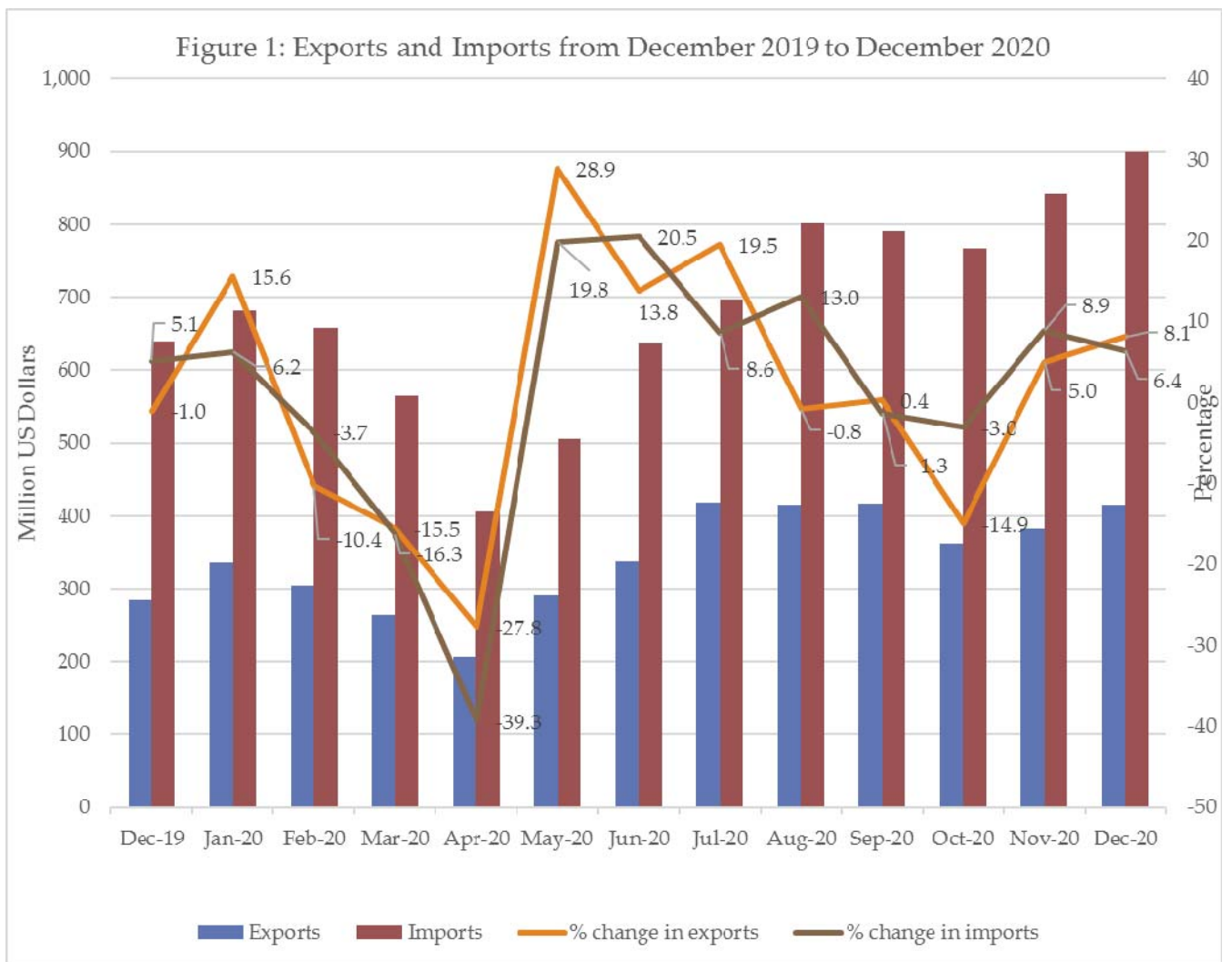
Introduction

The bulletin presents International Merchandise trade statistics (exports and imports flows) between Uganda and the rest of the world as compiled from Customs and Non-Customs data sources. **International merchandise trade** statistics record all goods which add to, or subtract from, the stock of material resources of a country by entering (as imports) or leaving (as exports) its economic territory. The data compiled from customs and commodity authorities is herein referred to as Formal exports and imports.

The compilation of International Merchandise Trade Statistics is based on the General Trade System and coded according to Harmonized Commodity Description and Coding System 2017 (HS2017) and the Standard International Trade Classification (SITC Rev4) commodity nomenclatures as prescribed in the International Merchandise Trade Statistics manual 2010 (IMTS2010).

In December 2020, total trade increased by 7.4 percent to US\$ 1,315.1 million compared to US\$ 1,224.2 million recorded in November 2020. Total exports increased by 8.1 percent increase in December 2020 to US\$ 415.6 million in comparison to US\$ 381.9 million recorded in November 2020. Total imports flows increased by 6.4 percent to US\$ 899.5 million in December 2020 from US\$ 842.3 million registered in November 2020.

Annually, trade flows in December 2020 increased by 42.5 percent from US\$ 922.8 million recorded in December 2019. Imports increased by 40.8 percent in December 2020 compared to December 2019 while Exports increased by about 46.5 percent in December 2020 in comparison to December 2019. Formal exports and imports gradually increased in the period under review as seen in figure 1 and table 1 below.



The total imports bill continued to increase from US\$ 639.1million in December 2019 to the highest of US\$ 899.5million in December 2020.

This shows that the imports bill has continuously increased at a higher rate than export earnings

The trade deficit increased to US\$483.8 million in December 2020 compared to a deficit of US\$460.4 million recorded in November 2020 which were the highest deficits observed in the period under review. See figure 1 above and table 1 below.

Performance of Formal Commodity Exports

Gold and Gold compounds continued to be the leading exported commodity fetching US\$ 211.4 million in December 2020 compared to US\$ 173.9 million received in November 2020, contributing 50.9 percent to total exports in December 2020 compared to 45.5 percent registered in November 2020.

Coffee came second generating revenue of US\$ 37.8 million which accounted for 9.1 percent of total exports in December 2020. This was lower than the November 2020 export earnings of US\$ 38.3 million. Coffee exports were generally affected during the year by seasonal changes that lead to low yields, the COVID 19 pandemic and decline in world market prices.

Fish and fish products was the third most exported by Uganda with export earnings of US\$ 9.6 million in December 2020 accounting for 2.3 percent of export market share. This was however a decline of 25.0 percent in the fish and fish products exported in comparison to US\$ 12.8 million earned in November 2020.

Petroleum products, Cocoa beans, Maize, Tea, Sugar & sugar confectionaries, Animal/vegetable fats and oils, Iron and steel commodities were also among Uganda's leading exports, see Table 2 below.

Formal Commodity Exports by Regions and Countries of destination

Middle East was the leading destination of Uganda's formal exports throughout the period under review followed by EAC, Other Africa, European Union and Asia among others.

In December 2020, formal exports to Middle East stood at US\$ 217.6 million accounting for 52.4 percent of formal exports compared to US\$ 177.8 million registered in November 2020. The leading

country of destination was United Arab Emirates whose revenues amounted to US\$ 215.3 million representing 51.8 percent of total export earnings.

The East African Community (EAC) was the second with US\$ 86.9 million in December 2020 compared to US\$ 93.6 million in November 2020.

Within the EAC, the major destination countries for the period under review were; Kenya and South Sudan fetching US\$ 47.4 million and US\$ 28.7 million respectively in December 2020

compared to US\$ 52.6 million and US\$ 25.9 million recorded in November 2020.

Exports to other African countries increased to US\$ 42.2million in December 2020 compared to US\$ 39.5 million recorded in November 2020. D.R Congo and Sudan were the major countries of destination in the region with a combined market share of 8.3 percent in December 2020 compared to 7.7 percent in November 2020.

Exports to Europe increased to US\$ 41.0 million in December 2020 from US\$ 40.7 million recorded in November 2020. Most countries in this region performed well with the export to Italy leading with US\$ 8.8 million in December 2020 compared to US\$ 11.9 million registered in November 2020. Netherlands, Germany and Belgium were also among the leading countries of destination in the region for the period under review.

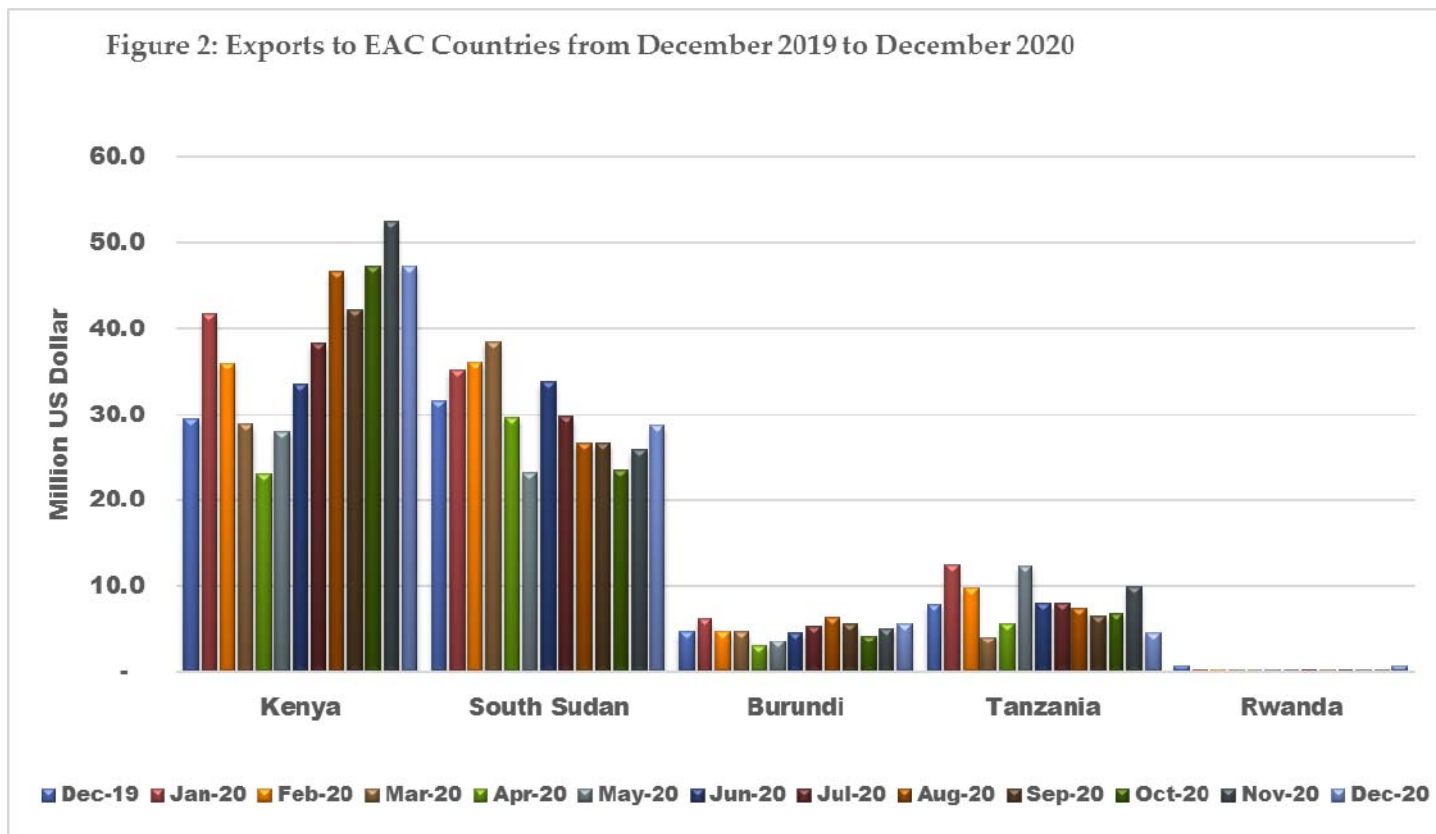
The Asian region had a share of 5.8 percent, resulting from revenue of US\$ 24.0 million in December 2020. India, China and Hong Kong were among the leading destinations of Uganda's exports.

Exports destined to North America/Caribbean were worth US\$ 3.7 million in December 2020. Specifically, these were destined to the United States, Canada, Turkey, Swaziland and United Kingdom, see Annex Table 6.

Formal Exports to East African Community (EAC) Countries

Kenya was the leading destination of Uganda’s exports among the East African Community (EAC) member states in December 2020 generating revenue of US\$ 47.4 million accounting for 11.4 percent of total exports. This

was however a decline in the export earnings to Kenya by 9.9 percent in comparison to US\$ 52.6 million earned in November 2020. South Sudan followed contributing 6.8 percent and 6.5 percent of export earnings in December and November 2020 respectively. Exports to Rwanda were the least due to closure of its busiest borders to Uganda of Katuna and Cyanika thus limiting trade activities, see Figure 2 below and Annex Table 6.



Performance of Formal Commodity Imports

Gold, non-monetary (excl. gold ores and concentrates) was the main imported Commodity into the country with an import bill increasing to US\$ 220.9 million in December 2020 from US\$

173.5 million recorded in November 2020. The proportion of Gold to total imports stood at 24.6 percent in December 2020 compared to 20.6 percent registered in November 2020.

Petroleum products (petrol, diesel, paraffin, aviation fuel and related materials) followed as the most imported products. Their imports bill increased to US\$ 113.2 million in December 2020 from US\$ 66.8 million recorded in November 2020. Petroleum products contributed 12.6 percent to total imports bill during December 2020 in comparison to 7.9 percent recorded in November 2020.

Road vehicles (including air-cushion vehicles) came third but with a slight decline in their import bill to US\$ 62.9 million in December 2020

from US\$ 63.3 million registered in November 2020.

Iron and steel, medical and pharmaceutical products, cereals & cereal preparations, plastics in primary forms, Machinery specialized for particular industries and Fixed vegetable fats and oils, crude, refined or fractionated amongst others were among the leading imported goods, see Table 3 below.

Formal Commodity Imports by Regions and Countries of Origin

The Asia region was the main source of Uganda's merchandise imports. The region's import bill amounted to US\$ 349.0 million in December 2020 compared to US\$ 376.4 million recorded in November 2020. China and India were the leading countries of origin for Uganda's imports in the region. These accumulated expenses worth US\$ 147.5 million and US\$ 99.2 million respectively in December 2020 from US\$ 155.3 million and US\$ 109.9 million recorded in November 2020.

The East African Community (EAC) ranked the second accounting for 19.9 percent of the imports bill in December 2020. Expenses to the region were worth US\$ 196.2 million registered in December 2020 compared to US\$ 162.1 million as recorded in November 2020.

South Africa, Gambia and Egypt were the leading sources of imports from Other Africa region whose import bills were US\$ 46.2 million, US\$ 15.0 million and US\$ 10.3 million respectively in December 2020 compared to US\$ 33.1 million and US\$ 24.4 million and US\$ 11.2 million recorded in November 2020.

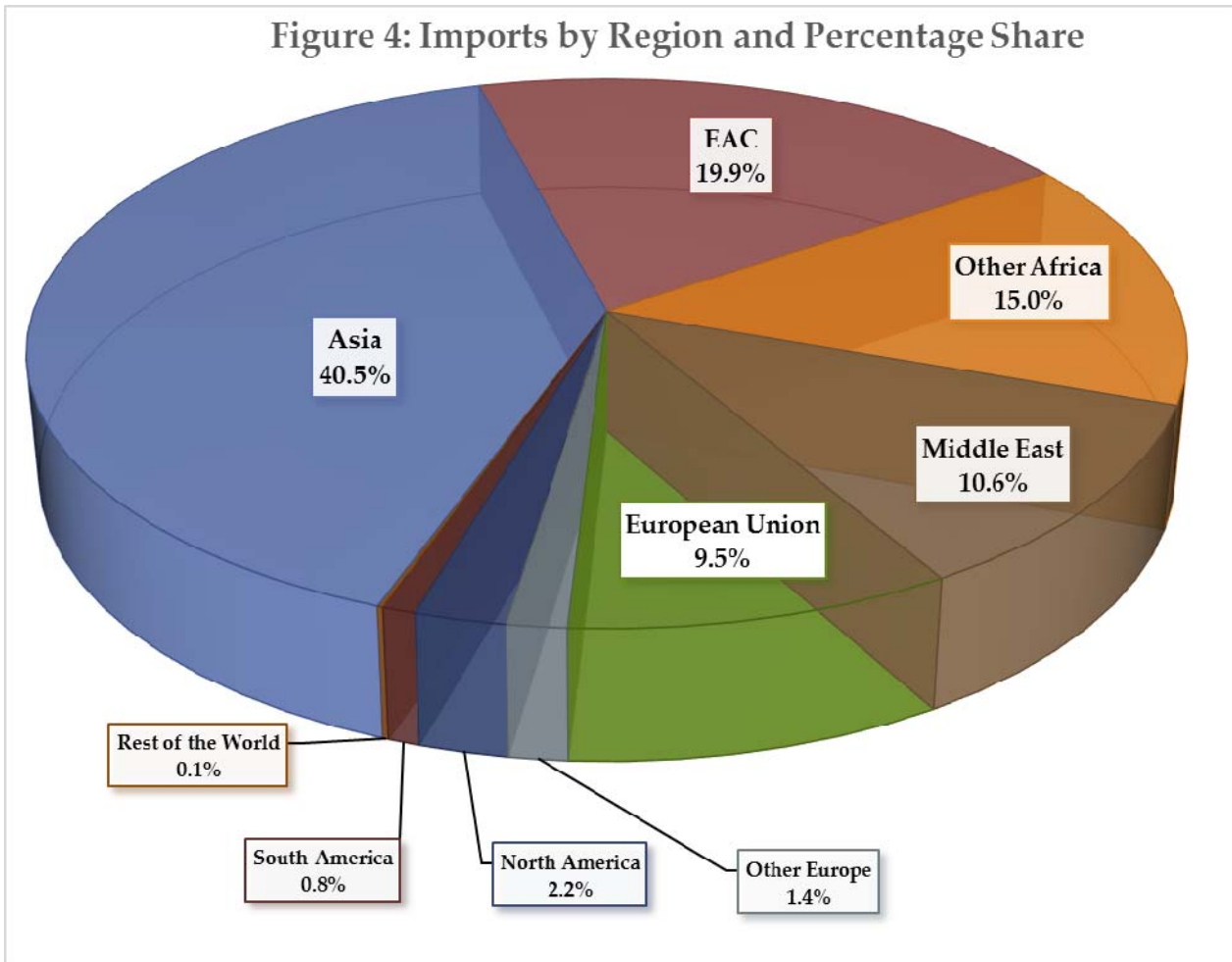
Netherlands was the main origin of imports from European Union region with expenses worth US\$ 66.9 million in December 2020 in comparison to US\$ 15.2 million registered in November 2020. The sharp rise in the imports bill to Netherland was due to increased importation of fuel from the country in the month of December 2020.

Imports from Middle East were US\$ 69.3 million contributing 10.6 percent to total imports in December 2020. United Arab Emirates was the main contributing country within this region with imports of US\$ 47.6 million accounting for 5.3 percent of total imports in both November and December 2020.

United States was the leading country of origin in the North American region and contributed US\$ 14.0 million in December 2020 in comparison to US\$ 11.2 million in November 2020, see Figure 4 and Annex Table 8.

It is worth noting that, 75.4 percent of Uganda's imports originated from the regions of Asia, East African Community (EAC) and Other African during the period under review as seen in Figure 4 below.

Figure 4: Imports by Region and Percentage Share



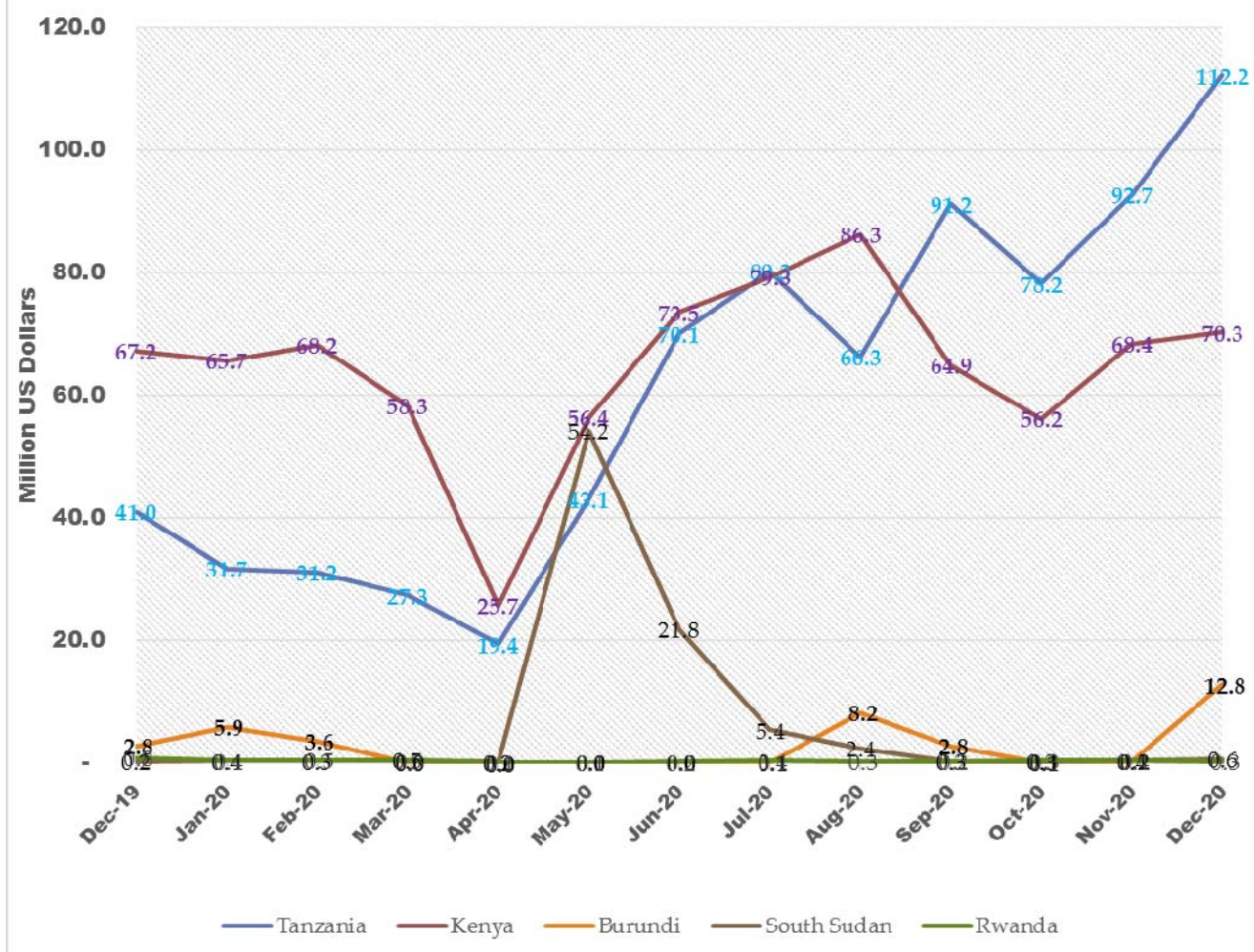
Formal Imports from East African Community (EAC) Countries

In December 2020, Tanzania and Kenya were the major source of Uganda's Imports in the EAC member Countries whose import bill increased to US\$ 112.2 million and US\$ 70.3 million in December 2020 from US\$ 92.7 million and US\$ 68.4 million in November 2020 respectively. It is

observed from the period under review that Uganda imports more from Tanzania and exports less to the same country.

South Sudan and Rwanda are the least countries of origins of Uganda's Imports. See figure 3 below and Annex table 8.

Exports by border station

Entebbe Airport, Malaba, Busia, Elegu, Mpondwe and Mutukula were the major border stations through which Traditional and Non-traditional exports worth US\$ 389.1 million exited the country to different destinations in December 2020 accounting for 93.6 percent of total exports while US\$ 358.8 million exited through the same borders in November 2020 representing 93.9 percent of total exports, see Annex Table 7.

Imports by border station

Malaba, Entebbe Airport, Elegu and Mutukula were the main entry border stations accounting for US\$ 896.8 million of Uganda's imports in December 2020 and representing 99.7 percent of imports getting into the country, see Annex Table 9.
