# PRODUCER PRICE INDICES AND INFLATION RATES

### THIRD OUARTER (JANUARY-MARCH) FY2021/2022

#### 1.0 Annual Inflation


The Annual Inflation as measured by the Producer Price Index for Hotels and Restaurants Services for the 4 Quarters to Quarter Three FY2021/22 increased to 1.6 percent, a slower rate compared to 2.1 percent registered in Quarter Two FY2021/22, Figure 1.

This was attributed to a minus 2.3 percent and 2.8 percent slowdown in the Annual Inflation for Producer Price Index for Catering Services and Producer Price Index for Accommodation respectively in Quarter Three FY2021/22 compared to minus 1.2 percent and 3.0 percent registered in Quarter Two FY2021/22. The drivers were Wines & Sprits whose inflation was registered at 18.1 percent compared to 23.6 percent registered in Quarter Two FY2021/22, Hotel Accommodation at minus 2.9 percent compared to minus 0.2 percent registered in Quarter Two FY2021/22 and Snacks at minus 0.1 percent compared to 1.2 percent registered in Quarter Two FY2021/22, Table 2.

## 2.0 Quarterly Inflation

The Quarterly Inflation for Hotels and Restaurants Services rose by 0.2 percent for Quarter Three FY2021/22 from 0.1 percent rise recorded in Quarter Two FY2021/22, Fig 3 and Table 3.

This is mainly attributed to the Quarterly increase in the Producer Prices for Catering Services that rose by 0.4 percent in Quarter Three FY2021/22 from 0.1 percent rise recorded in Quarter Two FY2021/22.

However, the Quarterly Producer Prices for Accommodation dropped by 0.4 percent in Quarter Three FY2021/22 from 0.3 percent rise registered in Quarter Two FY2021/22, Fig 3 and Table 3.

Fig 2. Quarterly Indices from Q3' FY2020/21 to Q3' FY2021/22




