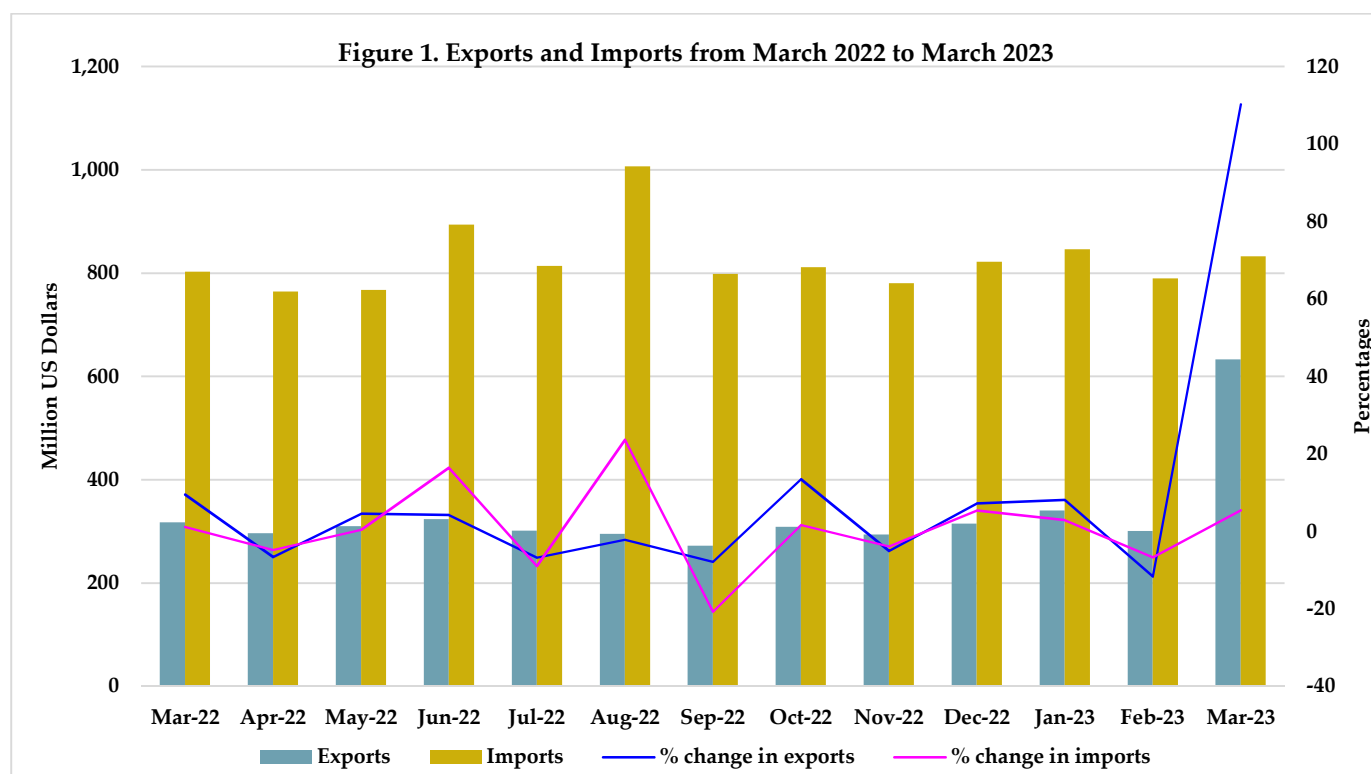
Introduction

This bulletin presents International Merchandise trade statistics (exports and imports flows) between Uganda and the rest of the world as compiled from custom and non-custom data sources. International merchandise trade statistics records all goods which add to, or subtract from, the stock of material resources of a country by entering (as imports) or leaving (as exports) its economic territory. The data compiled from customs and commodities authorities is herein referred to as formal exports and imports.

The compilation of international merchandise trade Statistics is based on the General Trade System and coded according to Harmonized Commodity Description and Coding System 2022 (HS2022) and the Standard International Trade Classification (SITC Rev4) commodity nomenclatures as prescribed in the International Merchandise Trade Statistics manual 2010 (IMTS2010).

In March 2023, total external trade increased by 34.4 percent to US\$ 1,465.9 million from US\$ 1,090.8 million recorded in February 2023. Total exports increased by 110.3 percent to US\$ 632.9 million in March 2023 from US\$ 301.0 million recorded in February 2023. The sharp increase in exports earnings was due to high exports of gold and gold compounds which contributed 42.4 percent to total exports. Total import flows increased by 5.5 percent to US\$ 833.0 million in March 2023 from US\$ 789.8 million registered in February 2023.

Annually, trade flows in March 2023 increased by 30.8 percent to US\$ 1,465.9 million from US\$ 1,120.5 million recorded in March 2022. Imports increased by 3.8 percent to US\$ 833.0 million in March 2023 compared to US\$ 802.8 million recorded in March 2022. Similarly, Exports increased by 99.2 percent to US\$ 632.9 million in March 2023 in comparison to US\$ 317.7 million registered in March 2022. See figure 1 and table 1 below.



The trade deficit decreased to US\$ 200.0 million in March 2023 compared to a deficit of

US\$ 488.8 million recorded in February 2023. See Table 1 below.

Performance of Formal Commodity Exports

The most exported commodity was Gold and gold compounds with revenue earnings of US\$ 268.1 million in March 2023, but no earnings in February 2023.

Coffee was the second most exported commodity whose revenues increased to US\$ 71.5 million, accounting for 11.3 percent of total exports in March 2023 in comparison to US\$ 66.0

million earned in February 2023

Maize, iron and steel, tobacco, fish and fish products, Cocoa Beans, Animal/Veg Fats & Oils, Petroleum Products and cement were also among Uganda's leading exported commodities. See Table 2 below.

Formal Exports by Region and Country of Destination.

In March 2023, Middle East was the major leading destination of Uganda's formal exports followed by EAC, Asia, European Union, Other COMESA, North America, Other Africa and Other Europe.

Formal exports to the Middle East increased drastically to US\$ 216.2 million, accounting for 34.2 percent of total formal exports compared to US\$ 7.9 million registered in February 2023. The leading country of destination was United Arab Emirates with revenues worth US\$ 212.8 million representing 33.6 percent of total export earnings.

Export earnings from EAC increased by 29.8 percent to US\$ 199.5 million, accounting for 31.5 percent of total formal exports compared to US\$ 153.7 million

registered in February 2023. The leading country of destination was Kenya with revenues worth US\$ 68.7 million representing 10.8 percent of total export earnings.

Asia was the third highest export destination region whose earnings increased to US\$ 96.7 million in March 2023 from US\$ 37.8 million recorded in February 2023. Hong Kong, India, China and Indonesia were the major countries of destination in the region, with a combined market share of 13.7 percent in March 2023.

Export earnings from European Union increased by 36.1 percent to US\$ 72.8 million in March 2023 from US\$ 53.5 million receipted in February 2023.

The leading destination countries in European Union were; Italy, Germany, Belgium and Netherlands whose earnings were US\$ 56.7 million accounting for 78 Percent of the exports to the EU in March 2023 from

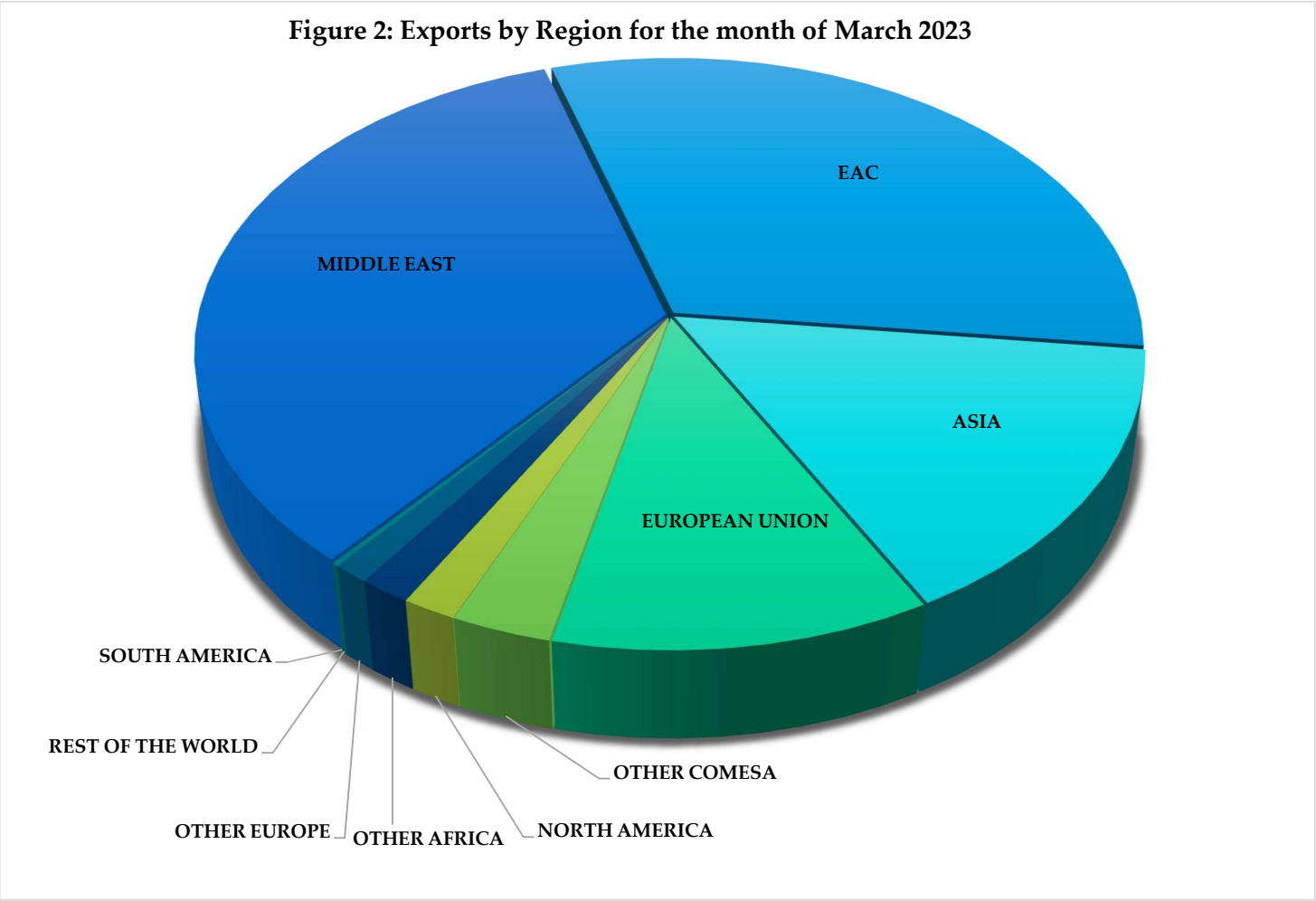
The market shares for Other COMESA (excl EAC) declined to 3.0 percent from 6.5 percent with earnings of US\$ 19.3 million in March 2023 from US\$ 19.7 million recorded in February 2023.

Export earnings from North America also increased

slightly by 1.7 percent to US\$ 10.4 million generated in March 2023 from US\$ 10.1 million registered in February 2023. In particular, these were destined to United States and Canada.

Exports destined to Other Africa increased by 13.1 percent to US\$ 9.8 million in March 2023 from US\$ 8.7 million recorded in February 2023. See Figure 2 below and annex Table 6.

Formal Exports to EAC Countries

Kenya remained the leading destination of Uganda’s exports among the East African Community (EAC) member states in March 2023 accounting for 10.8 percent of total exports. Revenues generated were worth US\$ 68.7 million. This was a 1.2 percent

increase in the export earnings from Kenya after a 6.2 percent increase recorded in February 2023.

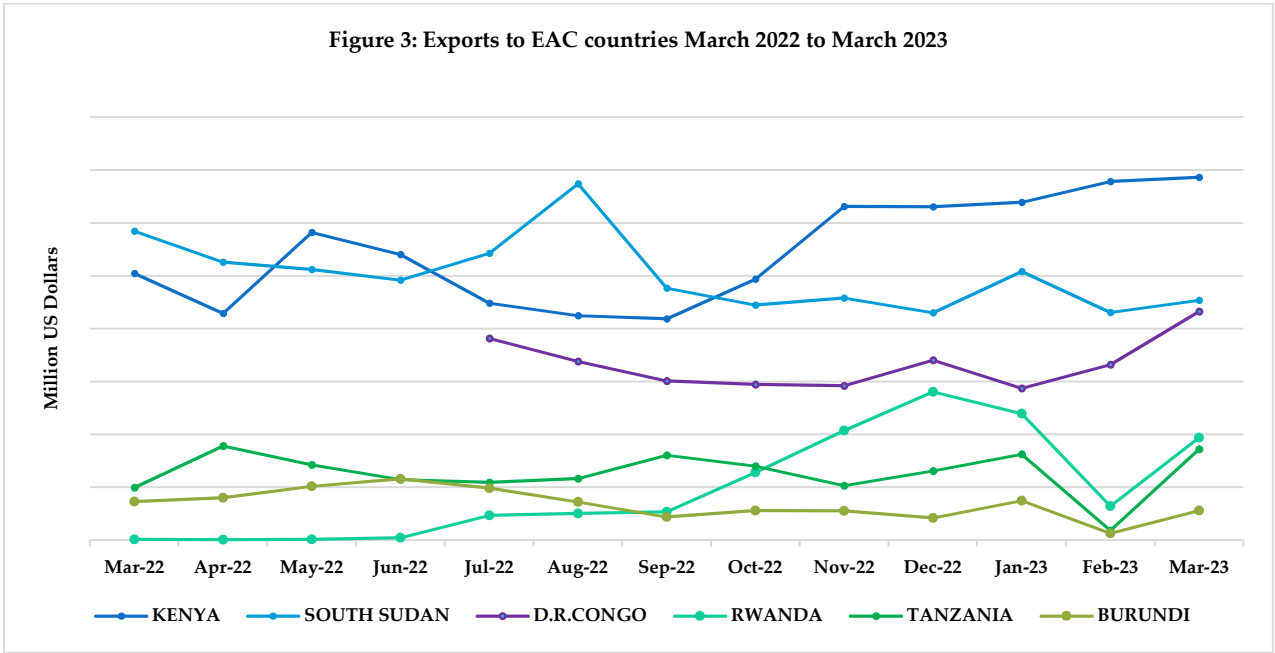
South Sudan was the second highest exports destination country accounting for 7.2 percent of Uganda’s exports

in March 2023, which was a decrease in the share from 14.3 percent registered in February 2023.

Export earnings from D.R. Congo increased to US\$ 43.3 million contributing 6.8 percent to total exports in March 2023 compared to US\$ 33.2 million registered in February 2023.

Exports to Rwanda, Tanzania and Burundi also increased respectively to US\$ 19.4 million, US\$ 17.2 million and US\$ 5.6 million in March 2023 from US\$ 6.4 million, US\$ 1.8 million and 1.3 US\$ million recorded in February 2023. See figure3 below and annex table 6.

Performance of Formal Commodity Imports

Petroleum, petroleum products and related materials were the most imported products accounting for 21.6 percent of total imports in March 2023. The import bill for petroleum products decreased by 3.2 percent to US\$ 180.1 million in March 2023 from US\$ 186.1 million recorded in February 2023.

Road vehicles (including air-cushion vehicles) were the second most imported product with import bill of US\$ 72.2 million in March 2023 from

US\$ 65.8 million registered in February 2023. Importation of Cereals and cereal preparations increased by 13.3 percent to US\$ 44.1 million in March 2023 from US\$ 38.9 million recorded in February 2023 thus accounting for 5.3 percent of total imports.

Iron and steel, Plastics in primary forms, Medical and pharmaceutical products were also among the leading imported products. See Table 3 below.

Formal Imports by Region and Country of Origin

The Asian region remained the main source of Uganda's merchandise for the period under review. The region's import bill increased to US\$ 371.9 million in March 2023 from US\$ 338.6 million recorded in February 2023. China and India were the leading countries of origin of Uganda's imports in the region. Value of imports from China decreased by 1.4 percent to US\$ 159.8 million in March 2023 from US\$ 162.1 million recorded in February 2023 while those from India increased by 29.3 percent to US\$ 107.2 million in March 2023 from US\$ 76.2 million recorded in February 2023.

Middle East ranked the second highest source of imports though its import bill slightly decreased to US\$ 182.8 million in March 2023 from US\$ 188.9

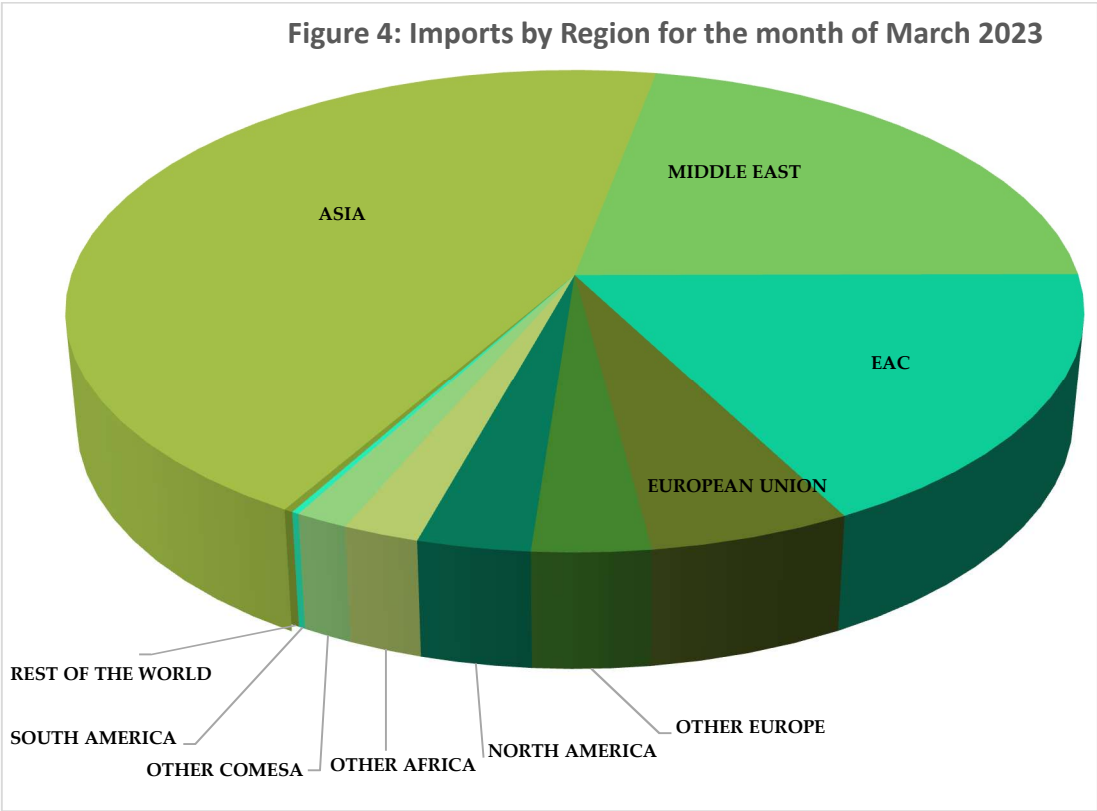
million recorded in February 2023 contributing 21.9 percent to the total imports in March 2023. The import bill from United Arab Emirates is decreased to US\$ 78.1 million accounting for 9.4 percent of total imports in March 2023 from US\$ 159.7 million registered in February 2023. This was due to less imports of petrol and gas oil from the country where much of it was imported from Saudi Arabia and Oman.

Import bill to EAC (East African Community) slightly increased to US\$ 144.9 million in March 2023 from US\$ 107.7 million. Kenya and Tanzania were the leading sources of imports from EAC with import bills of US\$ 82.5 million and US\$ 56.5 million respectively in March 2023 compared to US\$ 84.4 million and US\$ 17.2 million recorded in

February 2023. High imports of Rice, Beans and other legumes, bananas and fruits led to increase of import expenses to Tanzania in March 2023

The Share of Import bill for European Union

increased to 9.7 percent in March 2023 from 5.6 percent registered in February 2023. Expenses to the region decreased to US\$ 46.5 million in March 2023 from US\$ 76.8 million recorded in February 2023. See figure 4 below and annex Table 8.

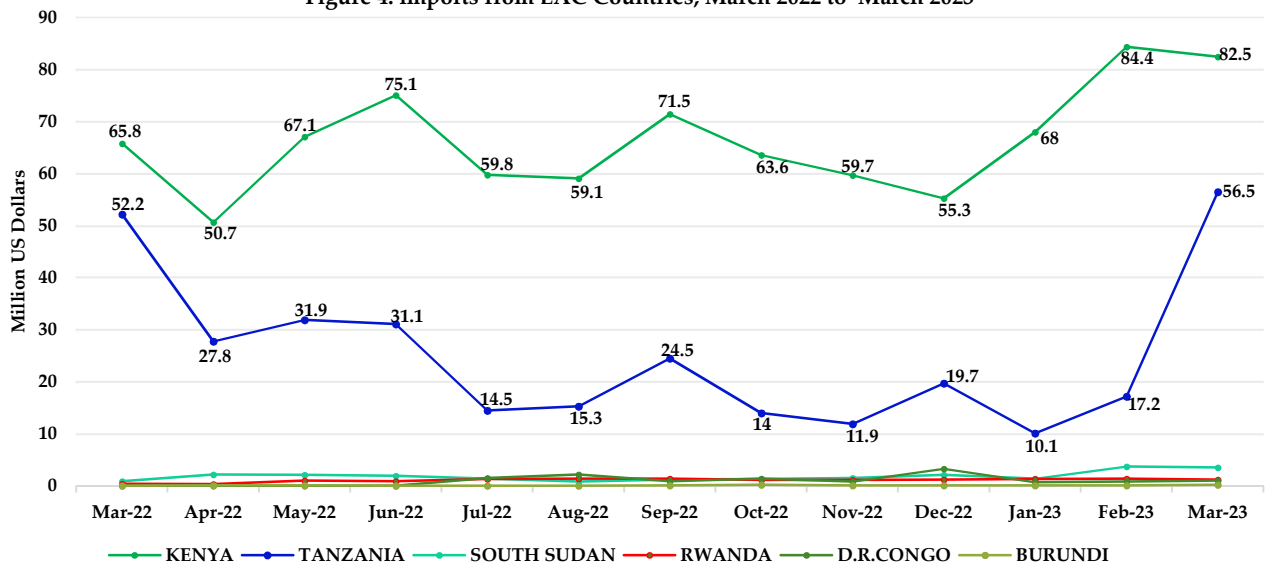


Formal Imports from East African Community (EAC) Countries

In March 2023, Kenya and Tanzania were the major sources of Uganda’s Imports among the EAC member states whose import bills decreased to US\$ 82.5 million and US\$ 56.5 million respectively from US\$ 84.4 million and US\$ 17.2 million

registered in February 2023. Uganda’s Imports from other member states were very low in the period under review. See figure 5 below and Annex table 8.

Exports by border station

Entebbe Cargo, Malaba, Busia, Elegu, Mutukula, Katuna and Mpondwe were the major border stations through which exports worth US\$ 601.5 million exited the country to different destinations in March 2023 accounting for 95.0 percent of total exports in comparison to US\$ 276.4 million (91.8 percent) registered in February 2023, see Annex Table 7.

Imports by border station

Malaba, Busia, Entebbe Cargo and Mutukula were the main entry border stations accounting for 98.8 percent (US\$ 822.6 million) and 98.7 percent (US\$ 779.4 million) of Uganda's imports recorded in March 2023 and February 2023 respectively. See Annex Table 9.
