

FOREWORD

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten baskets of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index was rebased from 2005/2006 to 2009/2010, using weights derived from the Uganda National Household Survey (UNHS IV) that was conducted from May 2009 to April 2010. During the rebasing exercise, Kampala was further decomposed into three baskets from the two that has been existing. In addition, Fortportal Centre was incorporated into the Index. The rebased CPI is now classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP). This is a shift from the Central Product Classification (CPC) that was used in the earlier series.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten baskets mentioned above and indices are available from the EA level.

ACRONYMS AND DEFINITIONS

COICOP: Classification of Individual Consumption According to Purpose, is a nomenclature developed by the United Nations Statistics Division to classify and analyse individual consumption expenditures incurred by households, non-profit institutions serving households and general government according to their purpose.

CPI: Consumer Price Index - a general indicator of price levels paid by households for consumer goods and services.

CPI basket: A commonly used term for the goods and services priced for the purpose of compiling the CPI.

Elementary aggregate: The lowest level of commodity classification in the CPI, and the only level for which index numbers are constructed by direct reference to price data.

Inflation: A term commonly used to refer to changes in price levels. A rise in prices is called inflation, and a persistent fall is called deflation.

Jevons price index: An elementary price index defined as the un-weighted geometric average of the sample price relatives. It can also be defined as the un-weighted geometric average of the current to base period price relatives.

Laspeyres price index: The Laspeyres price index is an index formula used in price statistics for measuring the price development of the basket of goods and services consumed in the base period. The question it answers is how much a basket that consumers bought in the base period would cost in the current period.

Outlet: The interface between a supplier of products and the consumer. It may be a shop, a market stall, a catalogue, a website etc. Also referred to as a "retail outlet", although it can include wholesale outlets which also sell directly to the consumers

Outlier: A term used to describe any extreme value in a set of data, such as a price or price relative that requires further investigation or has been verified as incorrect

Price relative: A measure of price movements: the ratio of the price level in one period to the price level in another.

Reference base: The period in which the CPI is given a value of 100.0. The CPI is currently on a reference base of 2009/10.

Weight: The measure of the importance of an item in the index regimen relative to the other items. Weights can be expressed in either quantity or value terms. Value weights are used in the CPI.

1. HIGHLIGHTS OF CPI FOR AUGUST 2018

1.1 Annual Inflation


The Annual Headline Inflation for the year ending August 2018 has been recorded at 3.8 percent compared to the 3.1 percent that was registered during the year ended July 2018. This is a 0.7 percentage point rise from that recorded during the year ended July 2018.

The rise in Headline Inflation is largely attributed to the Annual Core Inflation that rose to 3.5 percent for the year ending August 2018 compared to the 2.5 percent registered for the year ended July 2018. This increase was due to Annual Services Inflation that registered 5.3 percent for the year ending August 2018 compared to 4.1 percent recorded for the year ended July 2018. In particular, Communication Inflation rose to 12.0 percent for the year ending August 2018 compared to the 5.4 percent recorded in July 2018. Besides, Transport Inflation increased to 15.2 percent for the year ending August 2018 compared to the 12.1 percent recorded in July 2018. The other driver for the rise in Core Inflation was Annual Other Goods Inflation which increased to 2.3 percent for the year ending August 2018 compared to the 1.5 percent recorded for the year ended July 2018.

The Annual Food Crops and Related Items Inflation for the year ending August 2018, which increased to minus 1.2 percent compared to minus 2.0 percent recorded for the year ended July 2018, also contributed to the rise in Headline Inflation. The increase is attributed to Annual Fruits Inflation that registered minus 2.3 percent for the year ending August 2018 compared to minus 3.4 percent recorded for the year ended July 2018. In addition, the Annual Vegetables Inflation increased to minus 2.6 percent for the year ending August 2018 compared to minus 2.8 percent recorded for the year ended July 2018.

However, Energy, Fuels and Utilities (EFU) Annual Inflation declined to 14.1 percent for the year ending August 2018 compared to the 16.0 percent recorded for the year ended July 2018. The decrease in EFU is largely attributed to Solid Fuels that registered 23.4 percent for the year ending August 2018 compared to the 30.2 percent recorded for the year ended July 2018. In particular, Charcoal Inflation decreased to 24.3 percent for the year ending August 2018 compared to the 31.1 percent recorded during the year ended July 2018. Similarly, Firewood Annual Inflation declined to 6.5 percent for the year ending August 2018 compared to the 12.8 percent recorded during the year ended July 2018. The one year series for the Headline Index and the Annual Inflation rates for the three major components are shown in figure 1.

1.2 Annual Headline Inflation by Income Groups and Geographical areas


Kampala High Income registered the highest Annual Inflation of 6.2 percent for the year ending August 2018 compared to 5.0 percent recorded for the year ended July 2018. This rise was mainly driven by Annual Inflation for Transport that increased to 21.9 percent for the year ending August 2018 compared to 18.0 percent recorded for the year ended July 2018. In addition, Communication rose to 12.2 percent for the year ending August 2018 compared to the 5.2 percent registered during the year ended July 2018.

The second highest Inflation was registered in Kampala Low Income at 4.1 percent for the year ending August 2018 compared to 3.3 percent recorded for the year ended July 2018. The main driver for this increase was Annual Inflation for Communication that registered 15.0 percent for the year ending August 2018 compared to 4.3 percent registered for the year ended July 2018. In addition, Transport registered 11.9 percent for the year ending August 2018 compared to 8.6 percent for the year ended July 2018.

Kampala Middle Income registered the third highest annual Inflation of 3.4 percent for the year ending August 2018 compared to 3.2 percent recorded for the year ended July 2018. This was driven by Annual Inflation for Communication that registered 12.3 percent for the year ending August 2018 compared to 3.6 percent registered for the year ended July 2018. In addition, Transport registered an Annual Inflation of 10.1 percent for the year ending August 2018 compared to 6.7 percent for the year ended July 2018.

Annual Inflation figures for all the ten consumption baskets are shown in figure 2 and Table 7.

1.3 Monthly Inflation

The Monthly Headline Inflation for August 2018 has been recorded at a 0.9 percent increase from the 0.4 percent rise recorded in July 2018.

The increase in the Monthly Headline Inflation was due to the Monthly Food Crops and Related Items Inflation that registered a 1.8 percent rise in August 2018 from the minus 7.1 percent recorded in July 2018. The main driver was Monthly Vegetables Inflation that registered an increase of 1.0 percent during the month of August 2018 from the 6.4 percent drop recorded for the month of July 2018. In addition, Fruits Inflation rose to 2.4 percent during the month of August 2018 from the minus 9.8 percent recorded for the month of July 2018.

The Monthly Core Inflation increased by 1.0 percent in August 2018 from the 1.4 percent rise recorded in July 2018. This rise is due to Other Goods Inflation that registered 1.1 percent during the month of August 2018 from the 0.7 percent increase recorded for the month of July 2018.

The Monthly Energy Fuel and Utilities Inflation registered a minus 1.0 percent during the month of August 2018 from the earlier increase of 1.9 percent recorded in July 2018. This was attributed to Monthly Solid Fuels Inflation that dropped by minus 3.4 percent during the month of August 2018 from the minus 0.3 percent recorded for the month ended July 2018. In particular, Monthly Inflation for Charcoal decreased by minus 3.4 percent during the month of August 2018 from the minus 0.2 percent recorded in July 2018. The detailed Monthly Inflation figures per Division are presented in Section 3 of the explanatory notes.


2. ANNUAL INFLATION BY COICOP DIVISIONS

The evolution of Annual Inflation according to COICOP is described in the following paragraphs.

2.1 Food and Non-Alcoholic Beverages

The Annual Inflation for Food and non-alcoholic beverages dropped to minus 1.7 percent for the year ending August 2018 compared to minus 2.6 percent recorded for the year ended July 2018. This was due Annual Food Inflation that declined to minus 1.9 percent for the year ending August 2018 compared to the minus 2.9 percent recorded during the year ended July 2018. The Annual Inflation for Non-Alcoholic Beverages however rose to 1.7 percent for the year ending August 2018 compared to 1.2 percent recorded for the year ended July 2018. Graph 3 shows the trends of Food and Non Alcoholic Beverages Inflation from August 2016 to August 2018.

Figure 3: Food and Non Alcoholic Beverages Annual Inflation Trends; August 2016 – August 2018




2.2 Alcoholic Beverages, Tobacco & Narcotics

The Annual Inflation for Alcoholic Beverages, Tobacco & Narcotics decreased to 2.9 percent for the year ending August 2018 compared to 3.0 percent recorded for the year ended July 2018. This was due to the Annual Inflation of Alcoholic Beverages that dropped to 1.2 percent for the year ending August 2018 compared to 1.5 percent recorded for the year ended July 2018. However, the Annual Tobacco Inflation rose to 20.6 percent for the year ending August 2018 compared to the 19.8 percent recorded for the year ended July 2018.

2.3 Clothing and Footwear

The Annual Inflation for Clothing and Footwear increased to 3.7 percent for the year ending August 2018 compared to 3.4 percent recorded for the year ended July 2018. The rise was mainly attributed to Footwear Inflation that registered 10.4 percent for the year ending August 2018 compared to 7.8 percent recorded for the year ended July 2018. However, Clothing Inflation decreased to 2.3 percent for the year ending August 2018 compared to 2.4 percent recorded during the year ended July 2018. Graph 4 shows the trends of clothing and Footwear from August 2016 to August 2018.

2.4 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and other Fuels comprises of Actual Rentals for Housing, Maintenance & repair of the dwelling, Water Supply, Electricity, Gas and Other Fuels

The Annual Inflation for Housing, water, electricity, Gas & other fuels decreased to 7.7 percent for the year ending August 2018 compared to 9.0 percent recorded for the year ended July 2018. The drop was attributed to Inflation of Electricity, gas and other fuels that registered 17.7 percent for the year ending August 2018 compared to the 21.0 percent recorded for the year ended July 2018. In addition, Maintenance & repair of the dwelling dropped to 5.9 percent for the year ending August 2018 compared to 6.5 percent recorded for the year ended July 2018.

2.5 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture & furnishings, Carpets & Other Floor Coverings, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools & Equipment for House, and Goods & Services for Routine Household Maintenance

The Annual Inflation for Furnishings, household equipment & routine household maintenance registered 4.4 percent for the year ending August 2018 compared to 4.2 percent recorded for the year ended July 2018. This was due to the Annual Inflation for Glassware, tableware and household utensils that registered 1.4 percent for the year ending August 2018 compared to 1.0 percent recorded for the year ended July 2018. In addition, Tools and equipments for house and garden Inflation rose to 6.6 percent for the year ending August 2018 compared to 4.1 percent recorded for year ended July 2018.

2.6 Health

The health Division comprises of Medical Products, Appliances & Equipment, Outpatient Services, and Hospital Services.

The Annual Inflation for Health increased to 2.7 percent for the year ending August 2018 compared

to 2.6 percent recorded for year ended July 2018. The rise was attributed to Annual Inflation for Medical Products, Appliances & Equipment that registered 2.8 percent for the year ending August 2018 compared to 2.3 percent recorded for the year ended July 2018. In addition, Hospital Services inflation rose to 5.5 percent for the year ending August 2018 compared to the 4.3 percent recorded for the year ended July 2018.

2.7 Transport

Transport division comprises of Purchase of vehicles, Operation of Transport and Personal Equipment and Transport Services.

Annual Inflation for Transport increased to 15.2 percent for the year ending August 2018 compared to 12.1 percent recorded for the year ended July 2018. The rise was due to Purchase of Vehicles Inflation that recorded 30.3 percent for the year ending August 2018 compared to 25.3 percent recorded for the year ended July 2018. In addition, Transport Services Inflation rose to 10.4 percent for the year ending August 2018 compared to the 5.9 percent recorded for the year ended July 2018. Also, Operation of Personal transport equipment inflation rose to 13.3 percent for the year ending August 2018 compared to the 13.0 percent recorded for the year ended July 2018.

2.8 Communication

Communication includes Postal services, Telephones and Telefax equipment and Telephone and Telefax services.

The Annual Inflation for Communication registered an increase of 12.0 percent for the year ending August 2018 compared to the 5.4 percent recorded for year ended July 2018. The main driver was Telephone and Telefax services that registered 16.3 percent for the year ending July 2018 compared to the 7.5 percent recorded for the year ended July 2018.

2.9 Recreation and Culture

Recreation and Culture comprises of Audio-visual, photographic & Information processing equipment, Recreational & Cultural services, Newspapers, books & Stationery and Package Holidays.

Annual Inflation for Recreational and Culture rose to 1.5 percent for the year ending August 2018 from the 1.4 percent recorded the year ended July 2018. The increase was attributed to Newspapers, books and stationery Inflation that registered 3.6 percent for the year ending August 2018 compared to 3.2 percent recorded for the year ended July 2018.

2.10 Education

Education comprises of Pre-Primary and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education not definable by level.

The Annual Inflation for Education registered 4.3 percent for the year ending August 2018 compared to the 4.5 percent recorded for the year ended July 2018. This drop was mainly due to the Tertiary Inflation that registered 3.4 percent compared to the 4.9 percent recorded for the year ended July 2018.

2.11 Restaurants and Hotels

Restaurants and Hotels comprises of catering services and accommodation services. Restaurants and Hotels.

Annual Inflation for Restaurants and Hotels decreased to 1.7 percent for the year ending August 2018 compared to 1.9 percent registered for the year ended July 2018. The drop was due to Inflation of Catering services that registered 2.0 percent for the year ending August 2018 compared to 2.4 percent for the year ended July 2018. However, Accommodation services rose to 0.9 percent for the year ending August 2018 compared to 0.8 percent recorded for the year ended July 2018.

2.12 Miscellaneous Goods and Services

Miscellaneous goods and services comprises of Personal Care such as hairdressing salons and personal grooming establishments, Personal Effects such as Jewellery, clocks and watches, Insurance and Other services such as passport fees, photocopying and radio announcements.

The Miscellaneous goods and services Inflation for the year ending August 2018 registered 2.7 percent compared to the 2.3 percent recorded for the year ended July 2018. The rise was due to Inflation of Personal Effects n.e.c that recorded 8.7 percent for the year ending August 2018 compared to 7.1 percent recorded for the year ended July 2018. In addition, Annual Inflation of Personal Care rose to 2.3 percent for the year ending August 2018 compared to 1.8 percent recorded for the year ended July 2018.

3. MONTHLY INFLATION BY COICOP DIVISIONS

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs

3.1 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic beverages rose by 1.7 percent for the month of August 2018 from the minus 2.3 percent recorded for July 2018. The increase was due to Food Inflation that recorded 1.8 percent in August 2018 from the 2.5 percent drop recorded in July 2018. In addition, Non-alcoholic Beverages increased by 0.3 percent for the month of August 2018 from the minus 0.1 percent recorded in July 2018.

3.2 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages & Tobacco registered an increase of 0.1 percent during the month of August 2018 from the 0.2 percent increase recorded in July 2018. The rise was due to Tobacco Inflation that registered 1.1 percent in August 2018 from the 0.6 percent drop recorded for the month of July 2018. However, Alcoholic beverages Inflation remained stable in August 2018 from the 0.3 percent rise recorded in July 2018.

3.3 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear registered a 0.4 percent increase for the month of August 2018, the same rate recorded in July 2018. This rise was mainly attributed to Footwear Inflation that registered 1.7 percent during the month of August 2018 from the 0.1 percent decrease recorded in July 2018. However, Clothing Inflation remained stable for the month of August 2018 from the 0.5 percent increase recorded in July 2018.

3.4 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, water, electricity, Gas & other fuels, registered a decrease of 0.8

percent in August 2018 from the 1.1 percent rise recorded in July 2018. The drop was attributed to Electricity, gas and other fuels Inflation that registered 1.8 percent in August 2018 from the 2.2 percent increase recorded in July 2018.

3.5 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, household equipment & routine household maintenance registered 0.5 percent increase during the month of August 2018 from the 0.1 percent rise recorded for the month of July 2018. This was due to Glassware, tableware and household utensils that rose by 0.6 percent from the 0.0 percent recorded in July 2018. In addition, Furniture and furnishings, carpets and other floor coverings Inflation registered an increase of 0.8 percent in August 2018 from the 0.4 percent rise recorded for the month of July 2018.

3.6 Health

The Monthly Inflation for Health rose by 0.6 percent for the month ending August 2018 from 0.0 percent recorded for the month ended July 2018. The rise was attributed to the Monthly Inflation for Medical Products, Appliances & Equipment that registered 0.5 percent for the month of August 2018 compared to 0.0 percent recorded in July 2018. In addition, Hospital Services inflation rose to 1.2 percent for the month of August 2018 compared to the 0.0 percent recorded in July 2018.

3.7 Transport

Transport division registered an increase of 2.9 percent for the month of August 2018 from the 3.1 percent rise recorded during the month of July 2018. This increase was due to Transport services that registered an increase of 4.5 percent during the month of August 2018 from the 3.0 percent rise recorded for the month of July 2018. In addition, Purchase of Vehicles registered an increase of 2.9 percent during the month of August 2018, though lower than the 6.7 percent rise recorded for the month of July 2018.

3.8 Communication

The Monthly Inflation for Communication registered a 0.1 percent rise for the month of August 2018 from the 20.3 percent increase recorded for the month of July 2018. This was due to the Telephone and Telefax equipment that registered an increase of 0.4 percent for the month ending August 2018 from the minus 0.1 percent recorded for the month ended July 2018.

3.9 Recreation and Culture

Monthly Inflation for Recreational and Culture registered an increase of 0.1 percent during the month of August 2018 from the 0.5 percent rise recorded for the month of July 2018. This rise was attributed to Recreational and Cultural services that rose by 0.3 percent for the month ending August, the same rate recorded for the month ended July 2018. In addition, the Monthly Inflation of Newspapers, books & stationery recorded a 0.3 percent increase during the month of July 2018 from the 0.7 percent rise registered in July 2018.

3.10 Education

Monthly Inflation for Education registered a 0.4 percent rise during the month of August 2018 from the 0.0 percent recorded for the month ended July 2018. This was mainly attributed to the Tertiary Education inflation that rose by 3.4 percent for the month pf August 2018 from the 0.0 percent recorded for the month of July 2018.

3.11 Restaurants and Hotels

The Monthly Inflation for Restaurants and Hotels registered minus 0.2 percent during the month of August 2018 from the 0.0 percent registered for the month of July 2018. This was due to Catering Services dropped by 0.4 percent during the month of August 2018 from the 0.1 percent decrease recorded for the month ended July 2018. However, Accommodation services rose by 0.1 percent during the month of August 2018 from the 0.2 percent increase recorded for the month ended July 2018.

3.12 Miscellaneous Goods and Services

Miscellaneous goods and services Inflation for the month of August 2018 registered 0.4 percent increase from the 0.5 percent rise recorded for the month of July 2018. The rise was mainly attributed to Monthly Inflation for Personal Care Inflation that recorded 0.4 percent during the month of August 2018 from the 0.6 percent increase recorded for the month of July 2018. In addition, Personal effects n.e.c Inflation registered an increase of 1.6 percent for the month of August 2018 from the minus 0.1 percent recorded for the month of July 2018.
