

#### FOREWORD

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten baskets of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index was rebased from 2005/2006 to 2009/2010, using weights derived from the Uganda National Household Survey (UNHS IV) that was conducted from May 2009 to April 2010. During the rebasing exercise, Kampala was further decomposed into three baskets from the two that has been existing. In addition, Fortportal Centre was incorporated into the Index. The rebased CPI is now classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP). This is a shift from the Central Product Classification (CPC) that was used in the earlier series.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten baskets mentioned above and indices are available from the EA level.

#### ACRONYMS AND DEFINITIONS

**COICOP:** Classification of Individual Consumption According to Purpose, is a nomenclature developed by the United Nations Statistics Division to classify and analyse individual consumption expenditures incurred by households, non-profit institutions serving households and general government according to their purpose.

**CPI:** Consumer Price Index - a general indicator of price levels paid by households for consumer goods and services.

**CPI basket:** A commonly used term for the goods and services priced for the purpose of compiling the CPI.

**Elementary aggregate:** The lowest level of commodity classification in the CPI, and the only level for which index numbers are constructed by direct reference to price data.

**Inflation:** A term commonly used to refer to changes in price levels. A rise in prices is called inflation, and a persistent fall is called deflation.

**Jevons price index**: An elementary price index defined as the un-weighted geometric average of the sample price relatives. It can also be defined as the un-weighted geometric average of the current to base period price relatives.

**Laspeyres price index**: The Laspeyres price index is an index formula used in price statistics for measuring the price development of the basket of goods and services consumed in the base period. The question it answers is how much a basket that consumers bought in the base period would cost in the current period.

**Outlet:** The interface between a supplier of products and the consumer. It may be a shop, a market stall, a catalogue, a website etc. Also referred to as a "retail outlet", although it can include wholesale outlets which also sell directly to the consumers

**Outlier:** A term used to describe any extreme value in a set of data, such as a price or price relative that requires further investigation or has been verified as incorrect

**Price relative:** A measure of price movements: the ratio of the price level in one period to the price level in another.

**Reference base:** The period in which the CPI is given a value of 100.0. The CPI is currently on a reference base of 2009/10.

**Weight:** The measure of the importance of an item in the index regimen relative to the other items. Weights can be expressed in either quantity or value terms. Value weights are used in the CPI.

#### 1. HIGHLIGHTS OF CPI FOR OCTOBER 2018

#### 1.1 Annual Inflation


The Annual Headline Inflation for the year ending November 2018 has been recorded at 3.0 percent, the same rate registered during the year ended October 2018. The driver of this Annual Headline Inflation was the Annual Energy, Fuels and Utilities (EFU) Inflation that increased to 7.7 percent for the year ending November 2018 compared to 6.9 percent recorded for the year ended October 2018.

The increase in the Annual EFU Inflation is largely due to Solid Fuels (Charcoal and Firewood), which registered 5.2 percent for the year ending November 2018 compared to the 3.1 percent recorded for the year ended October 2018. Besides, Diesel Annual Inflation increased to 26.7 percent for the year ending November 2018 compared to the 25.5 percent recorded during the year ended October 2018.

The Annual Food Crops and Related Items Inflation for the year ending November 2018, registered minus 3.3 percent compared to minus 3.4 percent recorded for the year ended October 2018. This was due to the Annual Vegetables Inflation that registered minus 1.1 percent for the year ending November 2018 compared to minus 2.3 percent recorded for the year ended October 2018.

However, the Annual Core Inflation recorded 3.4 percent for the year ending November 2018 compared to the 3.5 percent registered for the year ended October 2018. The decline in Annual Core Inflation was driven by the Annual Services Inflation that declined to 4.0 percent for the year ending November 2018, compared to 4.4 percent recorded for year ended October 2018. In particular, Annual Communication Inflation declined to 6.1 percent for the year ending November 2018 compared to 12.4 percent recorded for the year ended October 2018.

The one year series for the Headline Index and the Annual Inflation rates for the three major components are shown in Figure 1.

#### **1.2** Annual Headline Inflation by Income Groups and Geographical areas

Analysis by geographical areas shows that Kampala High Income registered the highest Annual Inflation of 4.7 percent for the year ending November 2018 compared to the 4.6 percent recorded for the year ended October 2018. This is driven by Annual Inflation for Transport that increased to 21.2 percent for the year ending November 2018 compared to 19.2 percent recorded for the year ended October 2018. In addition, Housing, water, gas and other fuels Inflation rose to 3.1 percent for the year ending November 2018 compared to the 2.2 percent registered during the year ended October 2018.

The second highest Inflation was registered in Jinja at 3.3 percent for the year ending November 2018 compared to 3.1 percent recorded for the year ended October 2018. The main driver for this increase was Annual Inflation for Transport that is registered at 14.1 percent for the year ending November 2018 compared to the 13.9 percent registered for the year ended October 2018. In addition, Health inflation increased to 8.6 percent for the year ending November 2018 compared to the 5.2 percent for the year ended October 2018.

The least Annual Inflation was registered in Gulu Centre at 0.0 percent for the year ending November 2018 compared to minus 1.4 percent recorded for the year ended October 2018. This was driven by Annual Inflation for Housing, Water, Electricity, Gas and other Fuels that is registered at 6.4 percent for the year ending November 2018 compared to 0.6 percent registered for the year ended October 2018. In addition, Transport Inflation recorded 9.4 percent for the year ending November 2018 compared to 9.0 percent for the year ended October 2018.




Figure 2: Annual Inflation by Income Groups and Geographical Areas for the year ending October 2018 and November 2018

Annual Inflation figures for all the ten consumption baskets are shown in Figure 2 and Table 7.

#### **1.3** Monthly Inflation

The Monthly Headline Inflation for November 2018 has been recorded at minus 0.1 percent from the 0.3 percent deceleration recorded in October 2018.

The decrease in the Monthly Headline Inflation was attributed to the Monthly Food Crops and Related Items Inflation that registered a minus 1.4 percent in November 2018 from the 1.1 percent decrease recorded in October 2018. This was largely driven by Monthly Vegetables Inflation that declined by 1.5 percent during the month of November 2018 from the 2.7 percent drop recorded for the month of October 2018.

The Monthly Core Inflation registered 0.0 percent in November 2018 from the minus 0.1 percent recorded in October 2018. The monthly Other Goods Inflation registered a 0.1 percent drop during the month of November 2018 from the 0.3 percent decrease recorded for the month of October 2018. This was offset by Services Inflation that recorded a 0.1 percent rise during the month of November 2018, the same rate recorded for the month of October 2018.

The Monthly Energy Fuel and Utilities Inflation registered 0.0 percent during the month of November 2018 from the earlier decrease of 1.2 percent recorded in October 2018. The Monthly Solid Fuels Inflation decreased by 0.5 percent during the month of November 2018 from the 3.1 percent drop recorded for the month ended October 2018. This was offset by the Monthly Inflation for Liquid energy fuels that rose by 0.8 percent during the month of November 2018 from the 0.2 percent rise recorded in October 2018.



#### ANNUAL INFLATION BY COICOP DIVISIONS

The evolution of Annual Inflation according to COICOP is described in the following paragraphs.

#### 1.1 Food and Non-Alcoholic Beverages

The Annual Inflation for Food and non-alcoholic beverages registered minus 2.2 percent for the year ending November 2018, the same rate recorded for the year ended October 2018. This was due Annual Food Inflation that declined to minus 2.4 percent for the year ending November 2018 compared to the minus 2.5 percent recorded during the year ended October 2018. In addition, The Annual Inflation for Non-Alcoholic Beverages dropped to 2.0 percent for the year ending November 2018 compared to 2.1 percent recorded for the year ended October 2018. Graph 3 shows the trends of Food and Non Alcoholic Beverages Inflation from November 2016 to November 2018.



## Figure 3: Food and Non Alcoholic Beverages Annual Inflation Trends; November 2016 – November 2018


#### 1.2 Alcoholic Beverages, Tobacco & Narcotics

The Annual Inflation for Alcoholic Beverages, Tobacco & Narcotics was recorded at 1.5 percent for the year ending November 2018, the same rate recorded for the year ended October 2018. This was due to the Annual Alcoholic Beverages Inflation registered 1.1 percent for the year ending November 2018, the same rate recorded for the year ended October 2018. However, the Annual Inflation of Tobacco that rose to 5.7 percent for the year ending November 2018 compared to 4.7 percent recorded for the year ended October 2018.

#### 1.3 Clothing and Footwear

The Annual Inflation for Clothing and Footwear decreased to 5.9 percent for the year ending November 2018 compared to 6.2 percent recorded for the year ended October 2018. The drop was mainly attributed to Footwear Inflation that registered 8.9 percent for the year ending November 2018 compared to 10.9 percent recorded for the year ended October 2018. However, Clothing Inflation increased to 5.3 percent for the year ending November 2018 compared to 5.2 percent recorded during the year ended October 2018.

Graph 4 shows the trends of clothing and Footwear from November 2016 to November 2018.

#### 1.4 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and other Fuels comprises of Actual Rentals for Housing, Maintenance & repair of the dwelling, Water Supply, Electricity, Gas and Other Fuels

The Annual Inflation for Housing, water, electricity, Gas & other fuels increased to 3.8 percent for the year ending November 2018 compared to 3.3 percent recorded for the year ended October 2018. The rise was attributed to Inflation of Electricity, gas and other fuels that registered 7.7 percent for the year ending November 2018 compared to the 6.3 percent recorded for the year ended October 2018.

#### 1.5 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture & furnishings, Carpets & Other Floor Coverings, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools & Equipment for House, and Goods & Services for Routine Household Maintenance

The Annual Inflation for Furnishings, household equipment & routine household maintenance registered 3.5 percent for the year ending November 2018 compared to 3.6 percent recorded for the year ended October 2018. This drop was due to the Annual Inflation for Household appliances that registered 4.0 percent for the year ending November 2018 compared to 5.2 percent recorded for the year ended October 2018. In addition, Tools and equipment for house and garden Inflation dropped to 2.0 percent for the year ending November 2018 compared to 2.4 percent recorded for year ended October 2018.

#### 1.6 Health

The health Division comprises of Medical Products, Appliances & Equipment, Outpatient Services, and Hospital Services.

The Annual Inflation for Health increased to 2.3 percent for the year ending November 2018 compared to 2.1 percent recorded for year ended October 2018. The rise was attributed to Annual Inflation for Medical Products, Appliances and Equipment that registered 2.4 percent for the year ending November 2018 compared to 2.3 percent recorded for the year ended October 2018. In addition, Outpatient Services Annual inflation registered 0.9 percent for the year ending November 2018 compared to the 0.4 percent recorded for the year ended October 2018.

#### 1.7 Transport

Transport division comprises of Purchase of vehicles, Operation of Transport and Personal Equipment and Transport Services.

Annual Inflation for Transport increased to 15.1 percent for the year ending November 2018 compared to 14.1 percent recorded for the year ended October 2018. The rise was due to Purchase of Vehicles Inflation that recorded 40.5 percent for the year ending November 2018 compared to 35.3 percent recorded for the year ended October 2018. In addition, Transport services Inflation rose to 10.7 percent for the year ending November 2018 compared to the 10.0 percent recorded for the year ended October 2018.

#### 1.8 Communication

Communication includes Postal services, Telephones and Telefax equipment and Telephone and Telefax services.

The Annual Inflation for Communication registered a decrease of 6.1 percent for the year ending November 2018 compared to the 12.4 percent recorded for year ended October 2018. The main driver was Telephone and Telefax services that registered 7.6 percent for the year ending October 2018 compared to the 16.3 percent recorded for the year ended October 2018.

#### 1.9 Recreation and Culture

Recreation and Culture comprises of Audio-visual, photographic & Information processing equipment, Recreational & Cultural services, Newspapers, books & Stationery and Package Holidays.

Annual Inflation for Recreational and Culture increased to 2.2 percent for the year ending November 2018 from the 2.1 percent recorded the year ended October 2018. The rise was attributed to Newspapers, books and stationery Inflation that registered 5.0 percent for the year ending November 2018 compared to 4.8 percent recorded for the year ended October 2018. In addition, Recreation and Cultural Services inflation rose to 0.6 percent for the year ending November 2018 from the 0.0 percent recorded for the year ended October 2018.

#### 1.10 Education

Education comprises of Pre-Primary and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education not definable by level.

The Annual Inflation for Education registered 4.4 percent for the year ending November 2018, the same rate recorded for the year ended October 2018.

#### 1.11 Restaurants and Hotels

Restaurants and Hotels comprises of catering services and accommodation services. Restaurants and Hotels.

Annual Inflation for Restaurants and Hotels decreased to 1.2 percent for the year ending November 2018 compared to 1.3 percent registered for the year ended October 2018. The drop was due to Inflation of Catering services that registered 1.3 percent for the year ending November 2018 compared to 1.5 percent for the year ended October 2018. However, Accommodation services rose to 1.0 percent for the year ending November 2018 compared to 0.9 percent recorded for the year ended October 2018.

#### 1.12 Miscellaneous Goods and Services

Miscellaneous goods and services comprises of Personal Care such as hairdressing salons and personal grooming establishments, Personal Effects such as Jewellery, clocks and watches, Insurance and Other services such as passport fees, photocopying and radio announcements.

The Miscellaneous goods and services Inflation for the year ending November 2018 registered 3.2 percent, the same rate recorded for the year ended October 2018. This was due to Inflation of Personal Care that recorded 2.8 percent for the year ending November 2018, the same rate recorded for the year ended October 2018.

### MONTHLY INFLATION BY COICOP DIVISIONS

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs

#### 2.1 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic beverages dropped by 0.7 percent for the month of November 2018 from the minus 1.0 percent recorded for October 2018. The decrease was due to Food Inflation that recorded minus 0.7 percent in November 2018 from the 1.0 percent drop recorded in October 2018. However, Non-alcoholic Beverages increased by 0.1 percent for the month of November 2018, the same rate recorded in October 2018.

#### 2.2 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages & Tobacco registered an increase of 0.1 percent during the month of November 2018, the same rate recorded in October 2018. The rise was due to Tobacco Inflation that rose by 1.5 percent in November 2018 from the minus 0.6 recorded in October 2018. Alcoholic Beverages inflation, however, registered 0.0 percent for the month of November 2018 from the 0.2 percent rise recorded for the month of October 2018.

#### 2.3 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear registered a 0.5 percent decrease for the month of November 2018 from the 0.2 percent rise recorded in October 2018. This drop was mainly attributed to Clothing Inflation that registered minus 0.6 percent during the month of November 2018 from the 0.3 percent increase recorded in October 2018. However, Footwear Inflation registered a 0.4 percent increase for the month of November 2018 from the 0.2 percent decrease recorded in October 2018 from the 0.2 percent decrease recorded in October 2018.

#### 2.4 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, water, electricity, Gas & other fuels, registered a decrease of 0.1 percent in November 2018 from the minus 0.8 percent recorded in October 2018. The drop was attributed to Electricity, gas and other fuels Inflation that registered minus 0.2 percent in November 2018 from the 1.9 percent drop recorded in October 2018. In addition, Maintenance and repair of the dwelling inflation registered minus 0.1 percent in November 2018 from the minus 0.4 percent recorded in October 2018.

#### 2.5 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, household equipment & routine household maintenance registered a 0.4 percent increase during the month of November 2018 from the 0.2 percent drop recorded for the month of October 2018. This was due to Household textiles that rose by 0.9 percent from the 0.3 percent rise recorded in October 2018. In addition, Household appliances Inflation registered an increase of 0.8 percent in November 2018 from the 0.1 percent drop recorded for the month of October 2018.

#### 2.6 Health

The Monthly Inflation for Health registered 0.2 percent rise for the month ending November 2018 from 0.0 percent recorded for the month ended October 2018. This increase was due to the Monthly Inflation for Medical Products, Appliances & Equipment registered 0.2 percent for the month of

November 2018 compared to the 0.1 percent decrease recorded in October 2018. In addition, Outpatient services monthly inflation rose by 0.5 percent for the month ending November 2018 from the 0.0 percent recorded for the month ended October 2018.

#### 2.7 Transport

Transport division registered an increase of 0.4 percent for the month of November 2018 from the 0.1 percent rise recorded during the month of October 2018. This increase was due to Purchase of vehicles that registered 0.2 percent during the month of November 2018 from the 0.2 percent decrease recorded for the month of October 2018. In addition, monthly Transport inflation registered a 0.6 percent rise for the month of November 2018 from the 0.0 percent during the month of October 2018.

#### 2.8 Communication

The Monthly Inflation for Communication registered 0.0 percent for the month of November 2018, the same rate recorded for the month of October 2018. However, Telephone and telefax equipment monthly inflation rose to 0.1 percent for the month of November 2018 from the minus 0.1 percent recorded for the month of October 2018.

#### 2.9 Recreation and Culture

Monthly Inflation for Recreational and Culture registered 0.0 percent during the month of November 2018 from the 0.1 percent increase recorded for the month of October 2018. Monthly inflation of Package holidays recorded minus 0.6 percent during the month of October 2018 from the 1.9 percent rise registered in October 2018. In addition, Audio-visual, photographic and information processing equipment monthly inflation registered minus 0.2 percent during the month of November 2018 from the 0.1 percent rise recorded for the month of October 2018.

#### 2.10 Education

Monthly Inflation for Education registered 0.0 percent during the month of November 2018 from the 0.4 percent rise recorded for the month ended October 2018.

#### 2.11 Restaurants and Hotels

The Monthly Inflation for Restaurants and Hotels registered 0.0 percent during the month of November 2018 from the 0.3 percent rise registered for the month of October 2018. Catering Services rose by 0.1 percent during the month of November 2018, the same rate recorded for the month ended October 2018. However, Accommodation services that registered 0.0 percent during the month of November 2018 from the 0.7 percent increase recorded for the month ended October 2018.

#### 2.12 Miscellaneous Goods and Services

Miscellaneous goods and services Inflation for the month of November 2018 registered a 0.2 percent increase from the minus 0.2 percent recorded for the month of October 2018. The rise was mainly attributed to Monthly Inflation for Personal Care Inflation that recorded 0.2 percent during the month of November 2018 from the 0.5 percent decrease recorded for the month of October 2018.
