FOREWORD

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten baskets of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index was rebased from 2005/2006 to 2009/2010, using weights derived from the Uganda National Household Survey (UNHS IV) that was conducted from May 2009 to April 2010. During the rebasing exercise, Kampala was further decomposed into three baskets from the two that has been existing. In addition, Fortportal Centre was incorporated into the Index. The rebased CPI is now classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP). This is a shift from the Central Product Classification (CPC) that was used in the earlier series.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten baskets mentioned above and indices are available from the EA level.

ACRONYMS AND DEFINITIONS

COICOP: Classification of Individual Consumption According to Purpose, is a nomenclature developed by the United Nations Statistics Division to classify and analyse individual consumption expenditures incurred by households, non-profit institutions serving households and general government according to their purpose.

CPI: Consumer Price Index - a general indicator of price levels paid by households for consumer goods and services.

CPI basket: A commonly used term for the goods and services priced for the purpose of compiling the CPI.

Elementary aggregate (EA): The lowest level of commodity classification in the CPI, and the only level for which index numbers are constructed by direct reference to price data.

Inflation: A term commonly used to refer to changes in price levels. A rise in prices is called inflation, and a persistent fall is called deflation.

Jevons price index: An elementary price index defined as the un-weighted geometric average of the sample price relatives. It can also be defined as the un-weighted geometric average of the current to base period price relatives.

Laspeyres price index: The Laspeyres price index is an index formula used in price statistics for measuring the price development of the basket of goods and services consumed in the base period. The question it answers is how much a basket that consumers bought in the base period would cost in the current period.

Outlet: The interface between a supplier of products and the consumer. It may be a shop, a market stall, a catalogue, a website etc. Also referred to as a "retail outlet", although it can include wholesale outlets which also sell directly to the consumers

Outlier: A term used to describe any extreme value in a set of data, such as a price or price relative that requires further investigation or has been verified as incorrect

Price relative: A measure of price movements: the ratio of the price level in one period to the price level in another.

Reference base: The period in which the CPI is given a value of 100.0. The CPI is currently on a reference base of 2009/10.

Weight: The measure of the importance of an item in the index regimen relative to the other items. Weights can be expressed in either quantity or value terms. Value weights are used in the CPI.

1.0 HIGHLIGHTS OF CPI FOR NOVEMBER 2019

1.1 Annual Inflation

The Annual Headline Inflation for the year ending November 2019 is recorded at 3.0 percent compared to the 2.5 percent recorded during the year ended October 2019. The increase in Annual Headline inflation is largely attributed to the Annual Core Inflation, which increased to 2.9 percent for the year ending November 2019 compared to the 2.6 percent registered for the year ended October 2019. In addition, the Annual Energy, Fuels and Utilities (EFU) Inflation increased to 7.4 percent for the year ending November 2019 compared to the 5.1 percent recorded for the year ended October 2019.


The driver for the increase in Annual Core inflation was Annual Other Goods Inflation that increased to 3.8 percent for the year ending November 2019 compared to the 3.4 percent recorded for the year ended October 2019. In particular, Annual Inflation for Clothing and Foot wear increased to 4.7 percent for the year ending November 2019 compared to the 3.9 percent recorded in October 2019. Also, the Annual Inflation for Alcoholic Beverages and Tobacco increased to 2.1 percent for the year ending November 2019 compared to the 1.6 percent recorded for the year ended October 2019. However Services Inflation has been recorded at 1.5 percent for the year ending November 2019, the same rate recorded in October 2019.

The increase in Annual EFU Inflation is mainly due to Solid Fuels Inflation that is registered at 23.5 percent for the year ending November 2019 compared to the 16.3 percent recorded for the year ended October 2019. In particular, the Annual Inflation for Charcoal increased to 25.1 percent for the year ending November 2019 compared to the 17.2 percent recorded for the year ended October 2019. However, the Annual Inflation for Liquid Energy Fuels decelerated further to minus 4.2 percent for the year ending November 2019 compared to minus 2.8 percent recorded for the year ended October 2019.

The Annual Food Crops and Related Items Inflation registered 0.0 percent for the year ending November 2019 compared to the minus 0.9 percent recorded for the year ended October 2019. The driver for the increase was Annual Vegetables Inflation that increased to 5.7 percent for the year ending November 2019 compared to the 4.9 percent recorded for the year ended October 2019. In addition, Annual Inflation for Fruits increased to minus 7.7 percent for the year ending November 2019 compared to the minus 8.1 percent recorded in October 2019.

The one year series for the Headline Index and the Annual Inflation for the three major components are shown in Figure 1.

1.2 Annual Headline Inflation by Income Groups and Geographical areas


Analysis by geographical areas and income groups reveal that Gulu registered the highest Annual Inflation of 6.5 percent for the year ending November 2019 compared to the 6.3 percent registered for the year ended October 2019. This was driven by Annual Inflation for Clothing and Foot Wear that is registered at 8.2 percent for the year ending November 2019 compared to the 6.2 percent registered during the year ended October 2019. In addition, Alcoholic Beverages, Tobacco & Narcotics Inflation increased to 7.2 percent for the year ending November 2019 compared to the 3.6 percent registered during the year ended October 2019.

The second highest Inflation was registered in Masaka at 5.7 percent, for the year ending November 2019 though lower than the 5.9 percent recorded for the year ended October 2019. The main driver was Annual Inflation for Transport that rose to 4.7 percent for the year ending November 2019 compared to the 3.6 percent registered during the year ended October 2019. In addition, Health Inflation increased to 3.6 percent for the year ending November 2019 compared to the 3.4 percent registered for the year ended October 2019.

The least Annual Inflation was registered in Mbale at 0.0 percent for the year ending November 2019 the same rate recorded for the year ended October 2019. The Low inflation in the center is mainly due to Annual Inflation for Food and Non Alcoholic Beverages that decelerated to 2.7 percent

for the year ending November 2019 compared to the earlier deceleration of 2.4 percent registered for the year ended October 2019. In addition, Hotel and Restaurants inflation decreased to minus 2.1 percent for the year ending November 2019 the same decrease registered for the year ended October 2019. *Annual Inflation figures for all the ten consumption baskets are shown in Figure 2 and Table 7.*

1.3 Monthly Inflation

The Monthly Headline Inflation for November 2019 increased by 0.3 percent in November 2019 from the 0.2 percent rise recorded in October 2019.

The increase in the Monthly Headline Inflation was attributed to the Monthly Core Inflation that increased by 0.2 percent for the month of November 2019 from the earlier 0.0 percent recorded in October 2019. The increase in Core Inflation was due to the monthly Other Goods Inflation that rose by 0.3 percent during the month of November 2019 from the 0.1 percent drop recorded for the month of October 2019. In addition, Services Inflation increased by 0.2 percent during the month of November 2019 from the 0.1 percent rise recorded for the month of October 2019.

The Monthly Food Crops and Related Items Inflation dropped by 0.5 percent in November 2019 from the 1.0 percent rise recorded in October 2019. The drop was due to Monthly Vegetables Inflation that registered a 0.7 percent decline during the month of November 2019 from the earlier

minus 2.5 percent recorded for the month of October 2019. However, Fruits Inflation rose by 0.5 percent during the month of November 2019 from the 7.6 percent rise recorded for the month of October 2019

The Monthly Energy Fuel and Utilities Inflation rose by 2.1 percent during the month of November 2019 from the 1.3 percent increase recorded in October 2019. The rise was due to the Monthly Solid Fuels Inflation that recorded 5.6 percent rise during the month of November 2019 from the earlier rise of 3.9 percent recorded for the month of October 2019.

The detailed Monthly Inflation figures by COICOP Division are presented in Section 2 of the explanatory notes in the annex.

1. ANNUAL INFLATION BY COICOP DIVISIONS


The evolution of Annual Inflation according to COICOP is described in the following paragraphs.

01 Food and Non-Alcoholic Beverages

The Annual Inflation for Food and Non-Alcoholic Beverages increased to 0.9 percent for the year ending November 2019 compared to 0.3 percent recorded for the year ended October 2019. The increase was due to Annual Food Inflation that registered 0.9 percent for the year ending November 2019 compared to 0.3 percent rise recorded for the year ended October 2019.

Non-Alcoholic Beverages Inflation recorded 0.6 percent for the year ending November 2019 compared to the 1.2 recorded during the year ended October 2019. Figure 3 shows the trends of Food and Non Alcoholic Beverages Annual Inflation from November 2017 to November 2019.

02 Alcoholic Beverages, Tobacco & Narcotics


The Annual Inflation for Alcoholic Beverages, Tobacco & Narcotics increased to 2.1 percent for the year ending November 2019 compared to 1.6 percent recorded for the year ended October 2019. This increase was due to Annual Tobacco Inflation that registered 3.1 percent for the year ending November 2019 compared to 2.0 percent recorded for the year ended October 2019. In addition, Annual Inflation for Alcoholic Beverages increased to 2.0 percent for the year ending November 2019 compared to 1.5 percent recorded for the year ended October 2019.

03 Clothing and Footwear

The Annual Inflation for Clothing and Footwear increased to 4.7 percent for the year ending November 2019 compared to 3.9 percent recorded for the year ended October 2019. The increase is mainly attributed to Clothing Inflation that registered 4.9 percent for the year ending November 2019 compared to 3.9 percent recorded during the year ended October 2019.

Footwear Inflation maintained 4.2 percent for the year ending November 2019 same as recorded for the year ended October 2019. Figure 4 shows the trends of clothing and Footwear Inflation from November 2017 to November 2019.

04 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and other Fuels comprises of Actual Rentals for Housing, Maintenance & repair of the dwelling, Water Supply, Electricity, Gas and Other Fuels.

The Annual Inflation for Housing, water, electricity, Gas & other fuels increased to 5.9 percent for the year ending November 2019 compared to 4.2 percent recorded for the year ended October 2019. The increase was attributed to Electricity, Gas and Other Fuels Inflation that registered 12.3 percent for the year ending November 2019 compared to 8.4 percent recorded for the year ended

October 2019. Actual Rentals for Housing Inflation registered 1.2 percent for the year ending November 2019 same as recorded for the year ended October 2019. However, Maintenance & repair of the dwelling Inflation decreased to 0.0 percent for the year ending November 2019 compared to 0.1 percent recorded for the year ended October 2019.

05 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture & furnishings, Carpets & Other Floor Coverings, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools & Equipment for House, and Goods & Services for Routine Household Maintenance

The Annual Inflation for Furnishings, household equipment & routine household maintenance decreased to 2.1 percent for the year ending November 2019 compared to 2.4 that recorded for the year ended October 2019. This was mainly attributed to Household Textiles Inflation registered 2.4 percent for the year ending November 2019 compared to the 2.9 percent recorded for the year ended October 2019. In addition, Goods & Services for Routine Household Maintenance Inflation decreased to 0.3 percent for the year ending November 2019 compared to 1.2 percent recorded for the year ended October 2019.

06 Health

The health Division comprises of Medical Products, Appliances & Equipment, Outpatient Services, and Hospital Services.

The Annual Inflation for Health registered to 2.7 percent for the year ending November 2019 same to that recorded for the year ended October 2019. The Annual Medical Products, Appliances and Equipment Inflation increased to 3.2 percent for the year ending November 2019 compared to 3.1 percent recorded for the year ended October 2019. However, Annual Outpatient Services inflation decreased to 1.6 percent for the year ending November 2019 compared to 1.9 percent recorded for the year ended October 2019.

07 Transport

Transport division comprises of Purchase of vehicles, Operation of Transport and Personal Equipment and Transport Services.

Annual Inflation for Transport recorded to 4.0 percent for the year ending November 2019 same as recorded for the year ended October 2019. The Purchase of Vehicles Inflation increased to 18.9 percent for the year ending November 2019 compared to the 16.9 percent recorded for the year ended October 2019. However, Operation of Personal Transport Equipment Inflation dropped to minus 0.3 percent for the year ending November 2019 compared to 0.1 percent recorded for the

year ended October 2019. Transport Services Inflation decreased to 0.2 percent for the year ending November 2019 compared to 0.5 percent recorded for the year ended October 2019.

08 Communication

Communication includes Postal services, Telephones and Telefax equipment and Telephone and Telefax services.

The Annual Inflation for Communication registered minus 10.1 percent for the year ending November 2019 same as that recorded for the year ended October 2019. This was due to Telephone and Telefax Services Inflation that recorded minus 13.0 percent for the year ending November 2019 same as that recorded for the year ended October 2019. Additionally, Telephone and Telefax Equipment inflation registered minus 0.1 percent for the year ending November 2019 compared to 0.1 percent recorded for the year ended October 2019.

09 Recreation and Culture

Recreation and Culture comprises of Audio-visual, photographic & Information processing equipment, Recreational & Cultural services, Newspapers, books & Stationery and Package Holidays.

Annual Inflation for Recreation and Culture decreased to 1.5 percent for the year ending November 2019 compared to the 1.7 percent recorded for the year ended October 2019. The drop was attributed to Newspapers, Books & Stationery Inflation that decreased to 2.6 percent for the year ending November 2019 compared to 3.0 percent recorded for the year ended October 2019. In addition, Recreational & Cultural services Inflation decreased to minus 0.1 percent for the year ending November 2019 compared to 0.4 percent recorded for the year ended October 2019.

10 Education

Education comprises of Pre-Primary and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education not definable by level.

The Annual Inflation for Education registered 6.8 percent for the year ending November 2019 same to that recorded for the year ended October 2019. The Pre-Primary and Primary Education inflation recorded to 5.3 percent, Secondary Education Inflation 7.7 percent, Tertiary Education Inflation 7.5, and Education not definable by level 1.0 percent, for the year ending November 2019 same to that recorded for the year ended October 2019 respectively.

11 Restaurants and Hotels

Restaurants and Hotels comprises of catering services and accommodation services. Restaurants and Hotels.

Annual Inflation for Restaurants and Hotels increased to 2.5 percent for the year ending November 2019 compared to the 2.0 percent recorded for the year ended October 2019. This was due to Catering Services Inflation that increased to 3.1 percent for the year ending November 2019 compared to the 2.5 percent recorded for the year ended October 2019. However, Accommodation services Inflation decreased to 0.9 percent for the year ending November 2019 compared to 1.0 percent recorded for the year ended October 2019.

12 Miscellaneous Goods and Services

Miscellaneous goods and services comprises of Personal Care such as hairdressing salons and personal grooming establishments, Personal Effects such as Jewellery, clocks and watches, Insurance and Other services such as passport fees, photocopying and radio announcements.

The Miscellaneous Goods and Services Inflation for the year ending November 2019 increased to 7.7 percent compared to the 7.6 percent recorded for the year ended October 2019. The rise was due to Personal Care Inflation that increased to 7.6 percent for the year ending November 2019 compared to the 7.4 percent recorded for the year ended October 2019. However, Personal Effects n.e.c Inflation decreased to 13.4 percent for the year ending November 2019 compared to 13.8 percent recorded for the year ended October 2019 and other services inflation maintained 7.8 percent for the year ending November 2019 as was recorded for the year ended October 2019

2. MONTHLY INFLATION BY COICOP DIVISIONS

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs

01 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic Beverages registered a decrease of 0.1 percent for the month of November 2019 from the 0.2 percent rise recorded for October 2019. This was due to Food Inflation that recorded a drop of 0.1 percent for the month of November 2019 from the 0.2 percent increase recorded in October 2019. In addition, Non-Alcoholic Beverages Inflation registered a decrease of 0.5 percent for the month of November 2019 from the 0.2 percent that recorded in October 2019.

02 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages, Tobacco & Narcotics registered an increase of 0.7 percent for the month of November 2019 from the 0.1 percent rise recorded in October 2019. This was due to Alcoholic Beverages Inflation registered 0.5 percent rise for the month of November 2019 from the 0.0 percent recorded in October 2019. In addition, Tobacco Inflation registered a rise

of 2.5 percent for the month of November 2019 from the 1.6 percent increase recorded for the month of October 2019.

03 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear registered an increase of 0.3 percent for the month of November 2019 from the 0.2 percent rise recorded in October 2019. This was mainly attributed to Clothing Inflation that registered an increase of 0.3 percent during the month of November 2019 from the 0.2 percent rise recorded in October 2019. In addition, Footwear Inflation registered a rise of 0.4 percent for the month of November 2019 from the 0.1 percent increase recorded in October 2019.

04 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, Water, Electricity, Gas & Other fuels registered a rise of 1.5 percent for the month of November 2019 from the 1.0 percent increase recorded in October 2019. This was mainly attributed to Electricity, Gas and Other Fuels Inflation that registered an increase of 3.4 percent for the month of November 2019 from the 2.2 percent rise recorded for the month of October 2019. Actual Rentals for Housing inflation recorded 0.0 percent for the month of November 2019 from the 0.2 percent recorded for the month of October 2019.

05 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, Household Equipment & Routine Household Maintenance registered an increase of 0.1 percent for the month of November 2019 from the minus 0.1 recorded for the month of October 2019. This was due to Household Appliances Inflation that registered an increase of 0.8 percent for the month of November 2019 from the 0.9 percent drop recorded for the month of October 2019. In addition, Household Textiles Inflation increased by 0.4 percent for the month of November 2019 from the 0.6 percent drop recorded for the month of October 2019.,

06 Health

The Monthly Inflation for Health registered an increase of 0.2 percent for the month of November 2019 from the 0.1 percent rise recorded for the month of October 2019. This was mainly attributed to Medical Products, Appliances and Equipment Inflation that registered a rise 0.3 percent for the month of November 2019 from the 0.2 percent recorded for the month of October 2019. In addition, Outpatient Services Inflation increased by 0.3 percent for the month of November 2019 from the 0.1 percent rise recorded for the month of October 2019. Hospital Services Inflation however, registered a drop of 0.2 percent for the month of November 2019 from the 0.0 percent recorded for the month of October 2019.

07 Transport

Transport Inflation registered an increase of 0.4 percent for the month of November 2019 from the minus 0.6 percent recorded during the month of October 2019. This was due to Purchase of Vehicles inflation that registered an increase of 1.7 percent for the month of November 2019 from the 1.9 percent drop recorded during the month of October 2019. In addition, Transport Services Inflation registered an increase of 0.2 percent for the month of November 2019 from the 0.0 percent recorded during the month of October 2019.

08 Communication

The Monthly Inflation for Communication registered 0.0 percent for the month of November 2019 same as that recorded for the month of October 2019. Telephone and Telefax equipment inflation registered 0.0 percent for the month of November 2019 same as that recorded for the month of October 2019. Telephone and Telefax Services inflation registered 0.0 percent for the month of November 2019 same as that recorded for the month of October 2019.

09 Recreation and Culture

Monthly Recreation and Culture Inflation registered a decrease of 0.2 percent for the month of November 2019 from the 0.1 percent rise recorded for the month of October 2019. This was due to Recreational and Cultural Services inflation that decreased by 0.6 percent for the month of November 2019 from the 0.3 percent rise recorded for the month of October 2019. In addition, Newspapers, Books and Stationery Inflation recorded a 0.2 percent drop for the month of November 2019 from the minus 0.2 that was registered for the month of October 2019.

10 Education

Monthly Inflation for Education registered 0.0 percent for the month of November 2019 from the 0.2 percent recorded for the month of October 2019. Secondary Education inflation recorded 0.0 percent during the month of November 2019 from the 0.4 percent recorded for the month of October 2019. Pre-Primary and Primary Education inflation registered 0.0 percent during the month of November 2019 from the minus 0.1 percent recorded for the month of October 2019.

11 Restaurants and Hotels

The Monthly Inflation for Restaurants and Hotels registered an increase of 0.5 percent for the month of November 2019 from the 0.1 percent drop recorded for the month of October 2019. This was due to Catering Services inflation that recorded an increase of 0.7 percent during the month of

November 2019 from the 0.1 percent drop recorded for the month of October 2019. However, Accommodation services inflation registered a drop of 0.1 percent during the month of November 2019 from the 0.1 percent rise recorded for the month of October 2019.

12 Miscellaneous Goods and Services

Miscellaneous goods and services Inflation for the month of November 2019 registered an increase of 0.3 percent same as was recorded for the month of October 2019. This was due to Personal Care inflation that increased by 0.5 percent for the month of November 2019 from the 0.4 percent rise recorded for the month of October 2019. However, Personal Effects n.e.c inflation dropped by 0.3 percent for the month of November 2019 from the 1.2 percent increase recorded for the month of October 2019.
