CONSTRUCTION INPUT PRICE INDICES AND CONSTRUCTION SECTOR INFLATION

JULY 2024

1.0 Annual Construction Sector Inflation

Construction Sector Inflation as measured by the Construction Input Price Index for Uganda for the 12 months to July 2024 for inputs of the Construction Sector was registered at 1.8 percent compared to 1.9 percent registered for the year ended June 2024 as shown in Table 1. This was mainly attributed to the Annual Construction Sector Inflation of inputs into Specialised Construction Activities which was registered at 1.5 percent for the year ending July 2024 compared to 1.8 percent registered in the year ended June 2024 as shown in Table 2.

The main driver for the Construction Sector Inflation of inputs into Specialised Construction Activities was Demolition and Site Preparation whose Construction Sector Inflation was registered at 3.6 percent in the year ending July 2024 compared to 4.1 percent registered in the year ended June 2024. In addition, the Construction Sector Inflation of inputs for Building Completion and Finishing was registered at 0.6 percent in the year ending July 2024 compared to 1.0 percent in the year ended June 2023.

The Annual Construction Sector Inflation of inputs into Construction of Buildings increased to 2.1 percent for the year ending July 2024 compared to 2.0 percent registered for the year ended June 2024. This was mainly attributed to the Inflation of inputs into Construction of Non-Residential Buildings that increased to 2.5 percent for the year ended July 2024 compared to 2.3 percent registered for the year ended June 2024. The Inflation of inputs for Construction of Residential Buildings increased to 1.8 percent in the year ending July 2024 compared to 1.7 percent registered in the year ended June 2024.

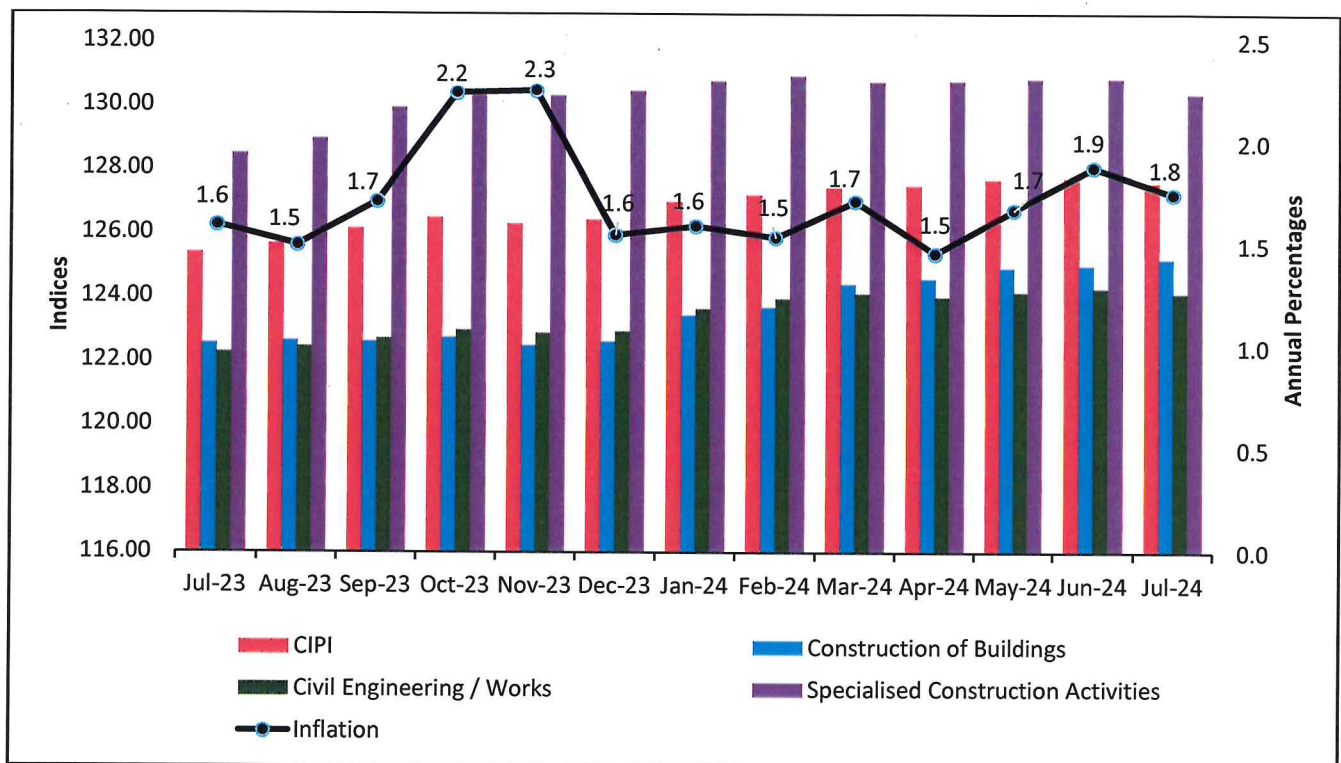
The Annual Construction Sector Inflation of inputs into Civil Engineering/Works was registered at 1.5 percent in the year ending July 2024 compared to 1.9 percent registered for the year ended June 2024. This was mainly attributed to the Inflation of inputs into Construction of Roads and Railways that was registered at 1.5 percent in the year ending July 2024 compared to 2.0 percent registered for the year ended June 2024. Construction of Utility Projects Inflation was registered at 1.5 percent in the year ending July 2024 compared to 1.3 percent registered in the year ended June 2024.

The overall Annual Construction Input Price Index and Construction Sector Inflation for the 12 months to July 2024 are shown in Table 1 below.

The overall Annual Construction Input Price Index and Construction Sector Inflation according to ISIC Divisions of Section F for the 12 months to July 2024 are shown in Table 2 below.

2.0 Monthly Construction Sector Inflation

On a month to month basis, the Construction Sector Inflation of inputs into the Construction Sector decreased by 0.1 percent for the month of July 2024 compared to 0.0 percent registered in the month of June 2024.

This was mainly due to 0.4 percent decrease in the Construction Sector Inflation of inputs into Specialised Construction Activities in July 2024 compared to 0.0 percent registered in June 2024. Specifically, Construction Sector Inflation of inputs into Demolition and Site Preparation decreased by 1.3 percent in July 2024 compared to 0.7 percent decrease registered in June 2024, Electrical, Plumbing and Other Construction Installation Activities Inflation decreased by 0.1 percent in July 2024 compared to 0.9 percent increase registered in June 2024 and Construction Sector Inflation of inputs for Building Completion and Finishing decreased by 0.1 percent in July 2024 compared to 0.0 percent registered in June 2024 as shown in Table 3 below.

In the month of July 2024, products whose prices decreased were; Diesel by 1.4 percent in July 2024 compared to 0.7 percent decrease registered in June 2024. Doors, Windows and Frames of Iron prices decreased by 0.0 percent in July 2024 compared to 0.3 percent increase in June 2024 and Timber prices decreased by 0.5 percent in July 2024 compared to 0.0 percent change registered in June 2024.

However, Sand prices increased by 0.1 percent in July 2024 compared to 0.2 percent decrease registered in June 2024, Paints & Vanishes prices increased by 0.3 percent in July 2024 compared to 0.3 percent decrease registered in June 2024. Eucalyptus props prices increased by 1.3 percent in July 2024 compared to 0.4 percent increase registered in the month of June 2024.

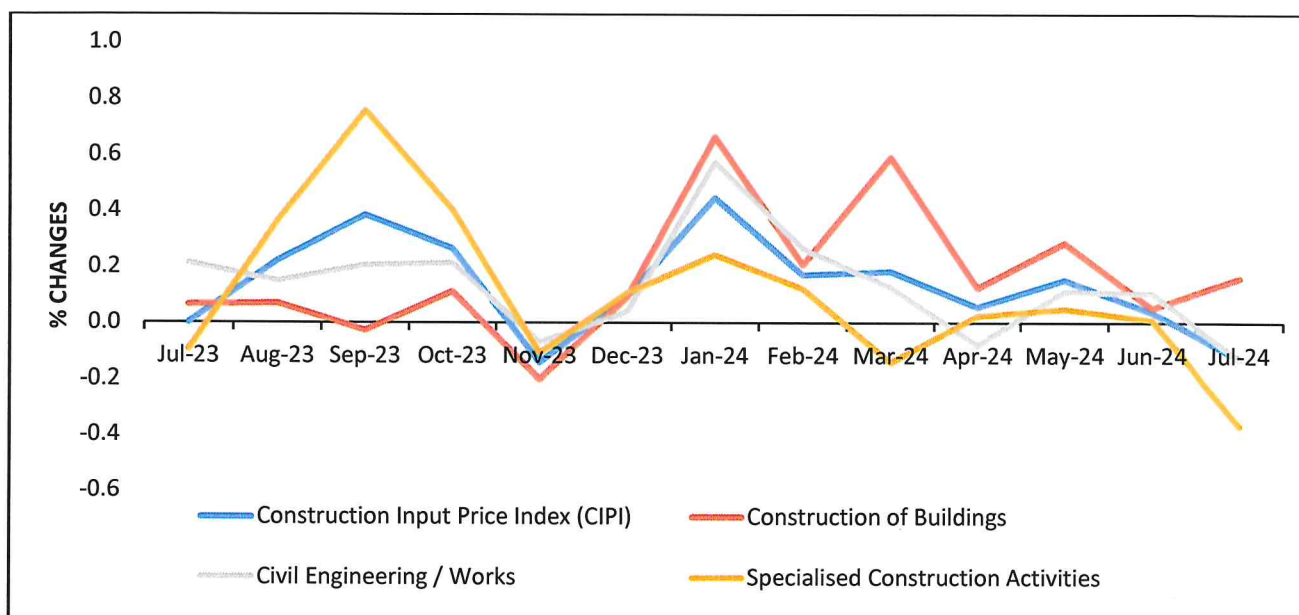
