CONSTRUCTION INPUT PRICE INDICES AND CONSTRUCTION SECTOR INFLATION

OCTOBER 2024

1.0 Annual Construction Sector Inflation

Construction Sector Inflation as measured by the Construction Input Price Index for Uganda for the 12 months to October 2024 for inputs of the Construction Sector was registered at 0.8 percent compared to 1.2 percent registered for the year ended September 2024. This was mainly attributed to the Annual Construction Sector Inflation of inputs into Specialised Construction Activities which was registered at minus 0.2 percent for the year ending October 2024 compared to 0.4 percent registered in the year ended September 2024. See Tables 1 and 2 for more details.

The main driver for the Construction Sector Inflation of Specialised Construction Activities was Demolition and Site Preparation whose Construction Sector Inflation was registered at minus 4.3 percent in the year ending October 2024 compared to minus 1.4 percent registered in the year ended September 2024. However, the Construction Sector Inflation for Building Completion and Finishing was registered at 0.9 percent in the year ending October 2024 compared to 0.7 percent in the year ended September 2024 and the Construction Sector Inflation for Electrical, Plumbing and Other Construction Installation was registered at 1.9 percent in the year ended September 2024 compared to 1.8 percent in the year ended September 2024.

The Annual Construction Sector Inflation of Civil Engineering/Works was registered at 0.7 percent in the year ending October 2024 compared to 1.0 percent registered for the year ended September 2024. This was mainly attributed to the Inflation of inputs into Construction of Roads and Railways which was registered at 0.7 percent in the year ended October 2024 compared to 1.0 percent registered in the year ended September 2024. Construction of Utility Projects Inflation was registered at 0.6 percent in the year ending October 2024 compared to 0.7 percent registered for the year ended September 2024.

The Annual Construction Sector Inflation of Construction of Buildings was registered at 2.0 percent for the year ending October 2024 compared to 2.2 percent registered for the year ended September 2024. This was mainly attributed to the Inflation of inputs into Construction of Non-Residential Buildings that was registered at 2.2 percent for the year ending October 2024 compared to 2.4 percent registered for the year ended September 2024. The Inflation of inputs for Construction of Residential Buildings was registered


at 1.9 percent in the year ending October 2024 compared to 1.9 percent registered in the year ended September 2024.

The overall Annual Construction Input Price Index and Construction Sector Inflation for the 12 months to October 2024 are shown in Table 1 below.

The overall Annual Construction Input Price Index and Construction Sector Inflation according to ISIC Divisions of Section F for the 12 months to October 2024 are shown in Table 2 below.

2.0 Monthly Construction Sector Inflation

On a month to month basis, the Construction Sector Inflation of inputs into the Construction Sector decreased by 0.1 percent for the month of October 2024 compared to 0.1 percent increase registered in the month of September 2024.

This was mainly due to 0.2 percent decrease in the Construction Sector Inflation of inputs into Specialised Construction Activities in October 2024 compared to 0.1 percent increase registered in September 2024. Specifically, Construction Sector Inflation of inputs into Demolition and Site Preparation decreased by 1.2 percent in October 2024 compared to 0.6 percent decrease registered in September 2024. However, Construction Sector Inflation of inputs for Electrical, plumbing and other construction installation activities increased by 0.1 percent in October 2024 compared to 0.9 percent in September 2024 and Building completion and finishing increased by 0.1 percent in October 2024 compared to 0.1 percent increase registered in September 2024 as shown in Table 3 below.

In the month of October 2024, products whose prices decreased were; Cement by 1.1 percent in October 2024 from 1.7 percent decrease registered in September 2024, Diesel decreased by 1.4 percent in October 2024 from 0.7 percent decrease registered in September 2024, Aggregates by 0.1 percent in October 2024 from 0.4 percent decrease in September 2024 and Sheet Steel & Roofing Sheets by 0.3 percent in October 2024 from 4.1 percent increase in September 2024.

However, Sand prices increased by 0.1 percent in October 2024 compared to 0.1 percent decrease registered in September 2024, Adhesives prices increased by 0.6 percent in October 2024 compared to 0.0 percent registered in September 2024. Nails prices increased by 1.8 percent in October 2024 compared to 1.2 percent decrease registered in the month of September 2024.


