

### **Foreword**

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten baskets of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index was rebased from 2005/2006 to 2009/2010, using weights derived from the Uganda National Household Survey (UNHS IV) that was conducted from May 2009 to April 2010. During the rebasing exercise, Kampala was further decomposed into three baskets from the two that has been existing. In addition, Fortportal Centre was incorporated into the Index. The rebased CPI is now classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP). This is a shift from the Central Product Classification (CPC) that was used in the earlier series.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten baskets mentioned above and indices are available from the EA level.

# Highlights of CPI, August 2017


### 1. Annual Inflation

The Annual Headline Inflation for the year ending August 2017 is 5.2 percent compared to the 5.7 percent recorded during the year ended July 2017. This represents a 0.5 percentage point drop from the previous month.

The drop in Annual Headline Inflation was due to the decline in Annual Food Crops Inflation which is recorded at 11.8 percent for the year ending August 2017 compared to 12.9 percent for the year ended July 2017. The driver for the lower Annual Food Crops Inflation was Fruits Inflation that declined to 17.4 percent for the year ending August 2017 compared to the 24.2 percent registered during the year ended July 2017.

In addition, the Annual Core Inflation declined to 4.1 percent for the year ending August 2017 compared to the 4.5 percent recorded for the year ended July 2017. This drop was due to Services Inflation that decreased to 3.3 percent for the year ending August 2017 compared to 4.0 percent recorded for the year ended July 2017. In addition, Other Goods Inflation declined to 4.6 percent for the year ending August 2017 compared to the 4.9 percent recorded during the year ended July 2017.

The Annual Energy, Fuels and Utilities (EFU) Inflation registered 7.8 percent for the year ending August 2017, the same rate recorded during the year ended July 2017. The Annual Inflation for solid fuels (charcoal & firewood) increased to 7.1 percent for the year ending August 2017 compared to 6.7 percent recorded for the year ended July 2017. However, Liquid Energy Fuels inflation declined to 5.7 percent for the year ending August 2017 compared to 6.4 percent recorded in July 2017. The one year series for the Headline Index and the Annual Inflation rates for the three major components are shown in Graph 1.



# 2. Annual Headline Inflation by Income Groups and Geographical Areas

Fort Portal registered the highest Annual Inflation of 9.2 percent for the year ending August 2017 though lower than 9.9 percent recorded for the year ended July 2017. This drop driven by Annual Inflation for Food and non-alcoholic beverages that registered 18.1 percent for the year ending August 2017 compared to the 19.3 percent recorded for the year ended July 2017. In addition, the Annual Inflation for Restaurants & Hotels registered 11.0 percent for the year ending August 2017 compared to the 11.2 percent registered during the year ended July 2017.

The second highest inflation was registered in Arua at 8.9 percent for the year ending August 2017 compared to 7.7 percent recorded for the year ended July 2017. The main driver was high Annual Inflation for Food and non-alcoholic beverages that registered 17.7 percent for the year ending August 2017 compared to the 15.1 percent for the year ended July 2017. In addition, Housing, Water, Electricity, Gas and other Fuels recorded an annual inflation of 4.3 percent for the year ending August 2017 compared to the minus 1.4 percent registered for the year ended July 2017.

Gulu registered the third highest annual inflation of 7.9 percent for the year ending August 2017 though lower than 9.0 percent recorded for the year ended July 2017. This decline was driven by Food and non-alcoholic beverages Inflation that declined to 18.3 percent for the year ending August 2017 compared to 19.2 percent that was recorded during the year ended July 2017. In addition, Restaurants & Hotels inflation declined to 6.7 percent for the year ending August 2017 compared to the 9.0 percent recorded during the year ended July 2017. Annual Inflation for all the ten consumption baskets are shown in Graph 2 and Table 7 below.

# 3. Monthly Inflation

The Monthly Headline Inflation for August 2017 increased by 0.2 percent from the 0.5 percent drop recorded in July 2017. This was due to Monthly Food Crops & Related Items Inflation that increased by 0.9 percent during the month of August 2017 from the earlier drop of 2.9 percent recorded in July 2017. In addition, Monthly Core Inflation registered a 0.0 percent in August 2017 from the 0.3 percent drop recorded in July 2017. Also, the Monthly Energy Fuel and Utilities (EFU) Inflation increased by 0.6 percent for the month of August 2017 from the 1.1 percent rise recorded in July 2017. The detailed Monthly Inflation figures per Division are presented in Section 2 of the explanatory notes.

### **EXPLANATORY NOTES FOR THE INFLATION OF AUGUST 2017**

# **SECTION 1: Annual Inflation by COICOP¹ Divisions**

The evolution of Annual Inflation according to COICOP is described in the following paragraphs

# 01 Food and Non-Alcoholic Beverages

The Annual Inflation for Food and non-alcoholic beverages dropped to 10.6 percent for the year ending August 2017 compared to 10.8 percent recorded for the year ended July 2017. The drop was due to a decline in Annual Food Inflation to 11.2 percent for the year ending August 2017 compared to the 11.5 percent recorded during the year ended July 2017. The Annual Inflation for Non-Alcoholic Beverages registered a 0.4 percent for the year ending August 2017 compared to 0.7 percent recorded for the year ended July 2017. Graph 3 shows the trends of Food and Non Alcoholic Beverages Inflation from December 2014 to August 2017

# 02 Alcoholic Beverages, Tobacco & Narcotics

The Annual Inflation for Alcoholic Beverages, Tobacco & Narcotics declined to 0.3 percent for the year ending August 2017 compared to 0.5 percent recorded for the year ended July 2017. The decrease was due to Annual Inflation of Tobacco that decreased to minus 0.3 percent for the year ending August 2017 compared to 2.0 percent recorded for the year ended July 2017. In addition, Alcoholic Beverages Inflation decreased to 0.3 percent for the year ending August 2017 compared to the 0.4 percent recorded for the year ended July 2017.

#### 03 Clothing and Footwear

The Annual Inflation for Clothing and Footwear decreased to 3.7 percent for the year ending August 2017 compared to 4.6 percent recorded for the year ended July 2017. The decrease was mainly attributed to Clothing Inflation that registered 4.4 percent for the year ending August 2017 compared to 5.3 percent for the year ended July 2017. In addition, Foot wear Inflation declined to 0.5 percent for the year ending August 2017 compared to 1.4 percent recorded during the year ended July 2017. Graph 4 shows the trends of clothing and Footwear from December 2014 to August 2017.

# 04 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and other Fuels comprises of Actual Rentals for Housing, Maintenance & repair of the dwelling, Water Supply, Electricity, Gas and Other Fuels

The Annual Inflation for Housing, water, electricity, Gas & other fuels increased to 5.1 percent for the year ending August 2017 compared to 5.0 percent recorded for the year ended July 2017. The increase was attributed to Inflation of Electricity, Gas and Other Fuels that recorded 7.0 percent for the year ending August 2017 compared to 6.7 percent recorded for the year ended July 2017. However, Annual Inflation for Water Supply and Miscellaneous Services relating to the dwelling decreased to 9.7 percent for the year ending August 2017 compared to 9.9 percent recorded for the year ended July 2017. Also, Annual Inflation for Maintenance and repair of the dwelling decreased to 1.0 percent for the year ending August 2017 compared to 2.3 percent recorded for the year ended July 2017.

## 05 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture & furnishings, Carpets & Other Floor Coverings, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools & Equipment for House, and Goods & Services for Routine Household Maintenance

The Annual Inflation for Furnishings, household equipment & routine household maintenance dropped to 5.1 percent for the year ending August 2017 compared to 5.2 percent recorded for the year ended July 2017. This drop was attributed to Annual inflation for Goods and Services for Routine Household Maintenance that decreased to 3.7 percent for the year ending August 2017 compared to 4.2 percent recorded for the year ended July 2017. In addition, Tools and Equipment for House and Garden inflation decreased to 12.9 percent for the year ending August 2017 compared to 13.6 percent recorded for year ended July 2017. However, Furniture & furnishings, Carpets & Other Floor Coverings inflation increased to 5.0 percent for the year ending August 2017 compared to 3.6 percent recorded for year ended July 2017.

#### 06 Health

The health Division comprises of Medical Products, Appliances & Equipment, Outpatient Services, and Hospital Services.

The Annual Inflation for Health registered 1.2 percent for the year ending August 2017, the same rate registered for the year ended July 2017. The was due to Annual Inflation for Outpatient services that rose to 2.6 percent for the year ending August 2017 compared to 1.4 percent registered for the year ended July 2017. However, the

Annual Inflation for Hospital Services dropped to 2.2 percent for the year ending August 2017 from the 2.9 percent registered for the year ended July 2017. In addition, Medical products, appliances & equipment inflation decreased to 0.4 percent in August 2017 compared to 0.7 percent recorded for year ended July 2017.

# **07 Transport**

Transport division comprises of Purchase of vehicles, Operation of Transport and Personal Equipment and Transport Services.

Annual Inflation for Transport declined to minus 1.3 percent for the year ending August 2017 compared to 0.3 percent drop recorded for the year ended July 2017. The decline was due to Purchase of Vehicles inflation that dropped to minus 13.8 percent for the year ending August 2017 compared to minus 10.2 percent recorded for the year ended July 2017. However, Annual Inflation for Operation of personal transport equipment increased to 4.8 percent for the year ended July 2017.

#### **08 Communication**

Communication includes Postal services, Telephones and Telefax equipment and Telephone and Telefax services.

The Annual Inflation for Communication registered minus 7.7 percent for the year ending August 2017 compared to minus 2.1 percent recorded for year ended July 2017. The main driver was Telephone and telefax services that registered a decrease of 9.9 percent for the year ending August 2017 compared to minus 2.6 percent recorded for the year ended July 2017. Telephone and telefax equipment also decreased to minus 0.4 percent for the year ending August 2017, the same rate recorded in July 2017.

### 09 Recreation and Culture

Recreation and Culture comprises of Audio-visual, photographic & Information processing equipment, Recreational & Cultural services, Newspapers, books & Stationery and Package Holidays.

Annual inflation for Recreational and Culture registered 8.2 percent for the year ending August 2017, the same rate recorded for the year ended July 2017. This was attributed due to Recreational and Cultural Services Inflation that registered 24.8 percent for the year ending August 2017 compared to 25.2 percent recorded for the year ended July 2017. However, Package holiday's inflation increased to 7.0 percent for the year ending August 2017 compared to 6.5 percent recorded for the year ended July 2017. Also, Audio-visual, photographic & Information processing equipment Inflation increased to 0.7 percent for the year ending August 2017 compared to 0.5 percent recorded for the year ended July 2017.

#### 10 Education

Education comprises of Pre-Primary and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education not definable by level. The Annual Inflation for Education increased to 7.7 percent for the year ending August 2017 from the 7.2 percent recorded for the year ended July 2017. This rise was due to Tertiary Education that recorded 4.3 percent rise for the year ending August 2017 from 0.2 percent recorded for the year ended July 2017.

#### 11. Restaurants and Hotels

Restaurants and Hotels comprises of catering services and accommodation services. Restaurants and Hotels. Annual inflation for Restaurants and Hotels decreased to 6.1 percent for the year ending August 2017 compared to 6.9 percent registered for the year ended July 2017. The decrease was due to inflation of Catering services that registered 7.0 percent for the year ending August 2017 compared to 7.8 percent for the year ended July 2017. In addition, Accommodation services declined to 4.0 percent for the year ending August 2017compared to 5.0 percent for the year ended July 2017.

#### 12. Miscellaneous Goods and Services

Miscellaneous goods and services comprises of Personal Care such as hairdressing salons and personal grooming establishments, Personal Effects such as Jewellery, clocks and watches, Insurance and Other services such as passport fees, photocopying and radio announcements.

The Miscellaneous goods and services Inflation for the year ending August 2017 decreased to 1.2 percent compared to 1.4 percent recorded for the year ended July 2017. The decrease was due to Inflation of Personal Effects n.e.c that recorded an inflation of minus 2.9 percent for the year ending August 2017 compared to minus 2.8 percent recorded for the year ended July 2017. In addition, the Annual Inflation for Insurance decreased to 1.1 percent for the year ending August 2017 compared to 0.9 percent recorded for the year ended July 2017.

# **SECTION 2: Monthly Inflation by COICOP Divisions**

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs

# 01 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic beverages rose by 0.7 percent for the month of August 2017 from the 1.5 percent decrease recorded for July 2017. The increase was due to Food inflation that recorded 0.7 percent in August 2017 from the 1.6 percent drop recorded in July 2017. However, Non-alcoholic Beverages decreased by 0.2 percent for the month of August 2017 from the 0.1 percent rise recorded in July 2017.

# 02 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages & Tobacco registered a 0.2 percent increase during the month of August 2017 from the stable inflation recorded in July 2017. The increase was due to Monthly Inflation of Alcoholic Beverages that registered 0.2 percent in August 2017 from the stable inflation recorded for the month of July 2017. In addition, Tobacco inflation registered an increase of 0.5 percent in August 2017 from 0.4 rise recorded in July 2017.

#### 03 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear registered a stable inflation for the month of August 2017 from the rise of 0.8 percent recorded in July 2017. This was mainly attributed to clothing inflation that registered 0.2 percent rise during the month of August 2017 from the 1.1 percent increase recorded in July 2017. This increase was offset by Monthly Inflation for Foot wear that declined by 0.6 percent for the month of August 2017 from the minus 0.7 percent recorded in July 2017.

### 04 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, water, electricity, Gas & other fuels, registered an increase of 0.3 percent in August 2017 from the 0.8 percent rise recorded in July 2017. It was attributed to Electricity, Gas & other Fuels inflation registered 1.0 percent increase in August 2017 from the 0.5 percent recorded in July 2017.

# 05 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, household equipment & routine household maintenance increased by 0.3 percent during the month of August 2017 from the 0.1 percent drop recorded for the month of July 2017. The rise was due to Furniture and furnishings, Carpets and Other Floor Coverings inflation of 1.0 percent from 0.5 percent drop recorded in July 2017. In addition, Household textiles Inflation registered an increase of 0.4 percent in August 2017 from 0.5 percent rise recorded for the month of July 2017.

#### 06 Health

The Monthly Inflation for Health increased by 0.5 percent during the month of August 2017 from the 0.1 percent rise recorded for the month of July 2017. The increase was due to Monthly Inflation for Outpatient services that recorded 1.7 percent rise in August 2017 from the stable inflation recorded for the month of July 2017. However, Medical products, appliances & equipment and Hospital services inflation remained stable during the month of August 2017.

#### **07 Transport**

Transport division registered an increase in the monthly inflation 0.1 percent for the month of August 2017 from the minus 0.7 percent recorded during the month of July 2017. The driver for the increase was the Monthly Inflation for Transport services that registered 0.3 percent during the month of August 2017 from a stable inflation recorded for the month of July 2017. In addition, Operation of Personal Transport Equipment monthly inflation rose by 0.5 percent in August 2017 from the 0.2 percent drop recorded during the month of July 2017. However, Monthly inflation for Purchase of vehicles registered minus 1.1 percent during the month of August 2017 from the decrease of 3.1 percent during the month of July 2017.

#### **08 Communication**

The Monthly Inflation for Communication decreased to 5.8 percent during the month of August 2017 from the 2.3 percent drop recorded for the month of July 2017. The main driver for the decrease was Telephone and telefax services inflation that recorded 7.5 percent during the month of August 2017 from the minus 2.6 percent registered in July 2017. In addition, Telephone and Telefax Equipment inflation registered 0.3 percent decline during the month of August 2017 from a decrease of 1.6 percent recorded for the month of July 2017. Postal services inflation, however, remained stable during the month of August 2017, similar to that recorded during the month of July 2017.

## 09 Recreation and Culture

Monthly inflation for Recreational and Culture decreased by 0.1 percent during the month of August 2017 from the 0.3 percent rise recorded for the month of July 2017. The decrease is attributed to monthly inflation of Newspapers, books and stationery that dropped by 0.2 percent for in August 2017 from the 0.3 percent rise in July 2017. However, Package holidays inflation rose by 0.3 percent during the month of August 2017 from the minus 0.9 percent recorded in July 2017.

# 10 Education

Monthly inflation for Education recorded a 0.5 percent increase during the month of August 2017 from a stable inflation recorded for the month ended July 2017. The rise was attributed to Tertiary Education that registered a 4.9 percent rise in August 2017 from the stable inflation recorded in July 2017. However, Pre-Primary & Primary Education, Secondary education and Education not defined by level inflation registered a stable inflation in August 2017, similar to that recorded in July 2017.

#### 11 Restaurants and Hotels

The Monthly Inflation for Restaurants and Hotels registered 0.0 percent during the month of August 2017 from the 0.8 percent rise registered for the month July 2017. This was due to Catering Services that registered 0.0 percent during the month of August 2017 from the 1.1 percent rise recorded for the month of July 2017. In addition, Accommodation Services inflation registered minus 0.1 percent during the month of August 2017 from the 0.0 percent recorded for the month of July 2017.

### 12 Miscellaneous Goods and Services

Miscellaneous goods and services Inflation for the month of August 2017 registered minus 0.1 percent from the 0.8 percent drop recorded for the month of July 2017. The drop was mainly attributed to Monthly Inflation for Personal care inflation that recorded 0.1 percent drop during the month of August 2017 from the 1.0 percent decrease recorded for the month of July 2017. In addition, other services n.e.c inflation registered a minus 0.1 percent during the month of August 2017 from 0.0 percent recorded in July 2017. However, Personal effects n.e.c registered 0.1 percent increase for the month of August 2017 form the minus 0.8 percent drop recorded for the month of July 2017.
