Foreword

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten baskets of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index was rebased from 2005/2006 to 2009/2010, using weights derived from the Uganda National Household Survey (UNHS IV) that was conducted from May 2009 to April 2010. During the rebasing exercise, Kampala was further decomposed into three baskets from the two that has been existing. In addition, Fortportal Centre was incorporated into the Index. The rebased CPI is now classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP). This is a shift from the Central Product Classification (CPC) that was used in the earlier series.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten baskets mentioned above and indices are available from the EA level.

Highlights of CPI, July 2017

1. Annual Inflation

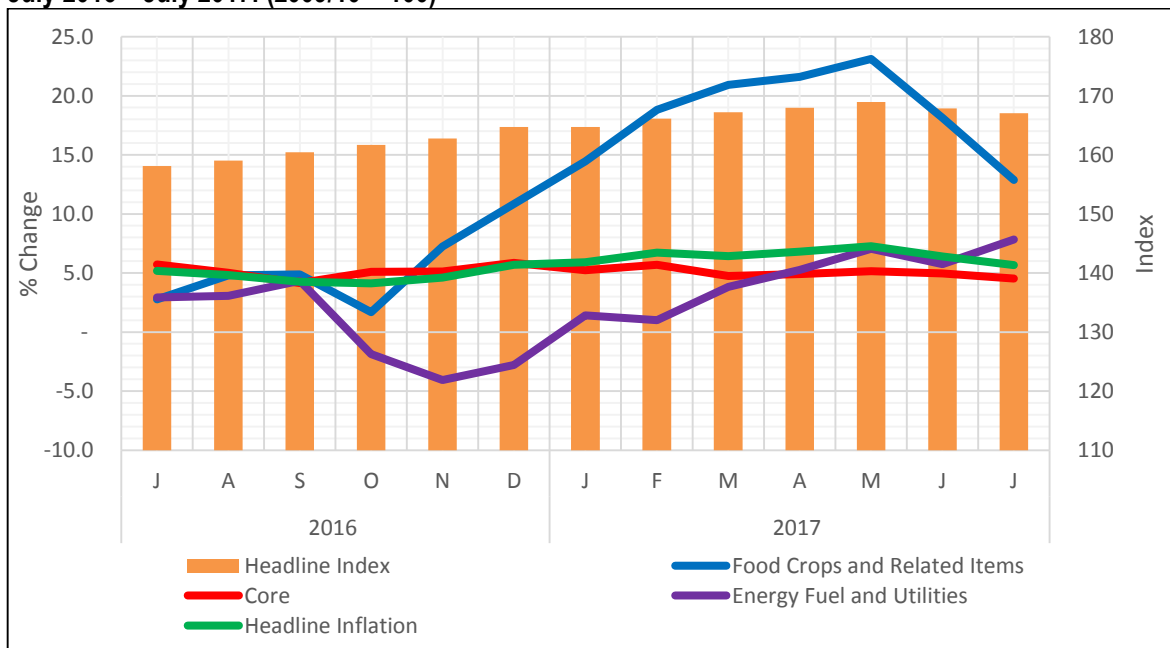
The Annual Headline Inflation for the year ending July 2017 is 5.7 percent compared to the 6.4 percent recorded during the year ended June 2017. This represents a 0.7 percentage point drop from the previous month.

The drop in Annual Headline Inflation was due to the decline in Annual Food Crops Inflation which is recorded at 12.9 percent for the year ending July 2017 compared to 18.1 percent for the year ended June 2017. The driver for the lower Annual Food Crops Inflation were Vegetables Inflation that declined to 4.9 percent for the year ending July 2017 compared to the 9.6 percent registered during the year ended June 2017. Fruits inflation also declined to 24.2 percent for the year ending July 2017 compared to the 32.4 percent recorded for the year ended June 2017. The lower inflation for fruits and vegetables is attributed to increased supply to the market during the month.

In addition, the Annual Core Inflation declined to 4.5 percent for the year ending July 2017 compared to the 4.9 percent recorded for the year ended June 2017. This drop was due to Other Goods Inflation that declined to 4.9 percent for the year ending July 2017 compared to the 5.6 percent recorded during the year ended June 2017. Services Inflation, however, increased to 4.0 percent for the year ending July 2017 compared to 3.9 percent recorded for the year ended June 2017.

The Annual Energy, Fuels and Utilities (EFU) Inflation increased to 7.8 percent for the year ending July 2017 compared to the 5.7 percent recorded during the year ended June 2017. The drivers for the increase were Annual Inflation for solid fuels (charcoal & firewood) that recorded 6.7 percent for the year ending July 2017 compared to 2.7 percent recorded for the year ended June 2017. On the other hand, liquid fuels inflation dropped to 5.1 percent for the year ending July 2017 compared to 6.6 percent recorded in June 2017. In particular, diesel inflation declined to 14.8 percent for the year ending July 2017 compared to 21.9 percent recorded in June 2017. The one year series for the Headline Index and the Annual Inflation rates for the three major components are shown in Graph 1.

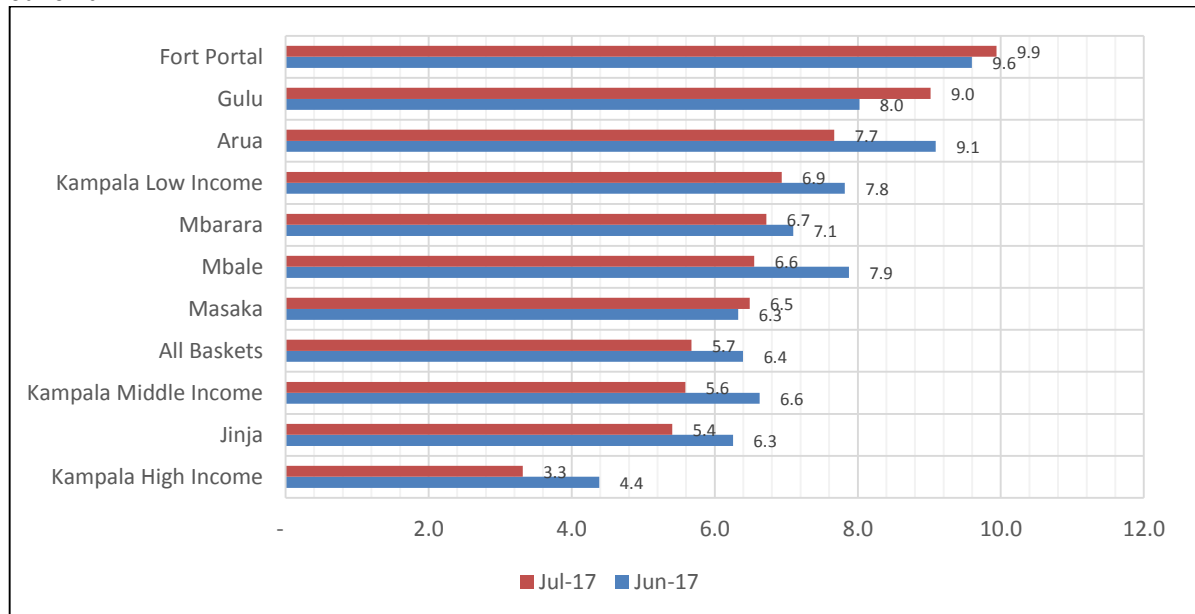
2. Annual Headline Inflation by Income Groups and Geographical Areas

Fort Portal registered the highest Annual Inflation of 9.9 percent for the year ending July 2017 compared to the 9.6 percent recorded for the year ended June 2017. This was driven by high Annual Inflation for Food and non-alcoholic beverages that increased to 19.3 percent for the year ending July 2017 compared to the 18.9 percent recorded for the year ended June 2017. In addition, the Annual Inflation for Clothing and Footwear rose to 12.7 percent for the year ending July 2017 compared to the 10.0 percent registered during the year ended June 2017.

The second highest inflation was registered in Gulu at 9.0 percent for the year ending July 2017 compared to 8.0 percent recorded for the year ended June 2017. The main driver was high Annual Inflation for Food and non-alcoholic beverages that registered 19.2 percent for the year ending July 2017 compared to the 16.7 percent for the year ended June 2017. In addition, Clothing and Footwear recorded an annual inflation of 7.4 percent for the year ending July 2017 compared to the 5.6 percent registered for the year ended June 2017.

Arua registered the third highest annual inflation of 7.7 percent for the year ending July 2017 though lower than 9.1 percent recorded for the year ended June 2017. This drop was driven by Food and non-alcoholic beverages Inflation that declined to 15.1 percent for the year ending July 2017 compared to 18.8 percent that was recorded during the year ended June 2017. In addition, Housing, Water, Electricity, Gas and other Fuels inflation registered a minus 1.4 percent for the year ending July 2017 compared to the 1.9 percent recorded during the year ended June 2017. Annual Inflation for all the ten consumption baskets are shown in Graph 2 and Table 7 below.

3. Monthly Inflation

The Monthly Headline Inflation for July 2017 declined by 0.5 percent from the 0.6 percent drop recorded in June 2017. This was due to Monthly Food Crops & Related Items Inflation that declined by 2.9 percent during the month of July 2017 from the earlier drop of 7.5 percent recorded in June 2017. In addition, Monthly Core Inflation declined by 0.3 percent in July 2017 from the 0.4 percent rise recorded in June 2017. However, the Monthly Energy Fuel and Utilities (EFU) Inflation increased by 1.1 percent for the month of July 2017 from the 0.1 percent recorded in June 2017. The detailed Monthly Inflation figures per Division are presented in Section 2 of the explanatory notes.

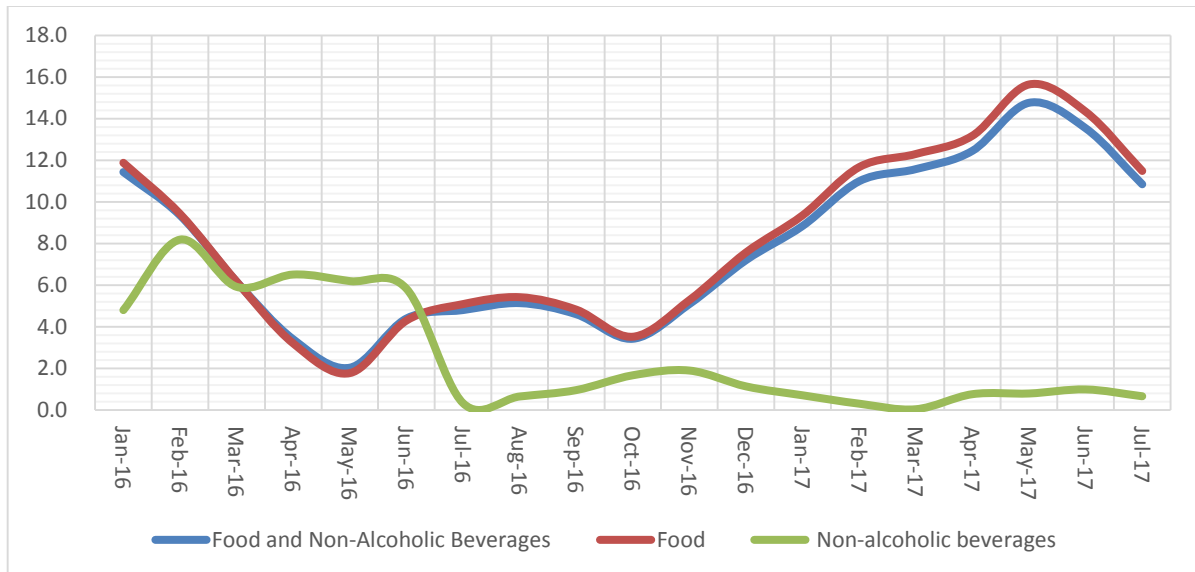
EXPLANATORY NOTES FOR THE INFLATION OF JULY 2017

SECTION 1: Annual Inflation by COICOP¹ Divisions

The evolution of Annual Inflation according to COICOP is described in the following paragraphs

01 Food and Non-Alcoholic Beverages

The Annual Inflation for Food and non-alcoholic beverages dropped to 10.8 percent for the year ending July 2017 compared to 13.5 percent recorded for the year ended June 2017. The drop was due to a decline in Annual Food Inflation to 11.5 percent for the year ending July 2017 compared to the 14.3 percent recorded during the year ended June 2017. The Annual Inflation for Non-Alcoholic Beverages registered a 0.7 percent for the year ending July 2017 compared to 1.0 percent recorded for the year ended June 2017. Graph 3 shows the trends of Food and Non Alcoholic Beverages Inflation from December 2014 to July 2017

02 Alcoholic Beverages, Tobacco & Narcotics

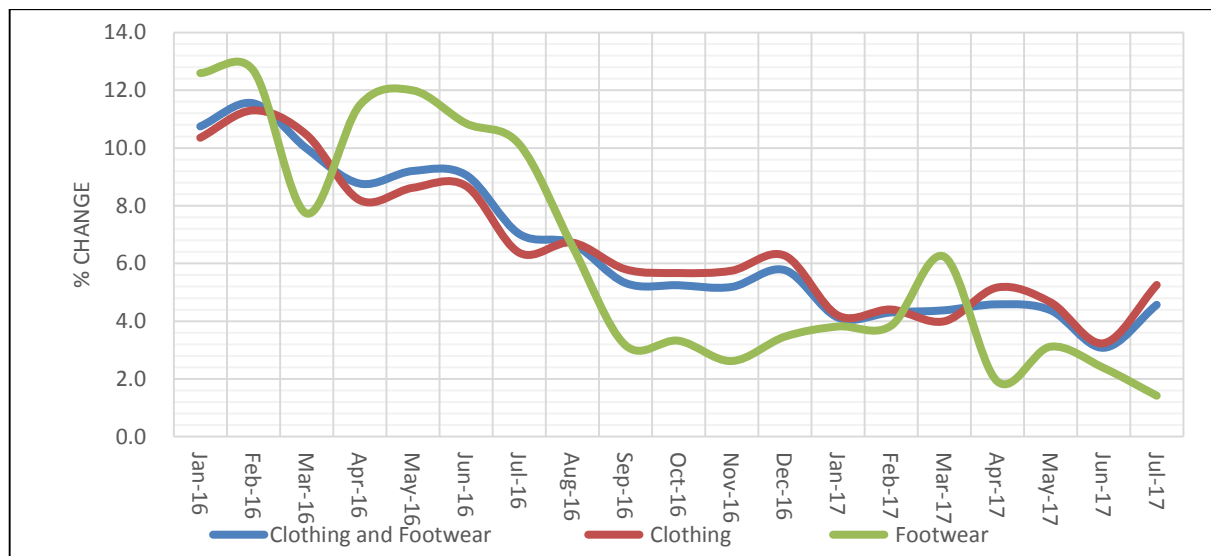
The Annual Inflation for Alcoholic Beverages, Tobacco & Narcotics increased by 0.5 percent for the year ending July 2017 compared to 0.5 percent recorded for the year ended June 2017. The increase was due to Annual Inflation of Alcoholic Beverages that increased to 0.4 percent for the year ending July 2017 compared to 0.3 percent recorded for the year ended June 2017. However, Tobacco Inflation decreased to 2.0 percent for the year ending July 2017 compared to the 2.3 percent recorded for the year ended June 2017.

03 Clothing and Footwear

The Annual Inflation for Clothing and Footwear increased to 4.6 percent for the year ending July 2017 compared to 3.1 percent recorded for the year ended June 2017. The increase was mainly attributed to Clothing Inflation that registered 5.3 percent for the year ending July 2017 compared to 3.2 percent for the year ended June 2017. However, Foot wear Inflation declined to 1.4 percent for the year ending July 2017 compared to 2.4 percent recorded during the year ended June 2017. Graph 4 shows the trends of clothing and Footwear from December 2014 to July 2017.

04 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and other Fuels comprises of Actual Rentals for Housing, Maintenance & repair of the dwelling, Water Supply, Electricity, Gas and Other Fuels

The Annual Inflation for Housing, water, electricity, Gas & other fuels increased to 5.0 percent for the year ending July 2017 compared to 3.6 percent recorded for the year ended June 2017. The increase was attributed to Inflation of Electricity, Gas and Other Fuels that recorded 6.7 percent for the year ending July 2017 compared to 4.0 percent recorded for the year ended June 2017. In addition, Annual Inflation for Water Supply and Miscellaneous Services relating to the dwelling increased to 9.9 percent for the year ending July 2017 compared to 6.4 percent recorded for the year ended June 2017. However, Annual Inflation for Maintenance and repair of the dwelling decreased to 2.4 percent for the year ending July 2017 compared to 3.1 percent recorded for the year ended June 2017.

05 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture & furnishings, Carpets & Other Floor Coverings, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools & Equipment for House, and Goods & Services for Routine Household Maintenance

The Annual Inflation for Furnishings, household equipment & routine household maintenance dropped to 5.1 percent for the year ending July 2017 compared to 5.5 percent recorded for the year ended June 2017. This drop was attributed to Annual inflation for Goods and Services for Routine Household Maintenance that decreased to 4.2 percent for the year ending July 2017 compared to 5.8 percent recorded for the year ended June 2017. In addition, Tools and Equipment for House and Garden inflation decreased to 13.6 percent for the year ending July 2017 compared to 15.2 percent recorded for year ended June 2017. However, Household Appliances inflation increased to 7.1 percent for the year ending July 2017 compared to 3.4 percent recorded for year ended June 2017.

06 Health

The health Division comprises of Medical Products, Appliances & Equipment, Outpatient Services, and Hospital Services.

The Annual Inflation for Health dropped to 1.2 percent for the year ending July 2017 compared to 1.4 percent registered for the year ended June 2017. The drop was due to Annual Inflation for Medical Products, Appliances and Equipment that dropped to 0.7 percent for the year ending July 2017 compared to 0.9 percent registered for the year ended June 2017. In addition, the Annual Inflation for Hospital Services dropped to 2.9 percent for the year ending July 2017 compared to 4.0 percent registered for the year ended June 2017. However, Outpatient Services inflation increased to 1.4 percent in July 2017 compared to 1.2 percent recorded for year ended June 2017.

07 Transport

Transport division comprises of Purchase of vehicles, Operation of Transport and Personal Equipment and Transport Services.

Annual Inflation for Transport declined to minus 0.3 per cent for the year ending July 2017 compared to 0.2 percent recorded for the year ended June 2017. The decline was due to Purchase of Vehicles inflation that dropped to minus 10.2 percent for the year ending July 2017 compared to minus 6.3 percent recorded for the year ended June 2017. Similarly, Operation of Personal Transport Equipment inflation decreased to 4.5 percent for the year ending July 2017 compared to 5.1 percent recorded for the year ended June 2017. However, Annual Inflation for Transport Services increased to 1.1 percent for the year ending July 2017 compared to minus 0.2 percent recorded for the year ended June 2017.

08 Communication

Communication includes Postal services, Telephones and Telefax equipment and Telephone and Telefax services.

The Annual Inflation for Communication registered a decrease minus 2.1 percent for the year ending July 2017 compared to 0.5 percent recorded for year ended June 2017. The main driver was Telephone and telefax equipment that registered a decrease of minus 0.4 percent for the year ending July 2017 compared to 2.4 percent recorded for the year ended June 2017. Postal Services inflation increased to 0.0 percent for the year ending July 2017 compared to minus 2.5 percent recorded for the year ended June 2017. Telephone and telefax services also decreased to minus 2.6 percent for the year ending July 2017 compared to 0.0 percent recorded in June 2016.

09 Recreation and Culture

Recreation and Culture comprises of Audio-visual, photographic & Information processing equipment, Recreational & Cultural services, Newspapers, books & Stationery and Package Holidays.

Annual inflation for Recreational and Culture increased to 8.2 percent for the year ending July 2017 compared to 8.0 percent recorded for the year ended June 2017. This drop was due to Recreational and Cultural Services Inflation that registered 25.2 percent for the year ending July 2017 compared to 22.6 percent recorded for the year ended June 2017. However, Audio-visual, photographic and information processing equipment inflation decreased to 0.5 percent for the year ending July 2017 compared to 1.0 percent recorded for the year ended June 2017. Also, Package holidays Inflation decreased to 6.5 percent for the year ending July 2017 compared to 9.0 percent recorded for the year ended June 2017.

10 Education

Education comprises of Pre-Primary and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education not definable by level. The Annual Inflation for Education remained at 7.2 percent for the year ending July 2017 the same rate recorded for the year ended June 2017. Pre-Primary and Primary Education Annual inflation registered 9.3 percent for the year ending July 2017 the same rate recorded for the year ended June 2017. Secondary Education, Tertiary Education and Education not defined by level recorded 7.8 percent, 0.2 percent and 0.1 percent respectively for the year ending July 2017, the same rates recorded for the year ended June 2017.

11. Restaurants and Hotels

Restaurants and Hotels comprises of catering services and accommodation services. Restaurants and Hotels. Annual inflation for Restaurants and Hotels increased to 6.9 percent for the year ending July 2017 compared to 5.8 percent registered for the year ended June 2017. The increase was due to inflation of Catering services that registered 7.7 percent for the year ending July 2017 compared to 6.1 percent for the year ended June 2017. However, Accommodation services declined to 5.0 percent for the year ending July 2017 compared to 5.2 percent for the year ended June 2017.

12. Miscellaneous Goods and Services

Miscellaneous goods and services comprises of Personal Care such as hairdressing salons and personal grooming establishments, Personal Effects such as Jewellery, clocks and watches, Insurance and Other services such as passport fees, photocopying and radio announcements.

The Miscellaneous goods and services Inflation for the year ending July 2017 decreased to 1.4 percent compared to 3.0 percent recorded for the year ended June 2017. The decrease was due to Inflation of Personal Effects n.e.c that recorded an inflation of minus 2.8 percent for the year ending July 2017 compared to minus 0.5 percent recorded for the year ended June 2017. In addition, the Annual Inflation for Personal care decreased to 2.1 percent for the year ending July 2017 compared to 3.2 percent recorded for the year ended June 2017.

SECTION 2: Monthly Inflation by COICOP Divisions

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs

01 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic beverages dropped by 1.5 percent for the month of July 2017 from the 2.0 percent decrease recorded for June 2017. The drop was due to Food inflation that recorded minus 1.6 percent in July 2017 from the 2.1 percent drop recorded in June 2017. However, Non-alcoholic Beverages increased by 0.1 percent for the month of July 2017 from the minus 0.1 percent recorded in June 2017.

02 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages & Tobacco registered a 0.0 percent during the month of July 2017 the same rate recorded in June 2017. The stability was due to Monthly Inflation of Alcoholic Beverages that registered 0.0 percent in July 2017 from the 0.1 percent rise recorded for the month of June 2017. However, Tobacco inflation registered an increase of 0.4 percent in July 2017 from 0.3 drop recorded in June 2017.

03 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear increase by 0.8 percent for the month of July 2017 from the drop of 0.5 percent recorded in June 2017. This was mainly attributed to increase in Clothing inflation that registered 1.1 percent during the month of July 2017 from the 0.7 percent drop recorded in June 2017. Monthly Inflation for Foot wear decline by 0.7 percent for the month of July 2017 from the 0.2 percent rise recorded in June 2017.

04 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, water, electricity, Gas & other fuels, registered an increase of 0.8 percent in July 2017 from the 0.0 percent recorded in June 2017. It attributed to Water Supply & Miscellaneous Services relating to the dwelling inflation registered 4.4 percent increase in July 2017 from the minus 0.2 percent recorded in June 2017. In addition, Actual Rentals for Housing inflation that recorded 0.2 percent during the month of July from a stable inflation registered in June 2017. Electricity, Gas & other Fuels inflation also recorded 0.5 percent rise in July 2017 from an increase of 0.1 percent recorded in June 2017. Monthly inflation for Maintenance and repair of the dwelling decreased by 1.0 percent in July 2017 from the 0.2 percent decline recorded in June 2017.

05 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, household equipment & routine household maintenance decreased by 0.1 percent during the month of July 2017 from the 0.3 percent drop recorded for the month of June 2017. The decrease was due to Goods & Services for Routine Maintenance inflation of minus 1.1 percent from 0.7 percent rise recorded in June 2017. In addition, Furniture and furnishings, Carpets and Other Floor Coverings Inflation registered a decrease of 0.5 percent in July 2017 from 0.0 percent inflation recorded for the month of June 2017. Tools & Equipment for House & Garden Monthly Inflation also decreased by 0.1 percent in July 2017 from the 1.0 percent drop for the month of June 2017. Household Appliances registered 2.6 percent rise in July 2017 from the minus 1.7 percent recorded in June 2017. Household Textiles inflation that registered 0.5 percent rise during the month of July 2017 from the decline of 1.4 percent recorded for the month of June 2017.

06 Health

The Monthly Inflation for Health increased by 0.1 percent during the month of July 2017 from the 0.2 percent drop recorded for the month of June 2017. The increase was due to Monthly Inflation for Medical Products, Appliances and Equipment that recorded 0.2 percent rise in July 2017 from the minus 0.2 percent recorded for the month of June 2017. However, Outpatient Services inflation remained stable during the month of July 2017.

07 Transport

Transport division registered a monthly inflation of minus 0.7 percent for the month of July 2017 from the minus 0.5 percent recorded during the month of June 2017. The driver for the decrease was the Monthly Inflation for Purchase of Vehicles that registered minus 3.1 percent during the month of July 2017 from the minus 3.6 percent recorded for the month of June 2017. In addition, Operation of Personal Transport Equipment monthly inflation declined by 0.2 percent in July 2017 from the 0.3 percent rise recorded during the month of June 2017. However, Monthly inflation for Transport Services registered a 0.0 percent during the month of July 2017 from an increase of 0.3 percent during the month of June 2017.

08 Communication

The Monthly Inflation for Communication decreased to 2.3 percent during the month of July 2017 from the 0.3 percent rise recorded for the month of June 2017. The main driver for the decrease was Telephone and telefax services inflation that recorded 2.6 percent decline during the month of July 2017 from a stable inflation registered in June 2017. In addition, Telephone and Telefax Equipment inflation that registered 1.6 percent decline during the month of July 2017 from an increase of 1.4 percent recorded for the month of June 2017.

09 Recreation and Culture

Monthly inflation for Recreational and Culture increased by 0.3 percent during the month of July 2017 from the 0.1 percent drop recorded for the month of June 2017. The increase is attributed to monthly inflation of Recreational and Cultural Services that registered 0.8 percent rise in July 2017 from the 0.0 recorded in June 2017. In addition, Newspapers, books and stationery inflation rose by 0.3 percent for in July 2017 from the minus 0.2 percent in June 2017. However, Package holidays inflation dropped by 0.9 percent during the month of July 2017 from the 0.1 percent rise recorded in June 2017.

10 Education

Monthly inflation for Education recorded 0.0 percent during the month of July 2017 from an increase of 1.2 percent for the month ended June 2017. The instability was attributed to Secondary Education that registered a stable inflation in July 2017 from the 1.3 percent rise recorded in June 2017. Also, Pre-Primary and Primary Education inflation registered a stable inflation in July 2017 from the increase of 1.6 percent recorded in June 2017.

11 Restaurants and Hotels

The Monthly Inflation for Restaurants and Hotels increased by 0.8 percent during the month of July 2017 from the 0.4 percent rise registered for the month June 2017. The increase was due to Catering Services that increased by 1.1 percent during the month of July 2017 from the 0.1 percent rise recorded for the month of June

2017. However, Accommodation Services inflation registered 0.0 percent during the month of July 2017 from the 1.1 percent rise recorded for the month of June 2017.

12 Miscellaneous Goods and Services

Miscellaneous goods and services Inflation for the month of July 2017 decline by 0.8 percent from the 0.1 percent recorded for the month of June 2017. The drop was mainly attributed to Monthly Inflation for Personal care inflation that recorded 1.0 percent drop during the month of July 2017 from the 0.2 percent rise recorded for the month of June 2017. In addition, Personal Effects n.e.c registered a minus 0.8 percent during the month of July 2017 from 0.0 percent recorded in June 2017.
