FOREWORD

This publication provides the monthly Consumer Price Indices for Uganda (Composite) and for the ten centres of Kampala High Income, Kampala Middle Income, Kampala Low Income, Jinja, Mbale, Masaka, Mbarara, Fortportal, Gulu and Arua. All the baskets are for the urban households.

The current Consumer Price Index has been rebased from 2009/2010 to 2016/2017, using weights derived from the Uganda National Household Survey (UNHS VI) that was conducted from July 2016 to June 2017. The rebased CPI is classified using international standards, referred to as Classification of Individual Consumption According to Purpose (COICOP 2018). This is a shift from the COICOP 1999 that was used in the earlier series. COICOP 2018 is more detailed than the previous (1999) version, responding to the users' need for more detail, and addresses several other issues that required revision of the classification. The new COICOP of 2018 reflects the significant changes in goods and services in some areas, improved links of COICOP to other classifications, and addresses emerging statistical and policy needs of regional and international users.

At the elementary aggregate (EA) level, the indices are computed using the Jevons (Geometric Mean) method for all items within the elementary aggregates. The modified Laspeyres index formula is used to compute higher level indices. The National CPI is computed as a weighted average of the ten centres mentioned above and rebased indices are available from July 2017 to date at EA level.

ACRONYMS AND DEFINITIONS

COICOP: Classification of Individual Consumption According to Purpose, is a nomenclature developed by the United Nations Statistics Division to classify and analyse individual consumption expenditures incurred by households, non-profit institutions serving households and general government according to their purpose.

CPI: Consumer Price Index - a general indicator of price levels paid by households for consumer goods and services.

CPI basket: A commonly used term for the goods and services priced for the purpose of compiling the CPI.

Elementary aggregate (EA): The lowest level of commodity classification in the CPI, and the only level for which index numbers are constructed by direct reference to price data.

Inflation: A term commonly used to refer to changes in price levels. A rise in prices is called inflation, and a persistent fall is called deflation.

Jevons price index: An elementary price index defined as the un-weighted geometric average of the sample price relatives. It can also be defined as the un-weighted geometric average of the current to base period price relatives.

Laspeyres price index: The Laspeyres price index is an index formula used in price statistics for measuring the price development of the basket of goods and services consumed in the base period. The question it answers is how much a basket that consumers bought in the base period would cost in the current period.

Outlet: The interface between a supplier of products and the consumer. It may be a shop, a market stall, a catalogue, a website etc. Also referred to as a "retail outlet", although it can include wholesale outlets which also sell directly to the consumers

Outlier: A term used to describe any extreme value in a set of data, such as a price or price relative that requires further investigation or has been verified as incorrect

Price relative: A measure of price movements: the ratio of the price level in one period to the price level in another.

Reference base: The period in which the CPI is given a value of 100.0. The CPI is currently on a reference base of 2016/17.

Weight: The measure of the importance of an item in the index regimen relative to the other items. Weights can be expressed in either quantity or value terms. Value weights are used in the CPI.

1.0 HIGHLIGHTS OF UGANDA CPI FOR SEPTEMBER 2025

1.1 Annual Headline Inflation

The Annual Inflation as measured by the Consumer Price Index for Uganda for the 12 months to September 2025 is 4.0 percent compared to 3.8 percent registered in the year ended August 2025, see Table 1 and Figure 1 below.

Annual Food Crops and Related Items Inflation increased to 7.4 percent in the year ending September 2025 compared to 3.0 percent registered in the year ended August 2025. This is attributed to Matooke (whose rate of price change is 14.8 percent compared to 32.5 percent recorded in the year ended August 2025), Tomatoes (whose rate of price change is 30.4 percent compared to minus 6.4 percent recorded in the year ended August 2025), Fresh Leafy Vegetables (whose rate of price change is 2.7 percent compared to minus 9.3 percent recorded in the year ended August 2025), Onions (whose rate of price change is 1.8 percent compared to minus 31.3 percent recorded in the year ended August 2025), Green Cabbage (whose rate of price change is minus 2.5 percent compared to minus 19.2 percent recorded in the year ended August 2025), Pineapples (whose rate of price change is 44.6 percent compared to 9.4 percent recorded in the year ended August 2025) and Mangoes (whose rate of price change is 9.6 percent compared to minus 6.1 percent recorded in the year ended August 2025).

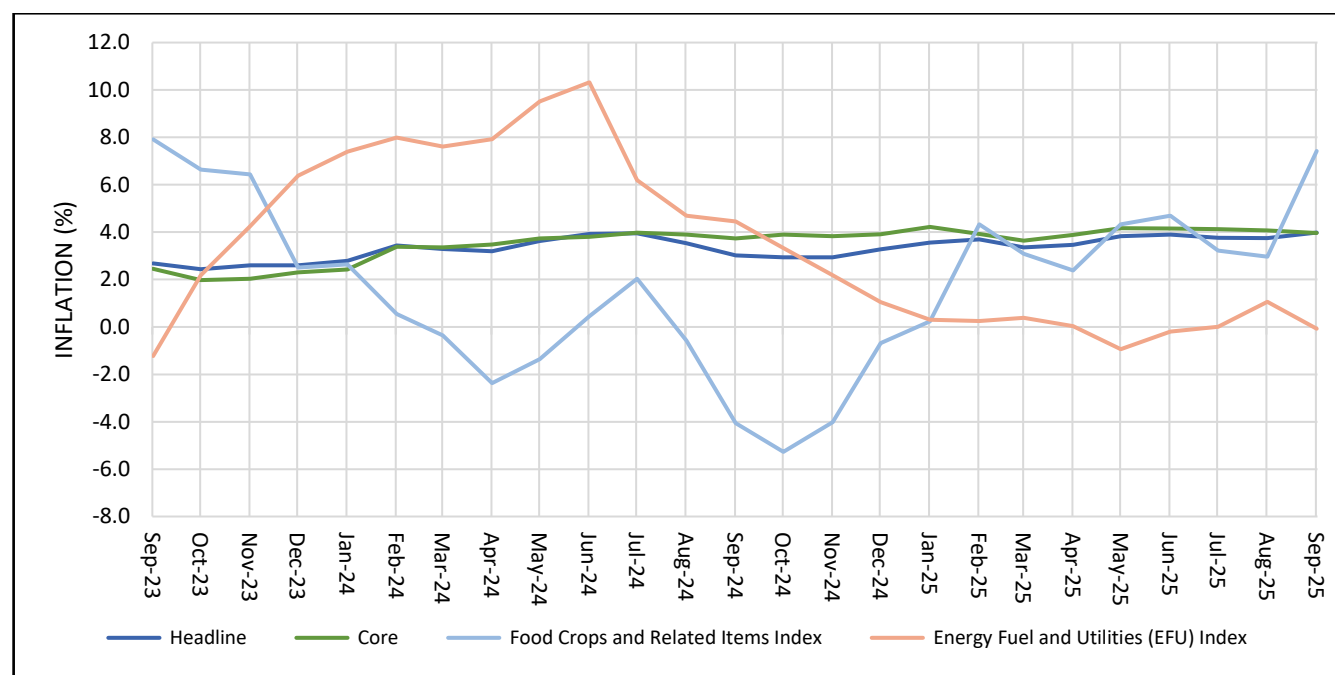
Annual Core Inflation registered 4.0 percent in the year ending September 2025 compared to 4.1 percent recorded in the year ended August 2025. Annual Core Goods Inflation registered 3.0 percent in the year ending September 2025 compared to 3.2 percent recorded in the year ended August 2025. This is attributed to items such as Dried fish (whose rate of price change is minus 7.3 percent compared to minus 5.7 percent recorded in the year ended August 2025) and Cooking Oil (whose rate of price change is 4.5 percent compared to 5.9 percent recorded in the year ended August 2025). Additionally, Annual Services Inflation recorded 5.1 percent in September 2025, same rate registered in August 2025. This was mainly due to Annual Transport Services Inflation (recorded at 3.3 percent in the year ending September 2025 compared to 3.0 percent recorded in the year ended August 2025) and Outpatient Care Services Inflation (recorded at 9.3 percent compared to 8.8 percent registered in the year ended August 2025).

Annual Energy Fuel and Utilities (EFU) Inflation was recorded at minus 0.1 percent in the year ending September 2025 compared to 1.1 percent registered in the year ended August 2025. This is mainly due to a decrease in the rate of price change of Charcoal to 5.5 percent in September 2025 compared to 8.3 percent recorded in the year ended August 2025, Firewood Prices (whose rate of price change is minus 1.2 percent compared to 2.7 percent recorded in the year ended August 2025).

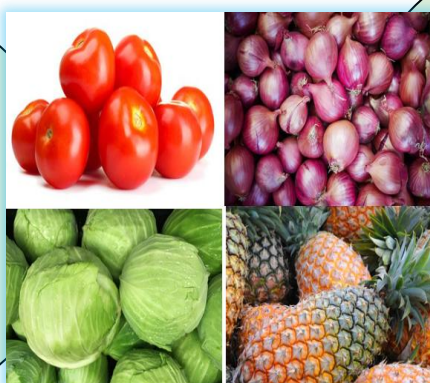

1.2 Annual Inflation by COICOP Divisions

According to the Classification of Individual Consumption According to Purpose (COICOP), the main drivers to the 4.0 percent Inflation were 'Food and Non-Alcoholic Beverages' Inflation that registered 5.2 percent in the year ending September 2025 compared to 3.7 percent registered in the year ended August 2025. 'Transport' Inflation increased to 3.3 percent in the year ending September 2025 compared to 3.0 percent recorded in the year ended August 2025. 'Alcoholic Beverages, Tobacco and Narcotics' Inflation registered 1.4 percent for the year ending September 2025 compared to 1.2 percent registered for the year ended August 2025.

However, 'Housing, Water, Electricity, Gas and Other Fuels' Inflation decreased to 2.3 percent in the year ending September 2025 compared to 3.0 percent registered in the year ended August 2025. 'Clothing and Footwear' Inflation registered 2.2 percent in the year ending September 2025 compared to 2.7 percent recorded in the year ended August 2025. 'Health' Inflation decreased to 4.2 percent for the year ending September 2025 compared to 4.9 percent registered for the year ended August 2025. 'Personal Care, Social Protection and Miscellaneous Goods' Inflation decreased to 1.6 percent for the year ending September 2025 compared to 2.1 percent registered for the year ended August 2025. 'Furnishings, Household Equipment and Routine Household' Inflation decreased to 1.9 percent in the year ending September 2025 compared to 2.1 percent registered in the year ended August 2025. 'Recreation, Sport and Culture' Inflation decreased to 1.4 percent in the year ending September 2025 compared to 1.5 percent registered in the year ended August 2025. 'Restaurants and Accommodation Services' Inflation recorded 5.6 percent in the year ending September 2025, same rate registered in the year ended August 2025. 'Information and Communication' Inflation registered 2.6 percent in the year ending September 2025, same rate recorded in the year ended August 2025. 'Insurance and Financial Services' Inflation registered 16.4 percent in the year ending September 2025, same rate recorded in the year ended August 2025. 'Education Services' Inflation registered 6.3 percent in the year ending September 2025, same rate recorded in the year ended August 2025, see Table 3 below.

1.3 Monthly Inflation.

The Monthly Headline Inflation for September 2025 increased by 0.5 percent from the 0.2 percent rise registered in August 2025, Table 4 below.

This was mainly due to the increase in the monthly Food Crops and Related Items Inflation by 4.5 percent in September 2025 from the 0.7 percent rise recorded in August 2025. This was attributed to increase in prices of matoke by 17.2 percent in September 2025 from the 0.9 percent drop recorded in August 2025, tomatoes by 20.8 percent in September 2025 from the 4.3 percent drop recorded in August 2025, mangoes by 33.8 percent in September 2025 from the 9.6 percent rise recorded in August 2025, onions by 17.4 percent in September 2025 from the 5.5 percent drop recorded in August 2025 and green pineapples by 34.0 percent in September 2025 from the 4.3 percent drop recorded in August 2025.

Monthly Core Inflation increased by 0.1 percent in September 2025, the same rate registered in August 2025. The main driver was the monthly Services Inflation that increased by 0.1 percent in September 2025 from the 0.4 percent rise recorded in August 2025. However, monthly Other Goods Inflation registered 0.0 percent in September 2025 from the 0.2 percent drop recorded in August 2025.

Monthly Energy Fuel and Utilities (EFU) Inflation increased by 0.3 percent in September 2025 from the 0.7 percent rise registered in August 2025. This was mainly due to monthly charcoal prices that increased by 2.9 percent in September 2025 from the 3.2 percent rise recorded in August 2025. In addition, diesel prices increased by 0.1 percent in September 2025 from the 0.0 percent recorded in August 2025.

1.4 Monthly Inflation by COICOP Divisions

According to the Classification of Individual Consumption According to Purpose (COICOP), monthly Food and Non-Alcoholic Beverages Inflation increased by 1.5 percent in September 2025 from the 0.0 percent recorded in August 2025. Monthly Transport Inflation increased by 0.2 percent in September 2025 from the 0.1 percent drop recorded in August 2025. Monthly Housing, Water, Electricity, Gas and Other Fuels Inflation increased by 0.2 percent in September 2025 from the 0.4 percent rise recorded in August 2025. Monthly Restaurants and Accommodation Services Inflation increased by 0.1 percent in September 2025 from the 0.6 percent rise recorded in August 2025. Monthly Alcoholic Beverages, Tobacco and Narcotics Inflation increased by 0.3 percent in September 2025 from the 0.5 percent drop recorded in August 2025. Monthly Information and Communication Inflation increased by 0.1 percent in September 2025 from the 0.8 percent rise recorded in August 2025. Monthly Recreation, Sport and Culture Inflation registered 0.0 percent in September 2025 from the 0.4 percent rise recorded in August 2025. Monthly Health Inflation recorded 0.0 percent in September 2025 from the 0.2 percent rise recorded in August 2025. Monthly Education Services Inflation recorded 0.0 percent in September 2025 same rate recorded in August 2025. Monthly Insurance and Financial Services Inflation recorded 0.0 percent in September 2025 same rate recorded in August 2025.

However, Monthly Clothing and Footwear Inflation decreased by 0.1 percent in September 2025 from the 0.2 percent rise recorded in August 2025. Monthly Personal Care, Social Protection and Miscellaneous Goods Inflation decreased by 0.1 percent in September 2025 from the 0.7 percent rise recorded in August 2025. Monthly Furnishings, Household Equipment and Routine Household Inflation decreased by 0.1 percent in September 2025 from the 0.2 percent rise recorded in August 2025.

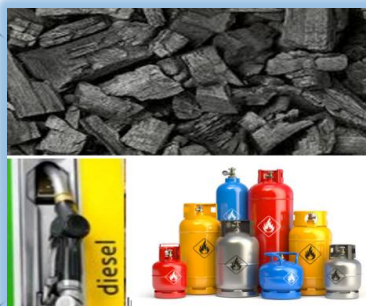

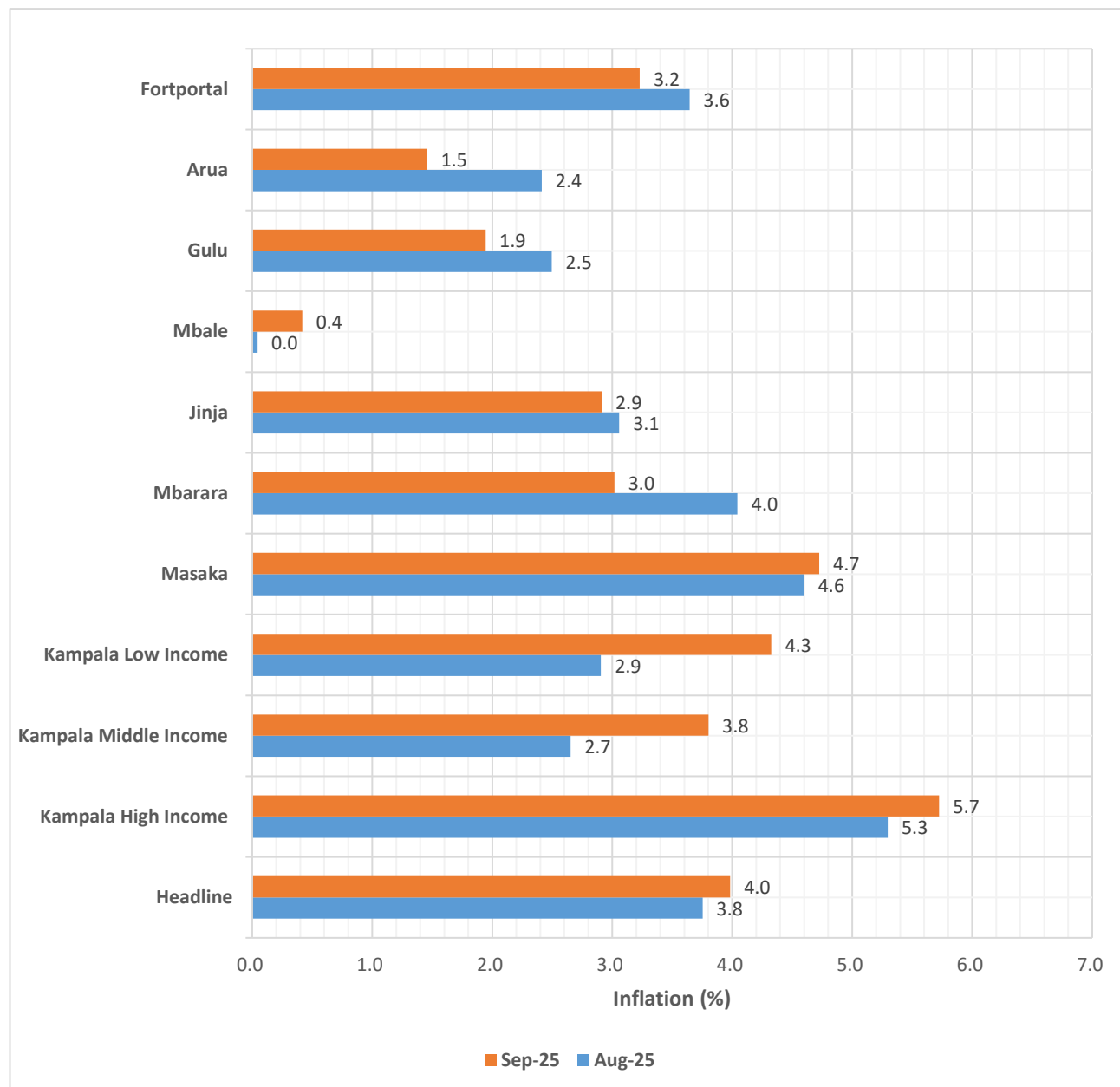
1.5 Annual Headline Inflation by CPI Geographical Center

Analysis by geographical areas and income groups revealed that Kampala High Income group registered the highest Inflation at 5.7 percent for the year ending September 2025 compared to 5.3 percent recorded in August 2025. This was mainly driven by annual 'Food and Non-Alcoholic Beverages' Inflation that increased to 9.1 percent in September 2025 compared to 7.0 percent registered in August 2025. In addition, Annual 'Transport' Inflation increased to 6.0 percent in September 2025 compared to 5.4 percent registered in August 2025.

The second highest Annual Inflation was registered in Masaka at 4.7 percent for the year ending September 2025 compared to 4.6 percent recorded in August 2025. This was mainly driven by annual 'Food and Non-Alcoholic Beverages' Inflation that increased to 6.9 percent in September 2025 compared to 4.2 percent registered in August 2025. In addition, Annual 'Restaurants and Accommodation Services' Inflation increased to 6.7 percent in September 2025 compared to 5.1 percent registered in August 2025.

The least Annual Inflation was registered in Mbale Centre at 0.4 percent for the year ending September 2025 compared to 0.0 percent recorded in August 2025. This was mainly due to the annual 'Housing, Water, Electricity, Gas and Other Fuels' Inflation that registered 2.0 percent in September 2025 compared to 4.6 percent registered in August 2025. In addition, Annual 'Furnishings, Household Equipment and Routine Household' Inflation registered minus 6.0 percent in September 2025 compared to minus 4.7 percent registered in August 2025.

The evolution of Annual Inflation according to COICOP is described in the following paragraphs, reference is made to table 6.

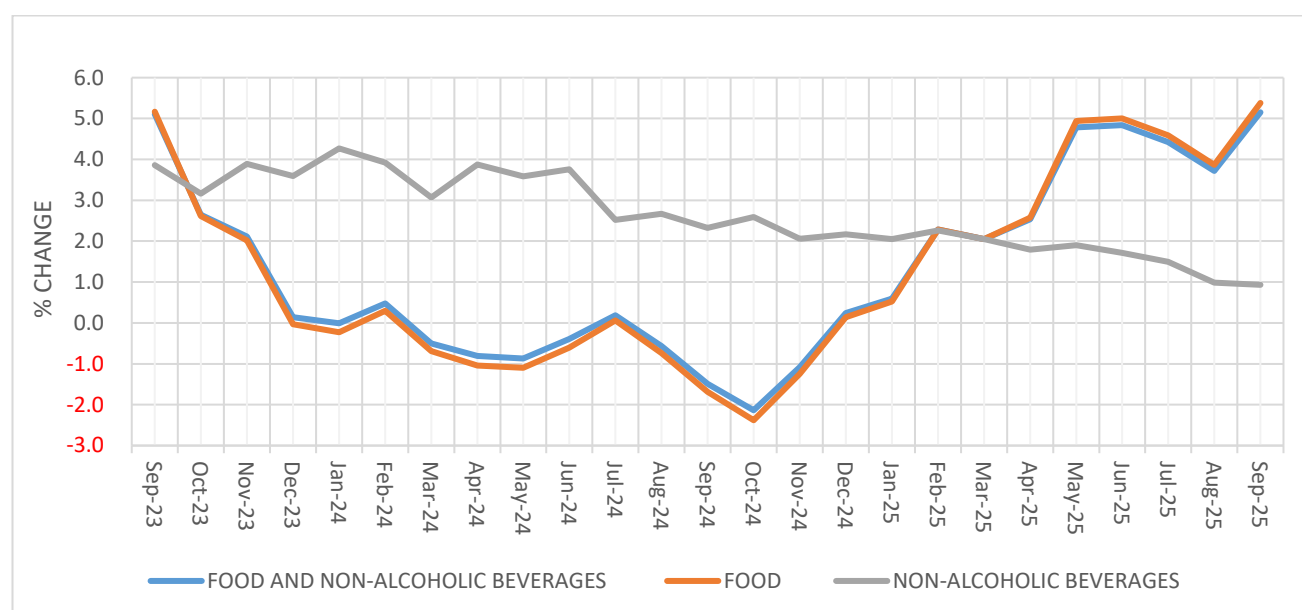
01 Food and Non-Alcoholic Beverages

The Inflation for Food and Non-Alcoholic Beverages increased to 5.2 percent for the 12 months to September 2025 compared to 3.7 percent registered in August 2025. This was mainly due to Annual Food Inflation that increased to 5.4 percent in September 2025 compared to 3.9 percent recorded in August 2025.

However, Non-Alcoholic Beverages Inflation for the 12 months to September 2025 slowed down to 0.9 percent compared to 1.0 percent recorded in August 2025.

02 Alcoholic Beverages, Tobacco & Narcotics

Alcoholic Beverages, Tobacco & Narcotics Inflation increased to 1.4 percent for the 12 months to September 2025 compared to 1.2 percent recorded in August 2025. This was attributed to the Annual Tobacco Inflation that increased to 2.4 percent in September 2025 compared to minus 1.0 percent registered in August 2025.

However, Annual Alcoholic Beverages Inflation slowed down to 1.3 percent for the 12 months to September 2025 compared to 1.5 percent recorded in August 2025.

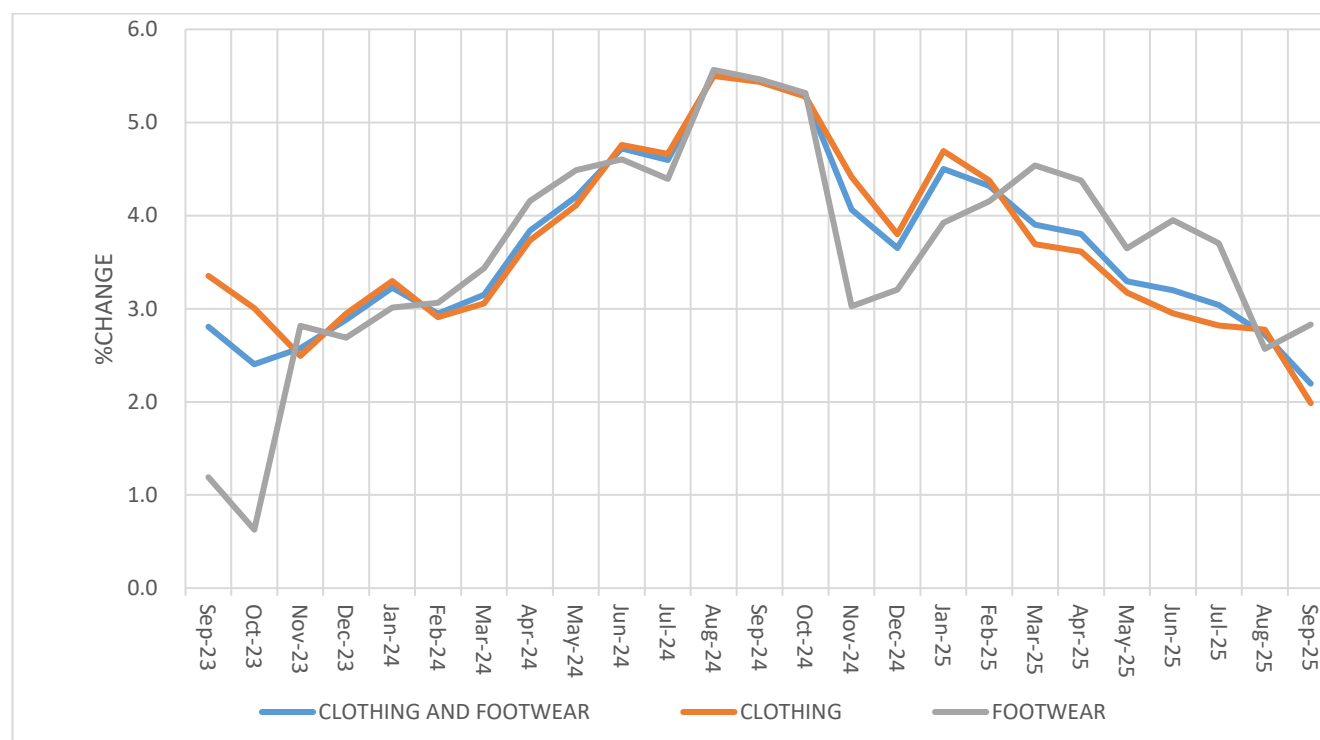
03 Clothing and Footwear

The Annual Clothing and Footwear Inflation slowed down to 2.2 percent for the 12 months to September 2025 compared to 2.7 percent recorded in August 2025. This was mainly attributed to Clothing Inflation that registered 2.0 percent for the 12 months to September 2025 compared to 2.8 percent recorded in August 2025.

However, Footwear Inflation increased to 2.8 percent in September 2025 compared to 2.6 percent recorded in August 2025.

Figure 5 shows the trends of Clothing and Footwear Inflation from September 2023 to September 2025.

04 Housing, Water, Electricity, Gas and other Fuels

Housing, Water, Electricity, Gas and Other Fuels comprises of Actual Rentals for Housing, Maintenance, Repair and Security of the Dwelling, Water Supply and Miscellaneous Services Relating to the Dwelling, Electricity, Gas and Other Fuels.

Housing, Water, Electricity, Gas & Other Fuels Inflation slowed down to 2.3 percent for the 12 months to September 2025 compared to 3.0 percent recorded in August 2025. This was mainly attributed to Annual Electricity, Gas and Other Fuels Inflation that slowed down to 0.3 percent for the 12 months to September 2025 compared to 1.9 percent recorded in August 2025. In addition, Water Supply and Miscellaneous Services Relating to the Dwelling inflation slowed down to 9.8 percent in September 2025 compared to 11.3 percent recorded in August 2025. Annual Actual Rentals for Housing Inflation registered 1.6 percent in September 2025 same as that recorded in August 2025.

However, Annual Maintenance, Repair and Security of the Dwelling Inflation registered minus 1.8 percent for the 12 months to September 2025 compared to minus 2.8 percent recorded in August 2025.

05 Furnishings, Household Equipment and Routine Household Maintenance

This Division Comprises of Furniture, Furnishings, and Loose Carpets, Household Textiles, Household Appliances, Glassware, Tableware and Household Utensils, Tools and Equipment for House & Garden, and Goods & Services for Routine Household Maintenance.

The Inflation for Furnishings, Household Equipment & Routine Household Maintenance slowed down to 1.9 percent for the 12 months to September 2025 compared to 2.1 percent recorded in August 2025. This was mainly due to Annual Goods & Services for Routine Household Maintenance Inflation that slowed down to 0.9 percent for the 12 months to September 2025 compared to 1.3 percent registered in August 2025. In addition, Annual Furniture, Furnishings, and Loose Carpets Inflation slowed down to 5.2 percent for the 12 months to September 2025 compared to 5.5 percent recorded in August 2025. Annual Tools and Equipment for House & Garden Inflation registered minus 1.2 percent for the 12 months to September 2025 compared to minus 0.8 percent recorded in August 2025. Annual Household textiles Inflation registered 0.1 percent for the 12 months to September 2025 same as that recorded in August 2025. Annual Glassware, Tableware and Household Utensils Inflation registered 6.5 percent for the 12 months to September 2025 same as that recorded in August 2025.

However, Annual Household appliances inflation rose to 1.9 percent for the 12 months to September 2025 compared to 1.8 percent recorded in August 2025.

06 Health

The Health Division comprises of Medicines and Health Products, Outpatient Care Services, Inpatient Care Services and Other Health Services.

The Inflation for Health slowed down to 4.2 percent for the 12 months to September 2025 compared to 4.9 percent registered in August 2025. This was mainly due to Annual Inpatient Care Services Inflation that slowed down to 0.6 percent for the 12 months to September 2025 from the 3.0 percent recorded in August 2025. In addition, Annual Medicine and Health Products Inflation slowed down to 3.8 percent for the 12 months to September 2025 compared to 4.3 percent recorded in August 2025. Annual Other Health Services Inflation slowed down to 5.4 percent for the 12 months to September 2025 from the 5.5 percent recorded in August 2025.

However, Annual Outpatient Care Services Inflation increased to 9.3 percent for the 12 months to September 2025 from the 8.8 percent recorded in August 2025.

07 Transport

Transport division comprises of Purchase of vehicles, Operation of Personal Transport Equipment and Passenger Transport Services.

The Inflation for Transport increased to 3.3 percent for the 12 months to September 2025 compared to 3.0 percent recorded in August 2025. This was mainly attributed to Annual Passenger Transport Services Inflation that decreased to minus 1.9 percent in September 2025 compared to minus 2.5 percent recorded in August 2025. In addition, Annual Purchase of vehicles Inflation registered 5.6 percent in September 2025 same as that recorded in August 2025.

However, Annual Operation of Personal Transport Equipment inflation slowed down to 7.9 percent for the 12 months to September 2025 from the 8.0 percent registered in August 2025.

08 Information and Communication

Information and Communication includes Information and Communication Equipment, and Information and Communication Services.

The Annual Inflation for Information and Communication registered 2.6 percent for the 12 months to September 2025 same as that recorded in August 2025. This was mainly due to Annual Information and Communication Equipment Inflation that registered 3.7 percent in September 2025 compared to 4.1 percent recorded in August 2025.

However, Annual Information and Communication Services Inflation registered 2.1 percent for the 12 months to September 2025 compared to 1.9 percent recorded in August 2025.

09 Recreation, Sport and Culture

Recreation, Sport and Culture comprises of Other Recreational Goods, Gardens and Pets, Recreational Services, Cultural Services, Newspapers, Books & Stationery and Package Holidays.

The Annual Inflation for Recreation, Sport and Culture slowed down to 1.4 percent for the 12 months to September 2025 compared to 1.5 percent recorded in August 2025. This was mainly due to Annual Cultural Services Inflation that slowed down to 0.2 percent for the 12 months to September 2025 compared to 0.3 percent recorded in August 2025.

Annual Package Holidays inflation registered 1.3 percent for the 12 months to September 2025 same as that recorded in August 2025. Annual Recreational Services Inflation registered 5.7 percent for the 12 months to September 2025 same as that recorded in August 2025. Annual Other Recreational Goods Inflation registered 10.1 percent for the 12 months to September 2025 same as that recorded in August 2025. Annual Gardens and Pets inflation registered 12.3 percent for the 12 months to September 2025 same as that recorded in August 2025.

However, Annual Newspapers, Books & Stationery Inflation increased to 0.6 percent in September 2025 same as that recorded in August 2025.

10 Education Services

Education Services comprises of Early Childhood and Primary Education, Secondary Education, Post-secondary non-tertiary education, Tertiary Education and Education Not Defined by level.

The Annual Inflation for Education Services registered 6.3 percent for the 12 months to September 2025 same rate recorded in August 2025. Annual Early Childhood and Primary Education inflation registered 6.9 percent for the 12 months to September 2025 same rate recorded in August 2025. Annual Secondary Education Inflation registered 7.8 percent for the 12 months to September 2025 same rate recorded in August 2025. Annual Post-Secondary Non-Tertiary Education inflation registered 9.3 percent for the 12 months to September 2025 same rate recorded in August 2025. Annual Education Not Defined by level registered 0.0 percent for the 12 months to September 2025 same as that recorded in August 2025.

11 Restaurants and Accommodation Services

Restaurants and Accommodation Services comprises of Food and Beverage Serving Services and Accommodation Services.

Annual Inflation for Restaurants and Accommodation Services registered 5.6 percent for the 12 months to September 2025 same as that recorded in August 2025.

This was mainly due to Annual Food and Beverage Serving Services Inflation that slowed down to 6.2 percent for the 12 months to September 2025 compared to 6.6 percent recorded in August 2025.

However, Annual Accommodation Services Inflation increased to 4.2 percent in September 2025 compared to 3.4 percent recorded in August 2025.

12 Insurance and Financial Services

Insurance and Financial Services comprises of Insurance and Financial Services.

The Annual Insurance and Financial Services Inflation for the 12 months to September 2025 registered 16.4 percent same as that recorded in August 2025. This was mainly due to Annual Insurance Services Inflation that increased to 1.1 percent for the 12 months to September 2025 compared to 1.0 percent recorded in August 2025

In addition, Annual Financial Services Inflation registered 17.8 percent for the 12 months to September 2025 same as that recorded in August 2025.

13 Personal Care, Social Protection and Miscellaneous Goods

Personal Care, Social Protection and Miscellaneous Goods comprises of Personal Care, Personal Effects n.e.c, Social Protection and Other services n.e.c

The Annual Personal Care, Social Protection and Miscellaneous Goods Inflation for the 12 months to September 2025 slowed down to 1.6 percent for the 12 months to September 2025 compared to 2.1 percent recorded in August 2025. This was mainly due to Annual Personal Effects NEC Inflation that registered 4.8 percent for the 12 months to September 2025 compared to 6.7 percent recorded in August 2025. In addition, Annual Other Services n.e.c Inflation slowed down to 2.6 percent for the 12 months to September 2025 compared to 4.2 percent recorded in August 2025.

Annual Personal Care Inflation registered 0.3 percent for the 12 months to September 2025 same as that recorded in August 2025. Annual Social Protection Inflation registered 4.5 percent for the 12 months to September 2025 same as that recorded in August 2025.

ANNEX 2: MONTHLY INFLATION BY COICOP DIVISIONS

The evolution of Monthly Inflation according to COICOP is described in the following paragraphs, reference is made to table 4.

01 Food and Non-Alcoholic Beverages

The Monthly Inflation for Food and Non-alcoholic Beverages increased by 1.5 percent for the month of September 2025 from the 0.0 percent recorded in August 2025. This was mainly due to monthly Food Inflation that increased by 1.6 percent for the month of September 2025 from the 0.0 percent recorded in August 2025.

In addition, Non-Alcoholic Beverages Inflation increased by 0.2 percent for the month of September 2025 from the 0.1 percent drop recorded in August 2025.

02 Alcoholic Beverages, Tobacco & Narcotics

The Monthly Inflation for Alcoholic Beverages, Tobacco & Narcotics registered a rise of 0.3 percent for the month of September 2025 from the 0.5 percent drop recorded in August 2025. This was mainly due to Alcoholic beverages Inflation that increased by 0.3 percent for the month of September 2025 from the 0.7 percent drop recorded in August 2025.

However, Tobacco Inflation increased by 0.9 percent for the month of September 2025 from the 0.5 percent rise recorded in August 2025.

03 Clothing and Footwear

The Monthly Inflation for Clothing and Footwear registered 0.1 percent drop for the month of September 2025 compared to 0.2 percent rise recorded in August 2025.

This was mainly due to clothing Inflation that registered 0.3 percent drop for the month of September 2025 from 0.2 percent rise recorded in August 2025.

However, Footwear inflation registered 0.3 percent rise for the month of September 2025 from the 0.1 percent rise recorded in August 2025.

04 Housing, Water, Electricity, Gas and other Fuels

The Monthly Inflation for Housing, Water, Electricity, Gas & Other fuels increased by 0.2 percent for the month of September 2025 from the 0.4 percent rise recorded in August 2025. This was mainly attributed to Electricity, Gas and Other Fuels Inflation that increased by 0.6 percent for the month of September 2025 from the 1.2 percent increase recorded in August 2025.

Water Supply and Miscellaneous Services Inflation registered 0.0 percent for the month of September 2025 from the 0.3 percent rise recorded in August 2025.

However, Maintenance, Repair and Security of the Dwelling Inflation registered 0.1 percent drop for the month of September 2025 from the 0.6 percent decrease recorded in August 2025. Actual Rentals for Housing Inflation registered 0.0 percent for the month of September 2025 same as that recorded in August 2025.

05 Furnishings, Household Equipment and Routine Household Maintenance

The Monthly Inflation for Furnishings, Household Equipment & Routine Household Maintenance registered 0.1 percent drop for the month of September 2025 from the 0.2 percent rise registered for the month of August 2025.

This was mainly due to Goods and Services for routine household maintenance inflation that registered 0.2 percent drop in September 2025 from the 0.1 percent rise recorded for the month of August 2025.

In addition, Household Appliances Inflation decreased by 0.5 percent for the month of September 2025 from the 0.6 percent rise recorded in August 2025. Tools and Equipment for House and Garden Inflation recorded 0.3 percent drop for the month of September 2025 from the 0.1 percent drop registered in August 2025.

Furniture, Furnishings, and Loose Carpets inflation registered 0.0 percent for the month of September 2025 from 0.5 percent increase recorded in August 2025.

However, Household Textiles inflation registered 0.2 percent rise for the month of September 2025 from the 0.6 percent rise recorded for August 2025.

Glassware, Tableware and Household Utensils Inflation recorded 0.1 percent rise for the month of September 2025 from the 0.1 percent drop registered in August 2025.

06 Health

The Monthly Inflation for Health registered 0.0 percent for the month of September 2025 from the 0.2 percent rise recorded in August 2025. This was mainly due to Inpatient care services inflation that registered 0.6 percent drop for the month of September 2025 from the 0.2 percent rise recorded for the month of August 2025. However, Outpatient Care Services Inflation registered 0.6 percent rise for the month of September 2025 from the 0.8 percent rise registered in August 2025.

Medicines and Health Products Inflation registered 0.1 percent rise for the month of September 2025 from the 0.1 percent rise registered in August 2025.

Other Health Services Inflation registered 0.1 percent rise for the month of September 2025 from the 0.0 percent registered in August 2025.

07 Transport

Transport Inflation registered 0.2 percent rise for the month of September 2025 from 0.1 percent drop recorded for the month of August 2025. This was mainly due to Passenger Transport Services inflation that increased by 0.7 percent for the month of September 2025 from the 0.3 percent rise recorded in August 2025.

However, Purchase of vehicles Inflation registered 0.1 percent drop for the month of September 2025 from the 0.4 percent rise recorded in August 2025.

Operation of personal transport equipment inflation recorded 0.1 percent drop for the month of September 2025 from the 0.7 percent decrease recorded in August 2025.

08 Information and Communication

The monthly inflation for Information and Communication increased by 0.1 percent for the month of September 2025 compared to 0.8 percent increase recorded in August 2025.

This was mainly due to Information and communication services inflation that registered an increase of 0.2 percent for the month of September 2025 from the 1.0 percent rise recorded in August 2025.

In addition, Information and Communication Equipment inflation registered 0.1 percent rise for the month of September 2025 from the 0.2 percent rise recorded in August 2025.

09 Recreation, Sport and Culture

Recreation, Sport and Culture inflation registered 0.0 percent for the month of September 2025 from the 0.4 percent rise recorded in August 2025. This was mainly due to Newspapers, books & stationery inflation that registered 0.2 percent rise for the month of September 2025 from the 0.3 percent drop recorded in August 2025.

However, the rise was offset by Cultural Services Inflation that registered a drop of 0.1 percent for the month of September 2025 from the 0.6 percent rise recorded in August 2025.

In addition, Package Holidays Inflation registered 0.0 percent for the month of September 2025 from the 9.8 percent rise recorded for the month of August 2025. Recreational services Inflation registered 0.0 percent for the month of September 2025 from 0.1 percent rise recorded for the month of August 2025.

Gardens and Pets Inflation registered 0.0 percent for the month of September 2025 the same rate recorded during the month of August 2025.

Other recreational goods inflation registered 0.0 percent for the month of September 2025 from 0.1 percent rise recorded in August 2025.

10 Education Services

Monthly Inflation for Education Services registered 0.0 percent for the month of September 2025 the same rate recorded in August 2025. Early Childhood and Primary Education Inflation that registered 0.0 percent for the month of September 2025 registered 0.0 percent for the month of September 2025 the same rate recorded in August 2025. Secondary Education Inflation registered 0.0 percent for the month of September 2025 registered 0.0 percent for the month of September 2025 the same rate recorded in August 2025. Post-secondary and non-tertiary education Inflation recorded 0.0 percent for the month of September 2025 registered 0.0 percent for the month of September 2025 the same rate recorded in August 2025.

Tertiary education Inflation registered 0.0 percent for the month of September 2025 the same rate recorded for the month of August 2025. Education not Defined by level inflation recorded 0.0 percent for the month of September 2025 the same rate recorded for the month of August 2025.

11 Restaurants and Accommodation Services

The Monthly Inflation for restaurants and accommodation services increased by 0.1 percent for the month of September 2025 from the 0.6 percent rise recorded for the month of August 2025. This was mainly due to Accommodation services inflation that registered a rise of 0.8 percent for the month of September 2025 compared to 0.1 percent drop registered in August 2025. However, Food and beverage serving services inflation decreased by 0.2 percent for the month of September 2025 from the 0.8 percent rise recorded for the month of August 2025.

12 Insurance and Financial Services

Insurance and Financial Services Inflation registered 0.0 percent for the month of September 2025 same as that recorded for the month of August 2025.

Financial Services Inflation registered 0.0 percent for the month of September 2025 same as that recorded for the month of August 2025.

Insurance Inflation registered 0.0 percent for the month of September 2025 same as that recorded for the month of August 2025.

13 Personal Care, Social Protection and Miscellaneous Goods

Personal Care, Social Protection and Miscellaneous Goods Inflation registered a drop of 0.1 percent for the month of September 2025 from the 0.7 percent increase recorded for the month of August 2025. This was mainly due to Personal care Inflation that recorded a drop of 0.2 percent for the month of September 2025 from the 1.0 percent increase recorded for the month of August 2025.

In addition, Personal Effects n.e.c Inflation registered 0.1 percent drop for the month of September 2025 from the 0.0 percent recorded for the month of August 2025.

Other services n.e.c inflation registered 0.0 percent for the month of September 2025 from the 0.6 percent increase registered for August 2025.

Social protection inflation recorded 0.0 percent in September 2025 the same rate recorded for the month of August 2025.
