
Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Increased by 10.5%

The Producer prices for manufactured goods increased by 10.5% for the year ending November 2015 compared with the year ended

Main Contributors to the 10.5% Annual increase

There was general increase in prices for all sub sectors.

Notable increases were in the following sectors:

- · Processed Food by 11.9% mainly due to a rise in prices of Sugar by 35.2%., Vegetable Oils by 16.6% and processed Tea by 8.8%
- · Drinks and Tobacco products by 10.5% mainly due to a rise in prices of Malt liquors by 6.3%, Soft Drinks by 6.2% and Tobacco Products by 8.3%.
- . Chemicals and Foam Products by 7.4% mainly due to a rise in prices of Mattresses by 5.4% and Pharmaceutical Products by
- · Metal Products by 5.1% mainly due to a rise in prices of Structural Metals by 2.1% and basic Iron & Steel by 8.3%.
- · Bricks and Cement by 11.0% mainly due to a rise in prices of Cements by 10.1%.

Monthly Changes

The Combined Producer prices for manufactured goods decreased by 0.8% in November 2015. The decrease in prices recorded in November 2015 was mainly due to a general fall in prices of the subsector. Notable decreases were recorded in Food Products by 1.7%, Drinks and Tobacco Products by 1.2%, Metal and Related Products by 0.4%.

The fall in prices of Processed Food recorded in November 2015 was mainly driven by a decrease in prices of Processed Coffee by 3.9%, Vegetable & Animal Oils by 0.1% and Processed Tea by 3.1%.

Additionally, the fall in prices of Drinks and Tobacco Products was mainly driven by a fall in prices of Tobacco Products by 5.8%.


Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market experienced a decrease of 0.3% in November 2015. The price decrease recorded in November 2015 was mainly due to a fall in prices for Food Products by 0.6%, Chemical Products by 0.2%, Metal and Related Products by 0.3%.

Monthly Changes - Exports

The prices of goods produced for Export registered a decrease of 4.2% in the month of November 2015. This was mainly due to a general fall in prices of all the sectors.
