Producer Price Index for Manufacturing and Utility

Introduction


The PPI for Uganda reports the price indices with reference to July 2009 to June 2010, the base period. This publication shows the Producer Price changes since January 2017, on annual and monthly basis and two subsectors of the industry – Manufacturing and Utility (M&U).

HIGHLIGHTS

Annual Producer Price for Manufacturing and Utility rose by 7.0%

The Producer prices for manufactured goods and utilities increased by 7.0 % for the year ending July 2017 compared to the year ended July 2016. Similarly, for the year ending June 2017, the producer prices for manufactured goods and utilities registered an increase in prices by 7.0% compared to the year ended June 2016.



Producer Price Index for Manufacturing

Annual Producer Price for Manufacturing Sector Increased by 6.6%

The Producer prices for manufactured goods increased by 6.6 % for the year ending July 2017 compared to the year ended July 2016. Similarly, for the year ending June 2017, the producer prices for manufactured goods registered an increase in prices by 6.5% compared to the year ended June 2016.

Main Contributors to the 6.6% Annual increase Notable increases were in the following sectors:

- Processed Food by 9.4% mainly due to a rise in prices of Grain milling products by 25.1%, Vegetable Oil by 6.7%, Sugar by 15.5%, Processed Tea by 15.9% and Processed Fish by 11.60%.
- Beverages by 3.5% mainly due to a rise in prices of Soft drinks 5.6% and Blended Sprits by 9.6%
- Chemical Products by 5.0% mainly due to a rise in prices of Soap and
 Detergent Products by 6.0%, and Paint and Varnishes by 2.6%.
- Manufacture of made-up textiles 11.4%
- Leather Products by 10.9%mainly due to a rise in prices of Dressing Leather by 11.0%.
- Basic Metal Products by 10.8% mainly due to a rise in prices of Basic Iron and Steel products by 10.8%.

However, in the same period, prices for Wearing apparels groups registered annual declines of 0.8%.

Monthly Changes

The Producer prices for manufactured goods increased by 0.8% in July 2017 following a previous decrease of 1.0% in June 2017. The increase in prices registered in July 2017 were mainly due to a rise in prices of Processed Food by 1.0%, Basic Metal Products by 0.9%, Non Metallic Mineral Products by 0.3%, and Pharmaceutical products by 0.5% and Fabricated Metal Products by 3.0%.


Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Domestic Market increased by 0.8 in July 2017 following a previous decrease of 0.9% in June 2017. The price increase registered in July was mainly due a rise in prices of processed foods by 1.6%, Non Metallic Mineral Products by 0.3%, Basic Metal Products by 0.9%, Non Metallic Mineral Products by 0.3%, and Pharmaceutical products by 0.5%.

Monthly Changes - Exports

Prices of Manufactured Products for Export registered an increase of 0.9% in July 2017 following a previous decrease of 1.2% in June 2017. The price increase registered in July 2017 was mainly due to a rise in prices of processed food products 0.3%, Non Metallic Mineral Products by 0.3% and Leather products by 10.4%.

Figure 3: Monthly Changes in PPI-M Domestic and Export





HIGHLIGHTS

Annual Producer Prices for Utility Increased by 11.9%

The Producer prices for utilities increased by 11.9% for the year ending July 2017 compared to the year ended July 2016. Similarly, for the year ending June 2017, the producer prices for utilities registered an increase in prices by 13.5% compared to the year ended June 2017.


The annual price increase is influenced by the price increases in the two

- Water Supply by 3.9%

Monthly Changes

The Producer prices for utilities decreased by 0.1% in July 2017 following a previous decrease of 0.4% in June 2017. The decrease in prices registered in July 2017 was mainly due to a fall in prices of generated Electricity by 0.1%
