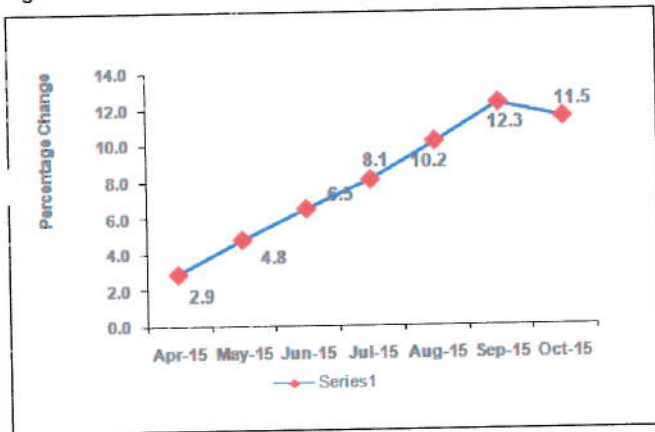
Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Increased by 11.5%

The Producer prices for manufactured goods increased by 11.5% for the year ending October 2015 compared with the year ended October 2014.

Main Contributors to the 11.5% Annual increase

There was general increase in prices for all sub sectors. Notable increases were in the following sectors:

- Processed Food by 13.2% mainly due to a rise in prices of Sugar by 26.9%, processed Coffee by 1.5% and Vegetable oils by 17.3%.
- Drinks and Tobacco products by 12.8% mainly due to a rise in prices of Malt liquors and Tobacco Products by 6.4% and 17.3% respectively.
- Chemicals and Foam Products by 8.4% mainly due to a rise in prices of Mattresses by 5.6% and Pharmaceutical Products by 26.4%
- Bricks and Cement by 11.2% mainly due to a rise in prices of Cements by 10.1%.
- Metal Products by 5.6% mainly due to a rise in prices of basic Iron Steel by 13.1% and Structural Metals by 3.0%.

Monthly Changes

The Combined Producer prices for manufactured goods decreased by 0.4% in October 2015. The decrease in prices recorded in October 2015 was mainly due to decreases in prices of Food Products by 1.1% and Drinks and Tobacco Products by 2.4%.

The fall in prices of Processed Food recorded in October 2015 was mainly driven by a decrease in prices of Processed Coffee by 9.0%, and Processed Fish Products by 3.9%. Additionally, the fall in prices of Drinks and Tobacco Products was mainly driven by a fall in prices of Tobacco Products by 9.4%.

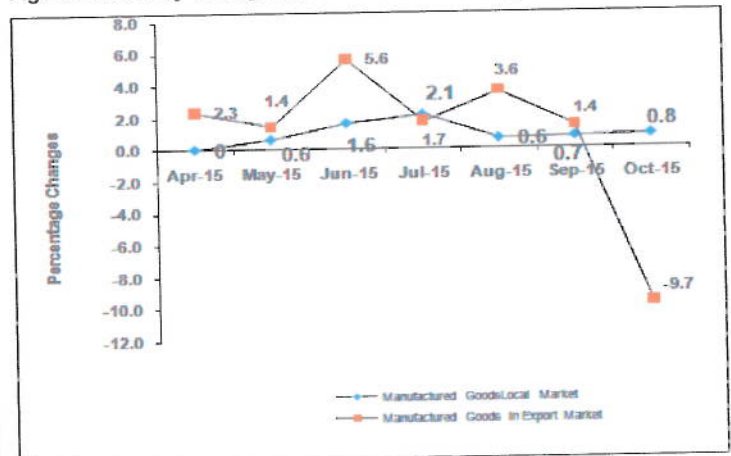
Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market experienced an increase of 0.8% in October 2015. The price increase recorded in October 2015 was mainly due to a rise in prices for Food Products by 1.6% and Bricks and Cements products by 0.6% and Chemical Products by 0.2%.

Monthly Changes - Exports

The prices of goods produced for Export registered a decrease of 9.7% in the month of October 2015. This was mainly due to a general fall in prices of all the sectors with the exception of Metal Products. Notable decreases were in Processed Food by 13.7% and, Drinks and Tobacco by 9.4%.
