



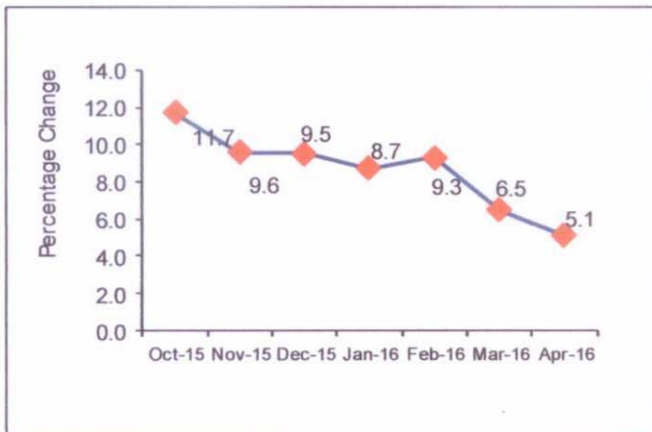
Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Increased by 5.1%

The Producer prices for manufactured goods increased by 5.1% for the year ending April 2016 compared to the year ended April 2015.

Main Contributors to the 5.1 % Annual increase

Notable increases were in the following sectors:

- Processed Food by 8.1% mainly due to a rise in prices of Sugar by 20.7%, processed Coffee by 10.3%, Vegetable and Animal Oils by 4.1%.
- Chemical Products by 2.7% mainly due to a rise in prices of Pharmaceutical Products by 27.9%
- Bricks and Cement by 6.2% mainly due to a rise in prices of Cement, Lime and Other Articles by 6.5%. Bricks and Ceramics by 3.7%.
- Metal Products by 1.5% mainly due to a rise in prices of other Metal Products by 4.6%.

However, in the same period, prices for Drinks and Tobacco and Miscellaneous Products Industry group registered annual declines of 1.3% and 0.7% respectively. This was mainly due to a fall in prices of Tobacco and Plastic products by 8.5% and 1.2% respectively.

Monthly Changes

The Producer prices for manufactured goods decreased by 0.7% in April 2016 following a previous decrease of 0.1% in March 2016. The decrease in prices registered in April 2016 was mainly due to a fall in prices of Food Products by 1.0%, Drinks and Tobacco by 1.1%, and Chemical Products by 2.9%.

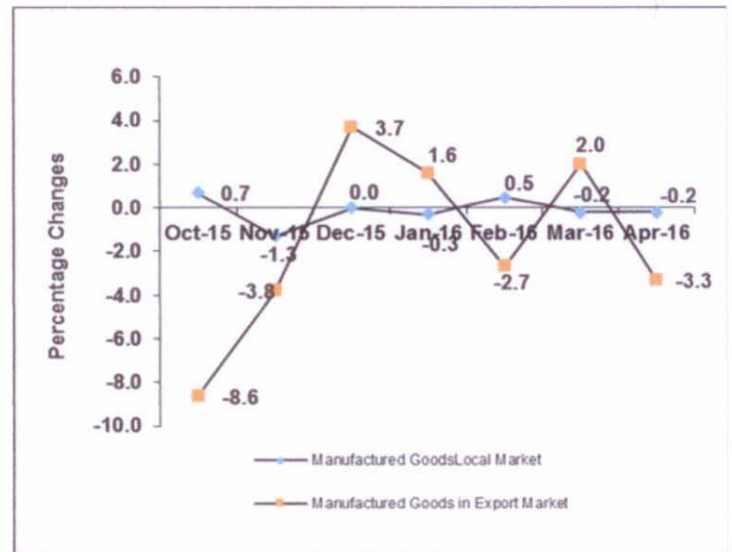
Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market in April 2016 decreased by 0.2% following a similar decrease in March 2016. The decrease in prices registered in April 2016 was mainly due to a fall in prices of Chemical Products by 3.0% and Metal Products by 0.4%.

Monthly Changes - Exports

Prices of goods Manufactured for Export registered a decrease of 3.3% in April 2016 following a previous increase of 2.0 % in March 2016. The price decrease registered in April 2016 was mainly due to a decrease in prices of Drinks and Tobacco by 6.8% and Metal products by 4.3%. However, in the same period prices for other Industry groups went up.
