Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Increased by 4.4%

The Producer prices for manufactured goods increased by 4.4% for the year ending May 2016 compared to the year ended May 2015.

Main Contributors to the 4.4 % Annual increase

Notable increases were in the following sectors:

- · Processed Food by 5.8% mainly due to a rise in prices of Sugar by 19.0%, processed Coffee by 8.6%, Vegetable and Animal Oils by 4.4%
- · Chemical Products by 6.2% mainly due to a rise in prices of Pharmaceutical Products by 30.9%
- · Bricks and Cement by 4.9% mainly due to a rise in prices of Cement, Lime and Other Articles by 4.4%., Bricks and Ceramics by 7.2%.
- . Metal Products by 2.1% mainly due to a rise in prices of other Metal Products by 4.7%.

However, in the same period, prices for Drinks and Tobacco and Miscellaneous Products groups registered annual declines of 0.7% and 1.5% respectively mainly due to a fall in prices of Tobacco and Plastic products by 7.6% and 2.3% respectively.

Monthly Changes

The Producer prices for manufactured goods increased by 0.1% in May 2016 following a previous decrease of 0.5% in April 2016. The increase in prices registered in May 2016 was mainly due to a rise in prices of Drinks and Tobacco by 0.1%, Chemical Products by 0.6%, Metal Products by 0.1%, Bricks and Cements by 0.1%,

Monthly Changes - Local


Prices of Manufactured goods produced for consumption in the Local Market remained relatively stable in May 2016.

Monthly Changes - Exports

Prices of goods Manufactured for Export registered an increase of 0.4% in May 2016 following a previous decrease of 3.7 % in April 2016. The price increase registered in May 2016 was mainly due to a general rise in prices of all the products.

Notable increases were in Processed Food by 0.6%, Drinks and Tobacco by 0.3%, Clothing and Footwear by 0.2%, Metal products by 0.1%.
