
## **Producer Price Index for Manufacturing**

## HIGHLIGHTS

### Annual Producer Price Increased by 13.7%

The Producer prices for manufactured goods increased by 13.7% for the year ending September 2015 compared with the year ended September 2014.

#### Main Contributors to the 13.7% Annual increase

There was general increase in prices for all the sub sector.

Notable increases were in the following sectors:

- Processed Food by 14.5% mainly due to a rise in prices of Sugar by 29.5% processed Coffee by 10.8% and Vegetable oils by 16.2%.
- Drinks and Tobacco products by 17.6% mainly due to a rise in prices of Soft Drinks and Tobacco Products by 6.2% and 36.1% respectively.
- Chemicals and Foam Products by 15.3% mainly due to a rise in prices of Soap and Pharmaceutical products by 12% and 29.6 % respectively.
- Bricks and Cement by 11.7% mainly due to a rise in prices of Cements by 11.4%.
- Metal Products by 6.1% mainly due to a rise in prices of basic Iron Steel by 15.0% and Structural Metals by 3.7%.

#### **Monthly Changes**

The Producer prices for manufactured goods increased by 2.0% in September 2015. The increase in prices recorded in September 2015 was mainly due to a rise in prices of Chemical products by 6.4%, Drinks and Tobacco by 3.4%, Metal and related Products by 1.2% and Food Products by 1.8%.

The rise in prices of Processed Food recorded in September 2015 was mainly driven by a rise in prices of Sugar by 6.8% and Vegetable Oils by 2.4%. On the other hand, the rise in prices of Chemical and Foam Products was mainly driven by a rise in prices of Soap & chemical Products by 12.3%.


### Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market experienced an increase of 1.8% in September 2015. The price increase recorded in September 2015 was mainly due to a rise in prices for Chemical Products by 6.5% and Food Products by 2.0%.

### Monthly Changes - Exports

In September 2015, prices of goods produced for Export registered an increase of 3.1%. The price increase recorded in September 2015 was mainly due to a rise in prices of Processed Food by 1.1%, Drinks and Tobacco by 6.2%.
