
Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Increased by 0.4%

The Producer prices for manufactured goods increased by 0.4% for the year ending September 2016 compared to the year ended September 2015.

Main Contributors to the 0.4 % Annual increase

Notable increases were in the following sectors:

- Processed Food by 4.9% mainly due to a rise in prices of Sugar by 11.1%, processed Coffee by 16.4%, and Processed Tea by 13.3%.
- Chemical Products by 1.3% mainly due to a rise in prices of Soap Products by 8.4% and Pharmaceutical Products by 8.2%.

However, in the same period, prices for Drinks and Tobacco, Bricks and Cement, Metal Products and Miscellaneous Products groups registered annual declines of 9.8%, 2.1%, 1.5% and 0.2% respectively.

Monthly Changes

The Producer prices for manufactured goods increased by 1.1% in September 2016 following a previous increase of 0.2% in August 2016. The increase in prices registered in September 2016 was mainly due to a rise in prices of Food Products by 2.9 %, and Textile products by 0.2%.


Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market registered an increase of 0.2% in September 2016. The increase in prices registered in September 2016 was mainly due to a rise in prices of Processed Food by 0.7%, Textiles, Clothing and Footwear by 0.2%.

Monthly Changes - Exports

Prices of Manufactured Products for Export registered an increase of 5.2% in September 2016 following a previous increase of 0.5 % in August 2016. The price increase registered in September 2016 was mainly due to a general rise in prices of all the sub sectors. However notable increases in prices were registered in Processed Food (5.7%), Drinks and Tobacco (1.3%), Textiles, Clothing and Footwear products (0.2%).
