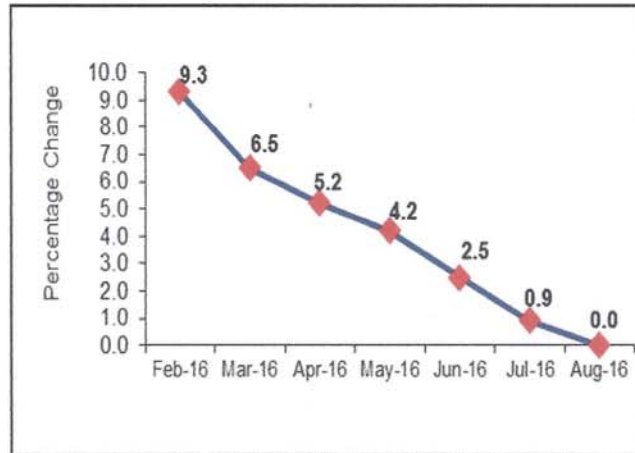
Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Remained Relatively Stable (0.0)

The Producer Prices for Manufactured Goods remained constant for the year ending August 2016 compared to the year ended August 2015.

Main Contributors

Prices remained relatively constant.

However, there were increases in prices of manufactured goods as follows:

- Processed Food by 3.5%,
- Chemical Products by 1.6%,
- Textile, Clothing and Foot wear by 5.8%.

The above increases in prices of manufactured goods were offset by a fall in prices of the following goods:

- Drinks and Tobacco by -8.0%,
- Bricks and Cement by -2.0%,
- Metal products by -0.8% and
- Miscellaneous Products group by -3.0%.

Monthly Changes

The Producer prices for manufactured goods increased by 0.1% in August 2016 following a previous increase of 0.4% in July 2016. The increase in prices registered in August 2016 was mainly due to a rise in prices of the following goods:

- Food Products by 0.4 %,
- Drinks and Tobacco by 0.3%, and
- Textile products by 0.4%.

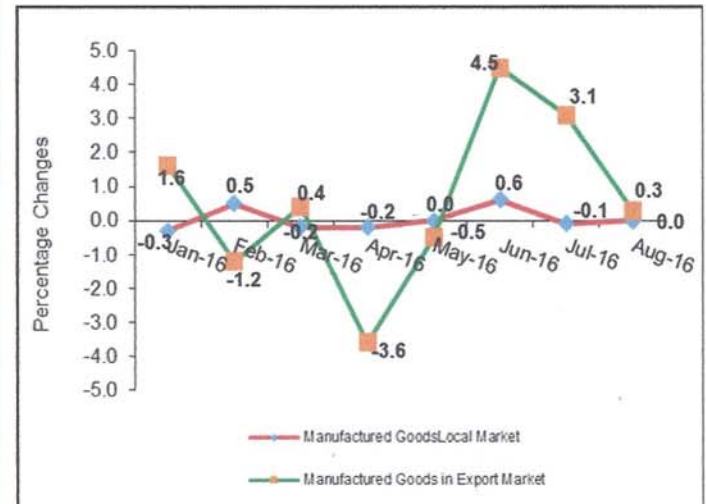
Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market remained relatively stable because the increases in prices of processed food (0.4%), Drinks and Tobacco (0.3%), and Textile products (0.4%) were offset by decrease in prices of Metal products (-0.9%).

Monthly Changes - Exports

Prices of Manufactured Products for Export registered an increase of 0.3% in August 2016 following a previous increase of 3.1 % in July 2016. The price increase registered in August 2016 was mainly due to a rise in prices of Processed Food by 0.4% and Metal products by 0.8%.
