
Producer Price Index for Manufacturing

HIGHLIGHTS

Annual Producer Price Declined by 2.0%

Producer prices for all manufactured goods fell by 2.0% for the year ending August 2014 compared with the year ending August 2013. The years ending April 2014, May 2014, June 2014, July 2014 and August 2014 the Producer prices fell by 0.5%, 1.1%, 0.5%, 0.7% and 2.0% respectively.

Main Contributors to the 2.0% Annual decline Notable decreases were in the sectors of:

- Food Products by 1.3% mainly due to a fall in the prices of Sugar, Processed Coffee and Vegetable Oil.
- Metal Products by 5.5% mainly due to fall in the prices of Structural Metal Products and Basic Iron and Steel.
- Drinks and Tobacco Products by 8.0% mainly due to a fall in the prices of Soft drinks and Tobacco Products
- Chemicals, Paint, Soap and Foam Products by 6.1% due to fall in prices of mainly pharmaceuticals and Soap.

However, during the same period increases in prices were registered in the sectors of Textile, Clothing and Footwear (1.6%), Paper and Paper Products (10.1%).

Monthly Changes

In August, Producer Prices decreased by 0.9% following a previous increase of 0.5% in July 2014. The decrease in prices in the month of August was mainly due to a 4.4% drop in prices of Drinks and Tobacco. Producer Prices for the months of April 2014, May 2014 and June 2014 were (-0.1%), (-0.1%) and (1.1%) respectively.


Monthly Changes - Local

Prices of Manufactured goods produced for consumption in the Local Market experienced a decrease of 0.4% in August 2014 following a 0.3 % increase recorded in July 2014. The decrease in prices in August was mainly due to a 0.7% decrease in prices for Food Products (-0.7%), Chemicals, Paint, Soap & Foam Products (-0.2%) and Bricks & Cement (-0.2%).

Monthly Changes - Exports

A reduction of 2.2% in producer prices for goods manufactured for Export was registered in August 2014. This was mainly attributed to a general reduction in prices in all sectors due to fluctuations in the exchange rate.
