PRODUCER PRICE INDICES AND INFLATION MANUFACTURING AND UTILITIES – AUGUST 2025

1.0 Annual PPI M&U Headline Inflation

The Annual Headline Inflation as measured by the Producer Price Index of Manufacturing and Utilities for the 12 months to August 2025 was registered at 0.9 percent compared to 1.2 percent registered in the year ended July 2025. This was mainly attributed to the Annual Inflation of the Manufacturing sector that registered 1.5 percent in the year ended August 2025 compared to 1.7 percent registered in the year ended July 2025, see table 1 and figure 1 below.

The main driver for the Annual Inflation of the Manufacturing sector was Manufacture of food products whose Inflation was registered at 4.7 percent in August 2025 compared to 5.0 percent registered in July 2025 as shown in Appendix Table 2. Specifically, Processing and preserving of meat increased by 7.5 percent in August 2025 from 7.8 percent registered in July 2025 and Processing and preserving of fish, crustaceans and molluscs increased by 12.6 percent in August 2025 from 15.5 percent in July 2025.

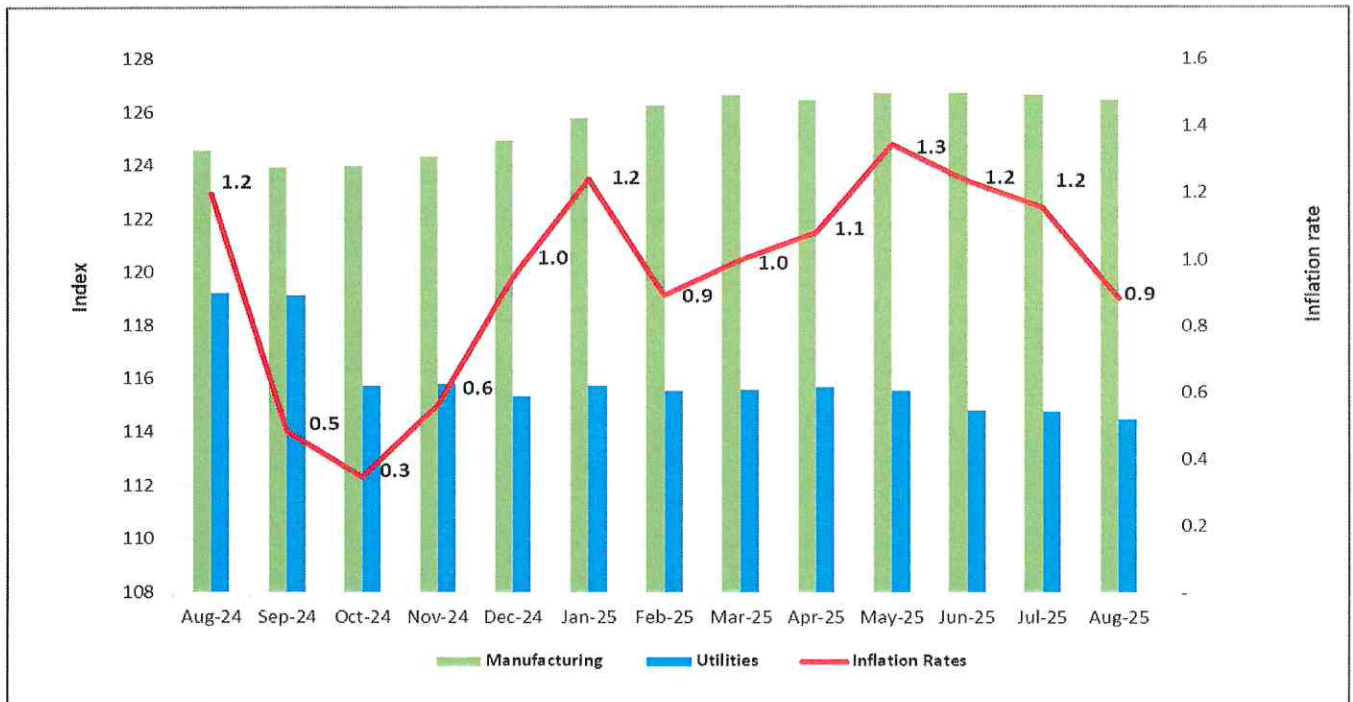
On the other hand, the inflation for Manufacture of grain mill products, starches and starch products, inflation, decreased to minus 0.3 percent from minus 2.2 percent registered in July 2025 and Manufacture of pharmaceuticals, medicinal chemical and botanical products inflation decreased to minus 1.9 percent from minus 3.1 percent registered in July 2025.

The Annual Inflation for Utilities sector was registered at minus 4.0 percent in the year ended August 2025 compared to minus 2.9 percent registered in the year ended July 2025. The main driver to the Annual Inflation for Utilities sector was the Electric power generation inflation which registered minus 8.7 percent in the year ended August 2025 compared to minus 7.9 percent registered in the year ended July 2025 see table 1 below and appendix table 2.

2.0 PPI M&U Monthly Inflation

The Monthly Headline Inflation as measured by PPI M&U for August 2025 decreased by 0.2 percent compared to a 0.1 percent decrease registered for the month of July 2025 as shown in Table 3 below. This was mainly attributed to the monthly inflation for Manufacturing sector which decreased by 0.2 percent in August 2025 compared to 0.1 percent decrease registered in July 2025 as shown in Appendix Table 3.

This main driver for the Monthly inflation of the Manufacturing sector was the Manufacture of sugar inflation which decreased by 6.3 percent in August 2025 from 5.2 percent increase recorded in July 2025 as shown in Appendix Table 3.

The monthly inflation for Utilities sector decreased by 0.3 percent in August 2025 from 0.0 percent registered in July 2025. This was mainly due to the monthly inflation for the Electric power generation, transmission and distribution inflation which decreased by 0.6 percent in August 2025 from 0.5 percent decrease registered in July 2025. See Appendix Table 3.
