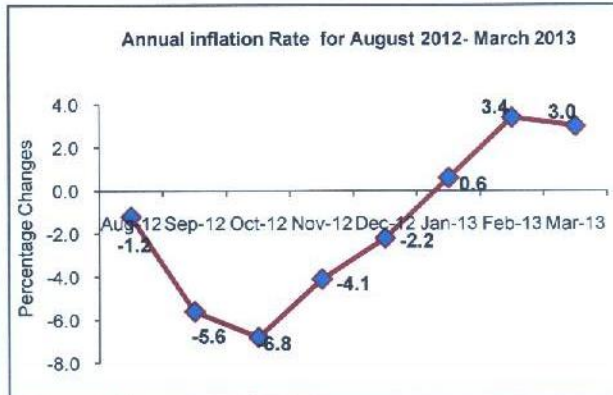

HIGHLIGHTS

Annual Inflation Rates for Manufactured Goods,

The annual inflation rate for the year ending March 2013 decreased to 3.0% from 3.4% increase registered for the year ending February 2013. The annual inflation rates for the years ending January 2013 increased to 0.6 % compared to minus 2.2% increase recorded for the year ending December 2012.



The Main Drivers of the Annual inflation rate.

The annual inflation rate for the year ending March 2013 was driven by a rise in prices of: Processed Food (5.2%), Drinks and Tobacco (6.5%), Chemical Products (2.4%), Bricks and Cement (1.1%). The rise in prices of Processed Food was due to increase in prices of Processed Coffee (10.6%) attributed to terms of sale, Vegetable Oil and fats by 8.6% attributed to high cost of raw materials.

However during the same period, prices of Metal Products; and Paper Products went down by 2.1% and 3.0 % respectively.

Monthly Changes

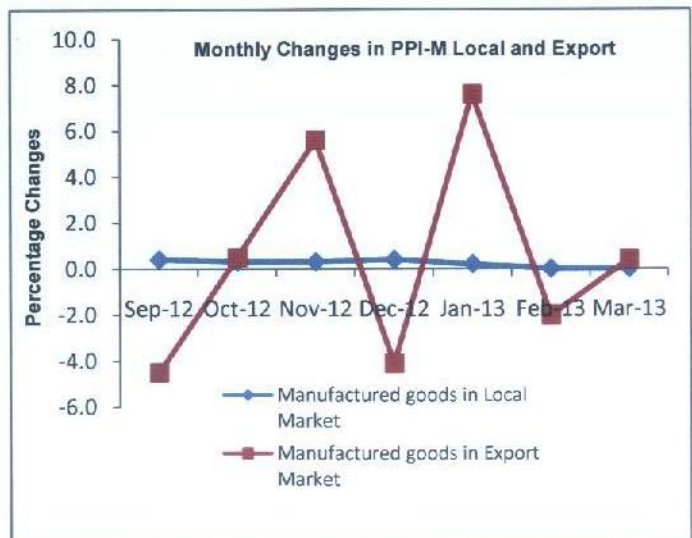
Producer prices increased by 0.1% between February 2013 and March 2013. This was driven by a rise in prices of Processed Food (0.2%), Drinks and Tobacco (0.3%), Bricks and Cement (0.1%). The increase in prices of Processed Food was mainly attributed to 8.7% rise in prices of Processed Fish. Between January 2013 and February 2013 Producer prices decreased by 0.6% compared to the increase of 1.4% between December 2012 and January 2013.

Monthly Changes – Local

Prices of Manufactured Goods produced for consumption in the Local Market remained relatively stable in March and February 2013. However, in January 2013 prices of Manufactured Goods produced for consumption in Local Market increased by 0.2% compared to December 2012.

Monthly Changes – Exports

In March 2013, prices of goods produced for Export registered an increase of 0.4% compared to February 2013. This was higher than the change registered between January 2013 and February 2013 of -2.0%. However, it was lower than the increase registered between December 2012 and January 2013 of 7.6%. The price increase in March 2013 was driven by rise in prices of Processed Food (0.5%) and Drinks and Tobacco (0.5 %). The rise in the prices of processed food was driven by the rise in the prices of Processed Fish (8.7%).
