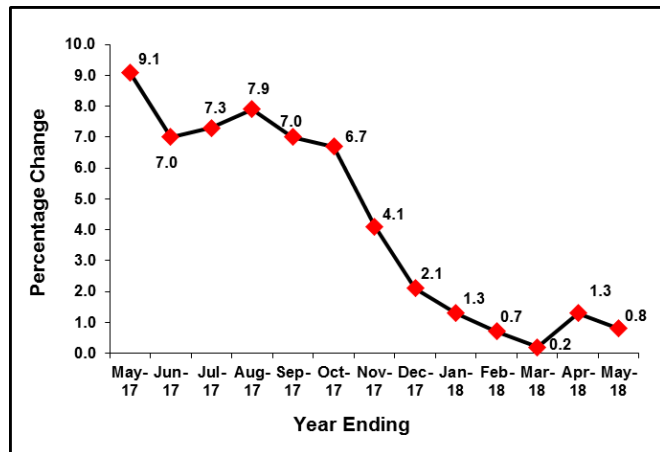


HIGHLIGHTS

Annual Producer Prices for Manufacturing and Utility stood at 0.8 percent

The producer prices for manufactured goods and utilities increased by 0.8% during the year ending May 2018 as compared to 1.3% recorded for the year ended April 2018.

The contributors to the 0.8 percentage change were;

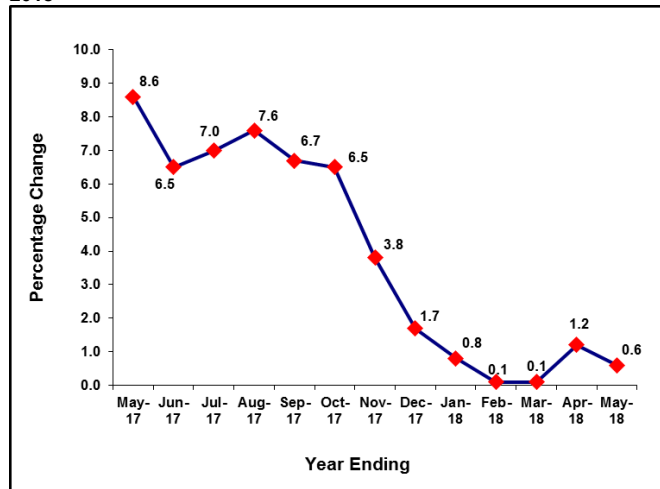
- A rise in the prices under Manufacturing sub-sector by 0.6% for the year ending May 2018 as compared 1.2% rise registered for the year ended April 2018 and in the Utility sub-sector by 2.9% during the year ending May 2018 as compared to the 2.4% recorded for the year ended April 2018.

Producer Price Index for Manufacturing Sub-sector.

Annual Producer Prices for manufacturing sub-sector Stood at 0.6 percent.

The Annual producer prices for manufactured goods increased by 0.6% during the year ending May 2018 compared to the 1.2% increase in prices registered for the year ended April 2018.

Main contributors to the 0.6 Percent

- Basic metal prices by 24.4% recorded during the year ending May 2018 compared to 23.9 % for the year ended April 2018.
- Fabricated Metal products except machinery and equipment by 10.7% recorded during the year ending May 2018 compared to 9.6% for the year ended April 2018.
- Paper and paper products by 6.8% registered during the year ending May 2018 compared to 6.4% recorded for the year ended April 2018.
- Wearing Apparel by 3.1% recorded during the year ending May 2018 compared to 3.1% (same rate) recorded for the year ended April 2018

Monthly Changes

(PPI-M&U)

The monthly producer prices for manufactured goods and Utilities increased by 0.3% in May 2018 compared to 0.7% rise registered in April 2018. The rise in the monthly prices was due to price increase in the manufacturing sub-sector by 0.2% in May 2018 compared to 0.7% in April 2018 and a rise in prices of utilities by 0.5% as recorded in April 2018.

Domestic Market

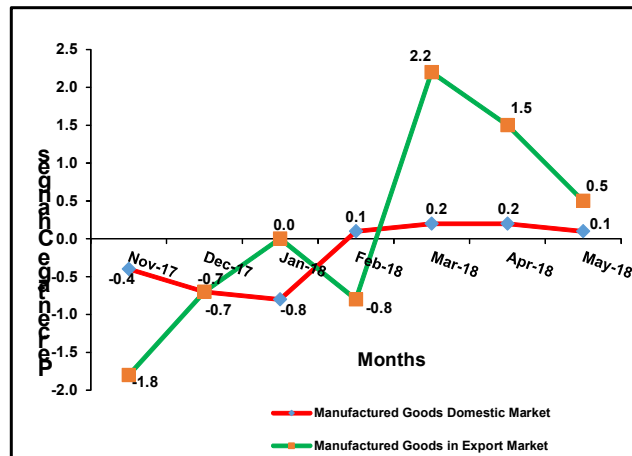
The monthly producer prices of manufactured goods produced for domestic consumption increased by 0.1% % in May 2018 from 0.2% registered in April 2018. The rise in monthly prices of domestic manufactured goods was mainly attributed to the rise in prices of fabricated metal products by 0.3% as compared to -1.6% recorded in April 2018, Food products by 0.3% in May 2018 as compared to 0.2% recorded in April 2018, Reproduction of recorded media by 0.4% in May 2018 as compared to 0.1% rise in April 2018 and Pharmaceuticals, Medicinal chemical & Botanical products by 0.2% compared to -0.2% recorded in April 2018 as shown in Table 2c.

Exports

Producer prices of Manufactured Products for Exports increased by 0.5% in May 2018 from 1.5% rise recorded in April 2018. The rise in prices of exported goods was attributed to rise in prices of Food products by 0.6% in May 2018 compared to 1.6% recorded in April 2018, Other Non-Metallic Mineral Products by 0.8% compared to 1.0% recorded in April 2018 and Tobacco by 0.8% in May 2018 as compared to 1.0% recorded in April 2018.

November 2017 – May 2018

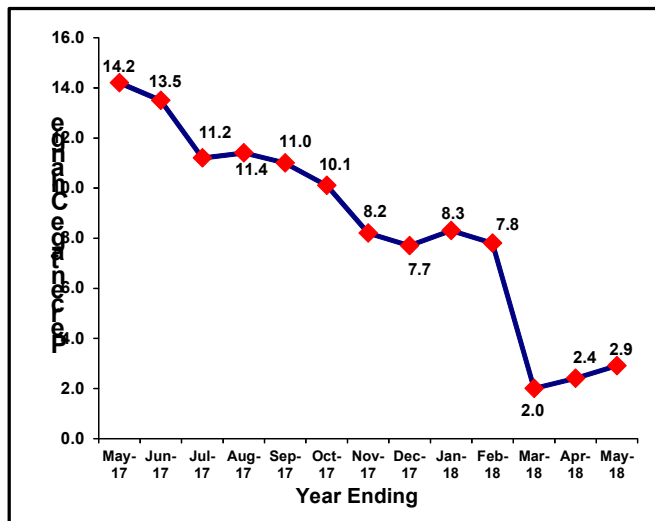


Producer Price Index for Utilities

Annual Producer Prices for Utility stood at 2.9 percent

The producer prices for utilities increased by 2.9% for the year ending May 2018 as compared to 2.4% recorded for the year ended April 2018.

Figure 4: Annual changes in PPI-Utility May 2017 – May 2018

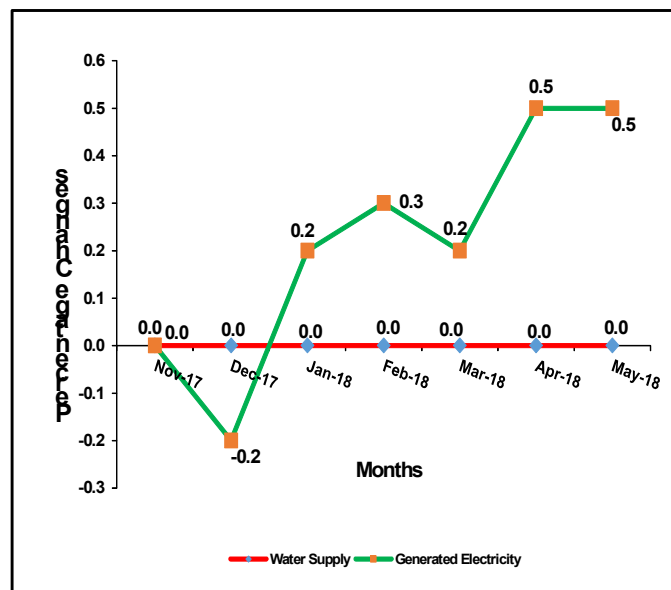


The contributor to the 2.9% was the rise in price of electricity power generation sub-sector by 4.6% registered during the year ending May 2018 as compared to 3.9% recorded for the year ended April 2018.

Monthly Changes in PPI-Utility

The Producer prices for utilities increased by 0.5% in May 2018 (same rate) as reported in April 2018. The rise in utility prices was due to the increase in prices of Electricity power generation by 0.6% in May 2018 as recorded in April 2018.
